Psychoanalytic exploration regularly reveals that these patients suffer from an unconscious sense of guilt and that the "emptying" of their subjective experience reflects their superego's attack, as it were, on the self. The harsh internal punishment inflicted by the superego consists in the implicit dictum that they do not deserve to be loved and appreciated, and that they are condemned to be alone. On a deeper level, and in severe cases, internal fantasies determined by superego pressures are that because of their badness they have destroyed their inner objects and are therefore left alone in a world now devoid of love.

The subjective experience of the therapist who relates to depressed in contrast to schizoid patients with experiences of emptiness is remarkably different. In the relation with a patient presenting a depressive personality structure or chronic neurotic depression, t the therapist may have a sense of intense human contact, a subjective experience of empathy, and at the same time, be aware that the patient cannot accept emotionally the very availability of the therapist in spite of his awareness of the therapist as a real person. The unconscious sense of guilt that prevents the depressed patient's accepting love or concern as it is offered, is reflected in the transference and in the therapist's emotional reaction to it. In contrast, the therapist in contact with schizoid patients describing a subjective sense of emptiness, of lack of

emotional meaning of their relationship with all other people and of life in general, may experience a similar estrangement and distance and unavailability in his interactions with these patients.

This example illustrates a stage of resolution of what often can be a chronically resistant and frustrating situation in the therapeutic relation with schizoid personalities, namely the dispersal and fragmentation of emotions in all human relations, inducing a chronic sense of emptiness in the patient and in the therapist's response to such patients. The schizoid experience of emptiness is not close to a sense of loneliness; loneliness implies an intense, full awareness of the possibility of significant relations with others, which these patients do not have available to them for a long time in their

I think that all I have said so far about the symptom of emptiness lends itself to the following generalizations. The subjective experience of emptiness represents a temporary or permanent loss of the normal relationship of the self with object representations, that is, with the world of inner -objects that fixates intrapsychically the significant experiences with others and constitutes a basic ingredient of eqo identity. Patients with a normally constituted ego identity and, therefore, a stable integrated self and a stable integrated world of internal objects, such as depressive personality structures, illustrate this process during periods when severe superego pressures threaten them with abandonment by their internal objects because of their internal sense of not deserving to be loved.



However, under these circumstances, the capacity for normal object-relations always remains and may be actualized in the transference and in other interpersonal experiences.

An important question has been raised in recent years regarding the relation between the subjective experience of futility and emptiness, on the one hand, and the rapid breakdown or shifts in social stability and cultural values, on the other. The question has been posed of whether contemporary social and cultural changes have affected the patterns of object relations. On the basis of the analysis underlying what I have said so far, I do not think that changes in contemporary culture have effects on patterns of object relations, if we define object relations not simply in terms of actual interactions between a person and others, but in terms of the intrapsychic structures that govern such interactions, and in terms of the internal capacity to relate in Many authors have talked about depth to others. what has been called this "age of alienation," and it

These patients not only lack emotional depth and fail to understand complex emotions in other people, but their own feelings lack differentiation, with quick flare-ups and subsequent dispersal of emotion. They are especially deficient in genuine feelings of sadness and mournful longing; their incapacity for experiencing depressive reactions is a basic feature of their personalities. When abandoned or

In their fantasies, these patients identify themselves with their own ideal self images in order to deny normal dependency on external objects and on the internalized representations of the external objects. -- possible for me to be loved by the ideal person I imagine would love me. That ideal person and my ideal image of that person and my real self are all one, -and better than the ideal person whom I wanted to love me, so that I do not need anybody else any more." In other words, the normal tension between actual self on the one hand, and ideal self and ideal object on the other, is eliminated by the building up of an in---flated self concept within which the actual self and the ideal self and ideal object are confused. At the same time, the remnants of the unacceptable self images are repressed and projected onto external objects, which are devaluated. This process is in marked contrast to the normal differentiation between ideal self images on the one hand and ideal object images on the other, both of which represent the internalized demands of objects as well as gratification from these objects if the demands are met. The normal superego integrates ideal self images and ideal object images; the tension between

actual self images and such integrated ideal ones. becomes tension between the ago and superego. In patients presenting pathological narcissism, however, the pathological fusion between ideal self, ideal object, and actual self images prevents such integration of the superego, because the process of idealization is highly unrealistic, preventing the condensation of such idealized images with actual parental demands and with the aggressively determined. superego forerunners.

One patient fell in love with a woman whom he considered very beautiful, gifted, warm, in short, completely satisfying. He had a brief period of awareness of how much he hated her for being so perfect, just before she responded to him and decided. to marry him. After their marriage he felt bored with her and became completely indifferent toward her. During his psychoanalysis he came to understand how. he treated his analyst in a similar way; he depreciated everything he was receiving from his analyst in order to prevent his envy and hatred from coming to the surface. After that, the patient gradually developed strong suspiciousness and hatred toward his wife for having all that he felt he did not have, and he was also afraid that she would abandon him and leave him with even less. At the same time, however, he was able for the first time to

become aware of and to be moved by her expressions of love and tenderness. His awareness of his aggressive disqualification of her and his analyst, and his increasing ability to tolerate his hatred without having to defend against it by destroying his awareness of other people made both his wife and his analyst "come alive" as real people with independent existences, and eventually permitted him to experience not only hatred but also love toward them.

The descriptive features of narcissistic personalities usually permit their differentiation from other forms of character pathology in which narcissistic character defenses are present. All character defenses have, among other functions, a narcissistic one: they protect self-esteem. In addition, there are patients with all kinds of character pathology who present marked character defenses especially erected to protect or enhance self-esteem. These latter cases have "narcissistic character defenses" in an essentially non-narcissistic personality structure, which has to be differentiated, therefore, from the narcissistic personality in the narrow sense used in this paper. Thus, for example, the stubbornness or oppositionalism of obsessive personalities often has a strong narcissistic quality; however, there is much more stability and depth in the interpersonal relationships

 of obsessive personalities than in those of narcissistic personalities, in spite of the fact that both may appear superficially as quite "cold." Also, he value systems of narcissistic personalities are enerally corruptible, in contrast to the rigid morality if the obsessive personality.

The was quite derogatory toward the analyst, reveled in his own interpretations of his material, and saw the analyst mainly as a background figure whose function was to applaud and admire these interpretations and insights. When this attitude was systematically examined, however, and the patient was consistently confronted with this defensive pattern, a new, deeper transference pattern evolved. In this new facet of the transference, the patient saw the analyst as a cold, indifferent, unloving mother image, and experienced feelings of sadness and loneliness, representing an early longing for his idealized mother. In this second illustration, too, when the narcissistic character defenses broke down, other transference patterns emerged in which the patient maintained a differentiated object relationship, neither devaluation the object nor taking flight into an idealized self image. In summary, both of these cases developed new, differentiated transference relationships after the narcissistic character defenses had been dissolved, whereas the narcissistic patient cannot acknowledge the analyst as an independent object and continuously and stubbornly regards him as a simple extension of the patient's own self concept, although the regression within this same transference paradigm may fluctuate.

At times it is difficult to imagine how frequent and how repetitive such interactions are, extending as they do over two or three years of analysis; this resistance to treatment illustrates the intensity of the narcissistic patient's need to deny any dependent relationship. It is obvious that consistent examination of the negative transference is even more crucial in these patients than in others undergoing psychoanalysis.

These patients usually cannot tolerate the severe regression and reactivation of very early pathogenic conflicts in the transference, necessary to their analytic treatment, without psychotic decompensation. A more supportive treatment approach seemsbest for this group. In regard to those narcissistic patients who seem capable of undergoing psychoanalysis, I have found the following prognostic considerations useful in individual cases.

The crucial test of the motivation of these patients. comes only after a period of analysis. The usually acceptable motivations for treatment, such as the wish to get rid of symptoms, may prove quite spurious in patients with narcissistic personalities. They may really want to become "perfect," and may enter analysis with such expectations. The question of whether "perfection" will turn out to mean for them freedom from symptoms so that they can be superior to everybody else, or whether it will be exchanged. for the wish to get rid of their crippled emotional lives is often difficult to answer at the initiation of treatment. In any case, the more a person wishes to overcome feelings of emptiness, difficulties in empathizing with others, and his internal coldness, the better the prognosis.

Perhaps one difference in my description from that derived from Kohut's work is my stress on the pathological nature of their internalized object relations, regardless of the superficially adaptive behavior of many of these patients. In addition, I stress the presence of chronic, intense envy, and defenses against such envy, particularly devaluation, omnipotent controll, and narcissistic withdrawal, as major characteristics of their emotional life.

He repeats the __essence of this statement later (p.39 footnote) and considers the development of object love largely -independent from that of lower to higher forms of narcissism (pp. 220, 228, 297)... Kohut conveys the impression that he analyzes the vicissitudes of normal and pathological narcissism and of normal and pathological object relationships as mostly dependent on the quality of libidinal catheres rather than in

terms of the vicissitudes of internalized object

I disagree with these viewpoints, and like Jacobson (1), Mahler (2) and van der Waals (3), I think that one cannot divorce the study of normal and pathological narcissism from the vicissitudes of both libidinal and aggressive drive derivatives, and from the development of structural derivatives of internalized -object relations (4 & 5). In what follows, I will provide clinical material as well as theoretical considerations in support of the following viewpoints.

Bathological narcissism can only be understood in terms of the combined analysis of the vicissitudes of libidinal and aggressive drive derivatives. Pathological narcissism does not simply reflect libidinal investment in the self in contrast to libidinal investment in objects, but libidinal investment in a pathological self structure. This pathological self has defensive functions against underlying libidinally invested and aggressively invested primitive self and object images which reflect intense, predominantly pregenital conflicts around both love and aggression**x**.

To summarize these three viewpoints into one overall statement: Narcissistic investment (i.e. investment in the self), and object investment (that is, investment in representations of others and in other human beings) occur simultaneously, and intimately influence each other, so that one cannot study the vicissitudes of narcissism without studying the vicissitudes of object relationships, in the same way one cannot study the vicissitudes of normal and pathological narcissism without relating the development of the respective internalized object relations to both libidinal and aggressive drive derivatives.

The inclusion of the child in the narcissistic world of mother during certain periods of his early development creates the predisposition for the "specialness" of the child, around which the fantasies of the grandiose self become crystallized. The analyst certainly needs to avoid education pressures or a moralistic stance, and I think that the best way to achieve this is by analyzing the motives which determine narcissistic defenses, including the activation of the grandiose self. One prominent reason why these patients cannot tolerate facing their feelings of hatred and envy is because they fear such feelings will destroy the analyst, destroy their hope for a good relationship with him, and crush their hope At a deeper level, these patients of being helped. fear that their aggression will not only destroy the potentially loving and giving object but also their own capacity to give and receive love. Narcissistic patients also attempt, in denying the reality of their emotional relationship with the psychoanalyst, to deny the danger of their destructiveness and to preserve

A careful study of Kohut's case of Miss F. (1) p. 283-95), illustrating the analyst's reactions to mirror transferences, lends itself to an interpretation along the lines I have suggested in this paper. At one point, the patient was able to "establish connexions between the rage which she experienced against me when I did not understand her demands and the feelings she had experienced in the reaction to the narcissistic frustration which she had suffered as a child" (p.293) Kohut states: "I was finally able to tell her that her anger at me was based on narcissistic processes, specifically on a transference confusion with a depressed mother who had deflected the child's narcissistic needs on to herself. These interpretations were followed by the recall of clusters of analogous memories concerning her mother's entering a phase of depressive self-preoccupation during later years of the

In the light of the overall information given about this case, I would raim the question to what extent, in making this interpretation, was the analyst implicitly blaming the patient's mother for having caused the patient's anger .-and -protecting the patient from full examination of the complex origins of her own rage7 In more general terms, I see a danger of a seductive effect given by the combination of the analyst's unquestioning acceptance of the patient's idealization, and by the immediate referral back to the original object of the negative transference without exploring fully the patient's participation in the development of pathological rage within the here and now of the transference.

For practical purposes, object relations in depth involve the capacity both to love well, and to hate well, and particularly to tolerate varying combinations of loving and hateful feelings, and their toned down mingling in the relationship with the same object and with the self. Normal object relations as well as normal narcissism include an integrative conception in depth of others and oneself. All this is in striking contrast to the frequent blandness and uninvolvement, the lack of commitment to others as well as to any convictions about himself that one sees in narcissistic patients. Baradoxically, such lack of emotional depth and commitment may permit a better social functioning, for example, in certain political and bureaucratic organizations in which lack of commitments means survival and access to the top.

It is dramatic how intense the denial of this longrange reality can be in narcissistic personalities, who under the influence of the pathological, grandiose self are unconsciously (and sometimes consciously) convinced of their eternal youth, beauty, power, wealth and the unending availability of supplies of confirmation, admiration, and security. For them, to accept the breakdown of the illusion of grandiosity means to accept the dangerous, lingering awareness of the depreciated self--the hungry, empty, lonely primitive self surrounded by a world of dangerous, sadistically frustrating and revengeful objects. Perhaps the most frightening experience that narcissistic personalities need to ward off and eventually may have to face is that of a surrounding world empty of love and human contact, a world of dehumanized objects within which animate as well as

inanimate objects have lost their previous, magically satisfying qualities.
