IN ACCORDANCE with his wishes, no biography of Thackeray was undertaken for many years after he died. One critic, observing that the great author's acquaintances were disappearing, lamented the fact that the chance of an authoritative Thackeray biography was dying with them. But it is hard to believe that even his intimate friends could have known as much about Thackeray as this biography reveals. He lived at a time when nearly every fact worth knowing about the private lives of educated people found its way into a letter or a diary. Gordon Ray, who has collected manuscripts by and about Thackeray for many years, has drawn his extremely detailed information from a large quantity of these first-hand sources.

Thackeray: The Uses of Adversity is the first installment of a massive two-volume work, it follows the novelist's development up to the time of Vanity Fair. It sees the first part of Thackeray's life as a Bildungsroman whose hero's character is gradually formed by his experiences. With the sensitiveness to atmosphere and personality which only an expert knowledge of a period can give, Professor Ray succeeds admirably in tracing the effects of Thackeray's various environments upon him.

Professor Ray has no doubt of Thackeray's greatness, though he acknowledges that it is not the fashionable kind, but he has reserved his general critical interpretation for the next volume. The discussion of Vanity Fair which closes this one is a scholarly account of its contemporary importance. Thackeray's masterpiece, it is pointed out, transformed Victorian fiction; it shattered burdensome conventions, established realism as the dominant mode of the English novel and embodied, in its balanced structure, a distinction between the incidental and the essential in the Victorian ideal of the gentleman. All this, says the author, made Thackeray's greatest novel "quite as revolutionary a book in the development of Victorian fiction as Ulysses has proved to be in the development of modern fiction."

tors whose work lies outside the realm of mental disorder, for laymen with the patience to follow a lengthy, semi-technical account of ideas they hear about frequently. . . . " The highest praise she could win, and has earned, is the fact that she has succeeded. Here, in clear, conscientious, objective form, is a progressive ana-

which has proliferated since Freud opened a new world to man's mind. sixty years ago. But Dr. Munroe is too wise to reach for the will-o'-thewisp of absolute objectivity and impartiality At the close of each chapter. differentiated from the text by double columns, she places what she calls "critical comment"; and here she reveals her own judgments which are remarkable for perspicuity and tolerance of positions other than

After a general "Overview" which discusses the basic concepts of psychoanalysis, determinism, the unconscious and the genetic approach she proceeds to Freud and the Freudians (her own territory). Next come Adler, Horney, Fromm and Sullivan. Finally, Jung and Otto Rank. Perhaps she is unfair to Jung, but for a good reason, since she discusses him essentially as a psychologist, whereas Jung's importance rests rather in the fields of psychic paleontology and epistemologyrealms in which the Freudians have too timidly followed him. On the other hand, she has done muchneeded justice to Rank, whose great contribution is his unitary concept of self and of will, based firmly on German philosophy (particularly Schopenhauer)-a synthetic approach which Freud's positivism precluded. The reader who seeks a general view of this vast and still pristine field of human knowledge, and who is ready to read 600 pages of sober and sound prose, cannot err in procuring Dr. Munroe's volume.

DR. FROMM has long been distinguished among the leading psychoanalysts by his dynamic and critical approach to our Western society and by his defense of the neurotic's discrepancy from a social order in which alienation of the human has become axiomatic. In a sense, Fromm is the analyst par excellence of our cultural neurosis. In this book, he becomes openly-one might say passionately-the social critic. And in an epoch which takes seriously the masked complacencies of David Riesman, dished up in pedantic and not remotely original terms, a book such as this is doubly welcome. Fromm's critique of the capitalist ethos is courageous and keen. He leads constantly to the frontiers of that basic metaphysical view of

SCIENCE AND SOCIAL ACTION. By W. J. H. Sprott The Free Press. \$3.50 The Josiah Mason Memorial Lectures delivered at the University of Birmingham in 1953 Using social action rather than social relations or society as the basic concept. Professor Sprott reviews theory, method and research findings, leaning heavily upon American sources. The lectures seldom go beyond the introductory sociology textbook level except in style.

FLIGHT AND RESETTLEMENT BY H B. M. Murphy and others Unesco. Columbia. \$3 50. Thirteen specialists on population and migration discuss the problems of refugees and displaced persons since the end of World War II, with an unusual emphasis on mental health problems in forced migration.

THE FEARS MEN LIVE BY. By4 Selma Hirsh Harper. \$2.75. A popular summary of what social scientists think they have learned about prejudice, especially as manifested in the "authoritarian personality." Useful for those unable or unwilling to examine Studies in Prejudices. the five-volume source of most of the ideas and data.

PROTESTANT-CATHOLIC-JEW-By Will Herberg. Doubleday \$4, "An essay in American religious sociology" The author's thesis is that both the religiousness and secularism of the American people derive from virtually the same bases. He leans heavily on such sociological concepts as the "triple melting-pot" for his analysis of the major re-

ligious groups. Not as original a contribution as the author's earlier Judaism and Modern Man, but probably more readable
