COPE OF STUDY: A study to determine the relative efveness of nondirective and directive group psychotherapy lping geriatric patients to decide to leave the hospital was ucted. The subjects were a group of institutionalized 'ly patients who no longer required the psychiatric care ided by the state hospital, but who refused to move to a ing home where they would continue receiving state sup-

Changes in attitude about leaving the hospital were deined by asking them if they would like to leave. A rating <sup>3</sup> was used to measure changes in the behavior of the pas and a sociometric questionnaire was employed to assess ersonal choices of group members as indicators of sointeraction between patients.

'INDINGS AND CONCLUSIONS: Therapy had a beneficial t on decision to leave the hospital. Seventy-five percent e entire group of subjects in this study were willing to move to nursing homes at the end of the treatment period. There was evidence to suggest that high scores on the Socialization dimension of the rating scale might indicate a favorable prognosis for this decision. Results also showed that there was no statistically significant behavioral effects due to therapy. This absence of significant change with therapy was not a function of the scale's lack of reliability. The median reliability for this instrument was .84. Therefore, it seems likely that substantial behavioral changes did not occur for the total group. Changes on a sociometric questionnaire indicated a highly significant improvement in choice behavior between patients. THE NATURE OF MAN AND GUILT: IMPLICATIONS FOR COUNSELING DERIVED FROM AN ANALYSIS OF THE PHILOSOPHIES OF CORNELIUS VAN TIL AND ERICH FROMM.

Motivated by the theory of guilt neurosis propounded by O. H. Mowrer, this study probes the nature of man and guilt by comparing and contrasting the opposing philosophies of Cornelius Van Til, philosopher, and Erich Fromm, psychoanalyst, who have both written extensively on these subjects. Their positions are analyzed in the belief that the counselor's attitude toward and treatment of guilt would be determined largely by the philosophical position assumed on the nature of man.

Van Til's system of thought is analyzed in terms of his position on basic presuppositions, theology, reality, knowledge and ethics. Van Til holds that there are only two possible alternatives that are logical to hold and that these are mutually contradictory. Christian man assumes a two-layer theory of being and reality. His primary presupposition is, first, the existence of the God of the Old and New Testaments, a God who is infinite, eternal and unchangeable in His being, wisdom, power, holiness, justice, goodness and truth; his second corollary presupposition is that the creation of the world, including man. Non-Christian man assumes the ultimacy, autonomy and creativity of the human mind. This presupposition rules out any sovereign God who controls or maintains the world, and depends upon a universe of chance. Paradoxically, this assumption implies that man must also hold to a deterministic cause-and-effect in order to leave room for rational thought. It further demands, says Van Til, that man must have exhaustive and comprehensive knowledge of reality in order to interpret available phenomena.

A detailed study is made of Van Til's theological position, focusing on his doctrines of God, man, Christ, salvation, revelation, the church and eschatology, and on his concepts of reality, knowledge and ethics.

Fromm's theories of reality and ethics are presented. Fromm deals with man's ultimacy and autonomy on the framework of an evolutionary scheme of reality. Man is capable of penetrating to the essence of phenomena, of discovering truth apart from outside sources, and has the potential for growth. Antithetically, man also has the potential for decay and degeneracy. His orientation around either growth or decay is determined by hereditary tendencies and the process of socialization. Man has transcended from the animal world and finds himself alienated from his origins. Fear drives him to project concepts of God; he yields up his independent spirit to authoritarianism and commits idolatry. The way to

## PERCEPTIONS OF URBAN DISADVANTAGED AND NON-DISADVANTAGED JUNIOR HIGH SCHOOL STUDENTS.

The ways a person views his world, his perceptions of his world, seem to influence his behavior, his goals, and his accomplishments. This study was designed to explore some perceptions of disadvantaged and non-disadvantaged junior high school students and the relationship of these perceptions to vocational maturity. Perceptions of school, work, and the family were studied.

Urban students in communities with school enrollment from 50,000 to 100,000 students were studied. Students with marked educational, social, and/or economic handicaps were collectively referred to as disadvantaged students.

Four communities participated in the study: a community on the eastern seaboard, a southern community, a border southern community, and one from the western part of the United States. From each community two schools participated in the study, one school which serves predominantly disadvantaged students and one school which serves predominantly non-disadvantaged students. The schools were selected by a staff member of each local Board of Education. The disadvantaged schools were selected on the basis of serving relatively low income families with low educational attainment of the adults, poor housing, and high unemployment rates, while the non-disadvantaged schools were selected as serving populations not characterized by these attributes. Census tract data were used to substantiate the selection of the schools as serving the designated populations.

A representative sample of approximately 200 seventh and 200 ninth grade students was selected from each school. The final sample included 1147 students from the schools designated as disadvantaged and 1223 students from the schools designated as non-disadvantaged.

Perceptions of school, work, and the family were measured by the Student Perception Inventory constructed for use in this study. Responses to the 109 items were factor analyzed separately for each community. Four scorable factors were identified which were found for all four communities, indicating the use of a common set of constructs within the sample.

The four Perception Factors were named Factor I, "Teacher-Student Relationship"; Factor II, "Work and the Future"; Factor III, "Family-Child Relationship"; and Factor IV, "Difficulty Level of School Work." The disadvantaged and non-disadvantaged students responded to Factors II and III at about the same level or score; they differed on Factors I and IV. The disadvantaged students reported that teachers were more understanding and helpful than the non-disadvantaged students indicated. They also perceived school as easier than the non-disadvantaged students. Vocational Maturity was measured by the Vocational Development Inventory, Attitude Scale, constructed by Crites, Vocational Maturity is defined by Crites as the responses given by the twelfth grade criterion group. Disadvantaced students scored markedly below the non-disadvantaced students on Vocational Maturity.

Results of the correlational analysis indicated that the p ception Factors are related. Factor II, "Work and the Fun is related to Vocational Maturity. Student characteristics a cluding number of people at home, parents at home. [ather"] and mother's education, and schooling desired by student ar related to Vocational Maturity and to being disadvantaged.

Analysis of variance results for the four Perception Fac tors and Vocational Maturity indicated that the characteristic of being disadvantaged accounted for some of the variance of three Perception Factors, but not of Factor III.
