The second of th of renaming would be the possibility of such experiments. The measurement of meaning is not new, though there are news tools for it such as Osgood's semantic differential, and many others which are still in the experimental stage, such as the information theoretic approach being used at the White Institute. If one grants the definition of meaning implied in these instruments, there is no reason why defect in aspects of connotative meaning cannot be measured in pathological and control populations, testing Dr. Artiss's hypothesis. Work to date using these new instruments and more rigorous experimental techniques has indicated that many of the classical notions regarding schizophrenic language are not as general as was thought, but that important differences from normal communication can indeed be demonstrated.

Dr. Fromm cited Freud's "Analysis Terminable and Interminable" as a most insightful discussion of the factors leading to analytic cure. Freudian theory states essentially that neurosis represents a conflict between instincts and ego, and hence that taming of the instincts and strengthening of the ego, with consequent disappearance of symptoms, represents cure. Prognosis for cure is best if trauma has played an important role in producing the neurosis, if the instincts are not too strong, constitutionally in relation to the ego, and if the ego has not been too greatly altered as a result of defensive operations. Dr. Fromm criticized this view of neurosis and its cure, suggesting that the battle is not between the rush of the instincts and the damming power of the ego, but between archaic passions or love of death (necrophilia) and other passions, namely love of life (biophilia). In evaluating a patient's

chances for cure, he distinguished between light, benign neuroses and malignant neuroses. The former, which have a good prognosis, are charactericized by the presence of severe effects due to trauma and the absence of severe damage to the nucleus of the character. Trauma, to have appreciable effects, must have been massive; much of what is commonly attributed to the "traumatic" offects of significant figures, should be ascribed to underestimated constitutional factors. The prognosis is not good for malignant neuroses, charactericized by narcissism, attachment to the mother, damage to the nucleus of the character, and necrophilia. In benign neuroses resistances are easily dropped, in malignant ones they are deeply

The kernel of cure in the method of analysis, according to Dr. Fromm, lies not in strengthening the ego, but in the patient's confrontation of the archaic, irrational part of himself and its contrast with his adult, rational power. Thus, two tracks are followed simultaneously in analysisthe "child" and the "adult" one. In classical analysis the patient is infantilized and never confronts himself since he is only the child; in rational conversations he does not confront himself, because he never experiences the child. Dr.: Fromm pointed out other factors affecting the evaluation of the probability of cure: To what extent are constitutional factors operative, particularly the patient's vitality and love of life vs. death? Has the patient reached the bottom of suffering? Does he have some notion what he wants life to be, or is he simply un-.happy? Does therapy represent chiefly narcissistic gratification in talking about himself? Can he distinguish between banality and reality? With what degree of neurosis can he get by in his present life situation? Is he willing and able to make the sacrifices and take the risks of active participation in analysis? Dr. Fromm concluded by discussing the curative role of the therapist. In an atmosphere of reality and truth, with an absence of sham, deception, and sentimentality, the patient is enabled to experience something different from the world of banalities. The therapist should be able to experience in himself what the patient is talking about and should view the

patient compassionately as the hero of his own drama.

Dr. Lawrence Epstein devoted his discussion to answering criticisms sometimes directed at Dr. Fromm. He maintained that Dr. Fromm is realistic, rather than pessimistically cynical, that he stresses rational authority and human values, rather than indulging in authoritarian moralizing, and that patients are not lost through confrontation.

Dr. Harry Bone bypassed his essential points of agreement with Dr. Fromm and focussed on their points of difference. He took issue with the sharp distinction between benign and malignant neuroses, suggesting, rather, that there was a continuum and that both positive and negative forces were present, to varying degrees, in all people. He questioned whether synthesis automatically followed the patient's shock at awareness of another part of himself. Dr. Bone pointed out the advisability of considering constellations and counterbalances of factors effecting change, not simply their magnitude. It is important to see how "good" the neurosis is, on the theory that the same forces used in building the neurosis could potentially be used creatively in analysis, and that perhaps extreme destructiveness held potentiality for extreme creativeness. He believes that it is not enough for a patient to confront himself, but that he must also have a real aim in therapy. The ultimate aim of therapy is not to strengthen the good and eradicate the bad, but rather for the patient to attain a fusion between his "bad" infantile self and his "good" adult self. The struggle is between being himself and not being himself. Lastly, Dr. Bone questioned Dr. Fromm's insistence on his debt to Freud, suggesting that Dr. Fromm has changed Freudian theory and that new wines require new wine

Dr. Fromm agreed that benign and malignant neuroses form a continuum and that cure depends not simply on momentary shock but on the will to get somewhere. He disagreed that his views were sufficiently different from Freud's to warrant a new system with new definitions of terms.


