


### About us

## The Surrey "open thesis" quest




- » Library always received a copy of the bound thesis and sent details to the British Library
- From 2010 we accepted thesis with a disc of the digital work
- » 2011 found historic thesis in a box file (from 1920's)
- » From 2013 actively sought electronic copies and uploaded them to the repository
- » Feb 2015 digital copy only accepted by Library
- » 2016 ProQuest digitised 2,000
- » 2017 2019 digitising the remaining collection




# Open Access at Surrey in numbers

#### % of full text items of different types





# Rights

- » Who owns the Copyright?
  - At Surrey the Student owns the rights to the thesis but as part of their agreement to undertaking the programme they must deposit a copy in the Library
  - The thesis is part of the public record and so the expectation is that public are able to access it
- » What about 3<sup>rd</sup> party Copyright?
  - Do not stress too much fair dealing covers most things
  - Students are required to remove 3<sup>rd</sup> party Copyright it is their responsibility not the Library
  - But ... worth doing some checking to mitigate any major risks
  - And the final tactic have a robust "Take-down" policy
- » What happens if it has sensitive, potentially commercial information or was externally funded?
  - Can request an embargo, but only under certain conditions and for a set period of time.
  - Any extension has to be signed off by Dean of Faculty

## Author clearance

- » You have to get the authors permission to digitise right?
  - Why? This is just a format shift
  - We did not get permission to share the physical item
  - Or when the British Library created a microfiche to send to anyone who made a request
  - Or indeed when the British Library launched the <u>EThOS</u> service

Remember this is a public obligation – they can't refuse

### Additional benefits



- » We have worked with ProQuest as a partner
  - Expands the indexes our thesis are recorded
  - Linked into subject specific databases
  - Puts our research in front of a specialised audience (they are looking for thesis)
  - Last but by no means least allowing ProQuest to harvest our thesis means there are multiple preservation copies. That is something we would never have in the old paper artefact world!
