Acknowledgment of Bias and Harmful Content

Manuscripts, Archives, and Special Collections (MASC) at Washington State University Libraries recognizes there are materials in our collections that may be offensive or harmful, containing racist, sexist, Eurocentric, ableist or homophobic language or depictions. We retain such materials unaltered in order to document history and preserve context. MASC staff is making efforts to update our finding aids (collection descriptions) to acknowledge offensive content.

In addition, we recognize that there may be language in our collection descriptions written by staff that is outdated, problematic, and/or inaccurate. We are making efforts to identify such language and update terminology to be more respectful, accurate, and inclusive. Finding aids with problematic language will be retained for transparency purposes and will be available upon request. We also make a note of these changes in the "Processing Information" section of the finding aid or on the digital collection's home page. Going forward, we seek to use inclusive, accurate, and respectful language in describing newly acquired and newly processed collections.

This is an ongoing process, and we welcome feedback from MASC users. If you encounter harmful or offensive content or language in our collection descriptions, or have questions about our process, please email us at mascref@wsu.edu. Staff will review suggestions and may make changes in accordance with institutional policy.

DIGITIZED ARCHIVAL AND SPECIAL COLLECTIONS: POTENTIALLY OFFENSIVE MATERIALS

The University of Wisconsin-Milwaukee Libraries established a digitization program in the fall of 2001. The primary mission of the program is to serve the UWM academic community and the general public by providing digital access to unique library resources. Over the past several months SCA staff have discussed how to balance upholding the context of records with putting principles of equity and reconciliation into action. A decision was made to move beyond blanket 'language of its time' statements to identifying instances of problematic language or imagery.

As noted in the revised statement: "SCA staff view this manner of providing and expanding on the context of problematic records to be in keeping with the University of Waterloo's Principles of Inclusivity and Policy 33 - Ethical Behaviour, as well as the Association of Canadian Archivists' Code of Ethics and Professional Conduct and the Calls to Action of the Truth and Reconciliation Commission of Canada."

"(...) on-going efforts made by staff to acknowledge known instances of discrimination that appear in archival records."

"Content notes will be added to fonds or collection level records indicating, where known, the prevalence of particular types of problematic language or imagery. One such example is the note accompanying digitized versions of The Dominion, which, in part, reads: "The Dominion contains language from the era in which it was written. This includes problematic wording, cultural references, and stereotypes that are no longer used or appropriate today such as racist and sexist jokes or points of view."

"Records improvements and intentional description will be undertaken to allow for improved keyword searching and introduce more precise descriptive language. The finding aids for records in the E Palmer Patterson fonds are an example. They were recently updated to more appropriately refer to First Nations and Inuit, using current language. The work included documenting the changes in names used to refer to peoples over time, such as the Nisga'a or Tlingit, in corresponding authority records."

We will review word choice, do our best to contextualize original language within its historical context, and provide supplemental terms that aid in research. We understand that this process requires continual work, self-reflection, and learning."

Statement of Harmful Language in Penn Libraries Catalogs*

At Penn Libraries we are committed to describing our cataloged resources using inclusive, anti-racist, and non-derogatory language. However, we are aware that racist, homophobic, sexist, ableist or other offensive language can still sometimes be found in our search indexes, bibliographic records, and finding aids. We are working towards mitigating any harm by updating this language.

Harmful or offensive language may appear for the following reasons:

- · Our collections stretch back centuries and many records have not been updated recently
- . Some derogatory terms used to describe oppressed people have been reclaimed and used by authors and creators from those communities
- Preferred terms used by communities to describe themselves can change over time and vary within and between communities
- . We transcribed information directly from materials which contain the offensive language (for example, the title of a book)
- We retained offensive or harmful terms for historical accuracy or to document the issues and social context of a specific time and the attitudes of the people who created the material
- We are using records that were created by commercial vendors and other agencies external to the Libraries

"We commit to changing our recruitment and hiring practices, ensuring direct outreach to candidates of color. As part of that commitment, going forward we will require search advocates for every search committee."

"Beginning now, we will work hard to create an environment that is welcoming to those future colleagues by creating a training and education process for all library staff that focuses on the work we need to do both individually and collectively to bring about an end to discrimination, implicit bias and institutionalized racism."

"The Libraries now try to balance the use of historical terms which provide context, but which are also accurate and respectful. This is an ongoing process of:

- Working directly with misrepresented and underrepresented communities to improve the ways they are represented.
- Informing users about the presence and origin of harmful content.
- Revising descriptions and standardized sets of descriptive terms, such as Library of Congress Subject Headings, supplementing description with humanizing and identity or person-first terms, or creating new standardized terms to describe materials.
- Researching the problem, listening to users, experimenting with solutions, and sharing our findings with each other.

They are based in a nineteenth-century Eurocentric philosophy of information organization and management, and they have actively marginalized, demeaned, and erased groups outside the dominant culture."



NARA's records span the history of the United States, and it is our charge to preserve and make available these historical records. As a result, some of the materials presented here may reflect outdated, biased, offensive, and possibly violent views and opinions. In addition, some of the materials may relate to violent or graphic events and are preserved for their historical significance.

The National Archives is committed to working with staff, communities, and peer institutions to assess and update descriptions that are harmful and to establish standards and policies to prevent future harmful language in staff-generated descriptions.

Ethical Cataloging Statement

Cultural heritage organizations around the world continually reevaluate their practices in order to foster inclusion and more accurately describe the people and cultures represented in their collections. We acknowledge that the language we use to catalog and describe our materials needs improvement. Standardized vocabularies, such as those managed by the Library of Congress or the Getty Research Institute, are constantly reviewed and updated to expand representation and correct biases. But we still sometimes lack authorized terms to accurately capture the experiences of women, people of color, members of the LGBTQ community, or artists from non-Western countries. And some existing terms might use outdated language that we now understand to be harmful.

Enter Search Words

Search

Many of our records are missing information about an artist's race, gender, and culture. This makes it difficult for us to determine which or how many of our resources pertain to underrepresented groups. It is our responsibility to prevent artists from marginalized cultures from being misrepresented, overlooked, or forgotten in our collections.

We are keeping abreast of ethical cataloging practices within the scholarly community and confronting and rectifying problems in our records when they arise. We commit to maintaining transparency regarding our policies and procedures. We invite community input and welcome your feedback. On June 1, 2020, the Clark Library made <u>a</u> <u>commitment to our patrons</u>.

When we said it is important to create "a space in the cultural record for new voices, including those obscured, under-told, or excluded from our library in the past" we meant it.

A library catalog has never been a neutral space¹. It is also more than just a tool for collection discovery. The catalog reflects current and past attitudes towards the authority to name² and describe³, the power to organize and classify⁴. Its structure influences what you can find and how it can be discovered.

While we strive to catalog our collections as

carefully and thoroughly as possible, we acknowledge that previous descriptive practices and outdated metadata conventions sometimes produce entries and information that are not historically accurate, or are offensive or discriminatory.^{5,6}
