

## Publication of a student final thesis on the publication server OPUS of the HNE Eberswalde

Final theses (Bachelor's and Master's theses) by students of the HNE Eberswalde can, under certain circumstances, be stored and published as a quality-assured online publication freely accessible on the web in the HNE Eberswalde Open Access Repository.

The requirements are:

- 1. Students can request the publication of their final thesis for publication with a recommendation from the first examiner.
- 2. The thesis to be published must have been graded 2.5 or better.
- 3. The full text as well as the appendix of the thesis to be published is not restricted or similar.
- 4. The students are obliged to ensure that the rights of third parties do not conflict with the publication.
- 5. The full text of the thesis to be published must be available as an electronic document (PDF (PDF/A is recommended) with the following exemplary file name: Type of thesis\_name [Bachelor thesis\_Mustermann]).
- 6. Appendices belonging to the thesis in electronic form are published with the thesis.
- 7. The University Library checks the bibliographic data and the technical condition of the submitted electronic documents before publication.
