ZUSAMMENFASSUNG

Lärm in Schulen gilt aus unterschiedlichen Gründen als massiver Belastungsfaktor für Lehrkräfte und kann deshalb zu Leistungsdefiziten im Beruf, aber auch zu physischen und psychischen Beeinträchtigungen führen. Die Erforschung von Schullärm und seinen Auswirkungen ist daher essentiell. Die drei Studien, die in dieser Arbeit vorgestellt werden, untersuchten die unmittelbaren Auswirkungen von Lärm auf Lehramtsstudierende und die mittelbaren Auswirkungen auf praktizierende Lehrkräfte.

In der ersten und zweiten Studie wurde im Rahmen zweier Experimente überprüft, wie sich Pausenlärm auf das Stresserleben, die Leistung in einem Konzentrationstest und auf die Fehlerkorrektur eines Diktats auswirkt. Auf Grundlage des transaktionalen Stressmodells (Lazarus & Folkman, 1984) wurde vermutet, dass Lärm zu einer Erhöhung des Stresserlebens führt. Der Maximal-Adaptability-Theorie (Hancock & Warm, 1989, 2003) nach sollte der Lärm zunächst eine optimale Leistung, langfristig jedoch eine Leistungsbeeinträchtigung verursachen. Um dies zu überprüfen, bearbeiteten in der ersten Studie 74 und in der zweiten Studie 104 Lehramtsstudierende der Universität Passau zwei unterschiedliche Konzentrationstests und korrigierten das Diktat eines Schülers, während sie kurzen, kontinuierlichen oder keinen Pausenlärm hörten. In beiden Experimenten führte kontinuierlicher Lärm zu einer Erhöhung des Stresserlebens. Weder kurzer noch kontinuierlicher Lärm führte zu einer Verschlechterung der Konzentrationsleistung. Weiter zeigten sich unterschiedliche Befunde: Im ersten Experiment führte ein kurzer Konzentrationstest in Kombination mit kontinuierlichem Lärm zu positiven Effekten in der Diktatkorrektur, d.h. die Versuchspersonen wiesen eine bessere Leistung in der Fehlerkorrektur auf. Im zweiten Experiment führte ein langer Konzentrationstest in Kombination mit kurzem oder kontinuierlichem Lärm zu negativen Effekten, d.h. die Probanden machten vergleichsweise mehr Fehler bei der anschließenden Diktatkorrektur. Daraus lässt sich schlussfolgern, dass Schullärm einerseits das Stresserleben erhöhen und

andererseits die anschließende Leistungsfähigkeit der Lehrkräfte verbessern oder einschränken kann. Letzteres scheint allerdings von der konkreten Situation abzuhängen.

Im ersten Teil der dritten Studie lag der Fokus auf den Bewältigungsstilen und dem erlebten Stress der Lehrkräfte. Da Bewältigungsstile nachweislich einen großen Einfluss auf die psychische Gesundheit haben, lag die Vermutung nahe, dass das durch Lärm verursachte Stresserleben je nach Bewältigungsstil unterschiedlich ausfällt. Auf der Grundlage des Belastungs-Beanspruchungsmodells (Rudow, 2000) und des transaktionalen Stressmodells (Lazarus & Folkman, 1984) wurde angenommen, dass Lehrkräfte mit riskanten Copingstilen mehr Stresssymptome erleben. Deshalb wurde im Rahmen einer Online-Studie untersucht, ob es in Bezug auf psychische und körperliche Symptome Unterschiede zwischen Lehrkräften mit distinkten Bewältigungsstilen gibt. Dazu wurden 99 bayerische Grund- und Mittelschullehrkräfte befragt. Aus den übergeordneten Skalen Engagement und Resilienz resultierten vier berufliche Bewältigungsstile. Der Typ Gesundheit (hohes Engagement, hohe Resilienz), der Schon-Typ (niedriges Engagement, hohe Resilienz), Typ A (hohes Engagement, niedrige Resilienz) und Typ Burnout (niedriges Engagement, niedrige Resilienz) unterschieden sich hinsichtlich Bedrohungseinschätzung, Lärmstress, Stimm- und Hörproblemen sowie lärmbedingtem Burnout. Im Vergleich zum Typ Gesundheit wiesen die Risikotypen Typ A und Typ Burnout ein höheres Stresserleben auf und erwiesen sich generell anfälliger gegenüber Schullärm als der Typ Gesundheit. Dies ist die erste Studie, die zeigen konnte, dass Schullärm besonders für Lehrkräfte mit riskanten Copingstilen eine Gefährdung darstellt.

Im zweiten Teil der dritten Studie lag der Fokus auf den Wirkungspfaden von Schullärm. Hier wurden Zusammenhänge zwischen individuellen Eigenschaften der Lehrkräfte und den unterschiedlichen Auswirkungen von Schullärm vermutet. Basierend auf dem vereinfachten Modell von Lehrerstress (van Dick & Wagner, 2001) wurde an 159 bayerischen Grund- und Mittelschullehrkräften untersucht, ob Lärmstress und

Stimmermüdung die Verbindung zwischen Lärmempfindlichkeit und lärmbedingtem Burnout vermittelten. Die Ergebnisse zeigten, dass Stress die Beziehung zwischen Lärmempfindlichkeit und Stimmermüdung vermittelte; Stimmermüdung vermittelte die Beziehung zwischen Lärmstress und lärmbezogenem Burnout; Lärmstress und Stimmermüdung vermittelten seriell die Beziehung zwischen Lärmempfindlichkeit und lärmbedingtem Burnout. Dies ist die erste Studie die Verbindungen zwischen lärmempfindlichen Lehrkräften und Lärmstress, Stimmproblemen und lärmbedingtem Burnout aufzeigen konnte.

ABSTRACT

Noise in schools is considered a massive stress factor for teachers because of various reasons and can therefore lead to performance deficits in the job, but also to physical and psychological impairments. Consequently, research on school noise and its effects is essential. The three studies presented in this paper examined the immediate effects of noise on student teachers and the collateral effects on practicing teachers.

In the first and second study, two experiments were conducted to examine the effects of noise during breaks on stress experience, performance in a concentration test, and error correction of a dictation. Based on the transactional stress model (Lazarus & Folkman, 1984), it was hypothesized that noise leads to an increase in stress experience. According to the maximal adaptability theory (Hancock & Warm, 1989, 2003), noise should initially cause optimal performance, but in the long run should cause performance impairment. For this purpose, in the first study 74 and in the second study 104 student teachers of the University of Passau worked on two different concentration tests and corrected a student's dictation while listening to short, continuous, or no noise. In both experiments, continuous noise led to an increase in the experience of stress. Neither short nor continuous noise led to a deterioration in concentration performance. Further, different findings emerged: In the first experiment, a short concentration test in combination with continuous noise led to positive effects in dictation correction, i.e., subjects showed better performance in error correction. In the second experiment, a long concentration test combined with short or continuous noise resulted in negative effects, i.e., subjects made more errors in the subsequent correction of dictation. It can be concluded that school noise can, on the one hand, increase the experience of stress and, on the other hand, promote or limit teachers' subsequent performance. The latest, however, seems to depend on the specific situation of the individual.

In the first part of the third study, the focus was on teachers' coping styles and experienced stress. Since coping styles have been shown to have a major impact on mental

health, it was reasonable to assume that the stress experience caused by noise would vary depending on the coping style. Based on the stress-strain model (Rudow, 2000) and the transactional stress model (Lazarus & Folkman, 1984), it was hypothesized that teachers with risky coping styles experience more stress symptoms. Therefore, an online study was conducted to investigate whether there were differences in psychological and physical symptoms between teachers with different coping styles. For this purpose, 99 Bavarian elementary and middle school teachers were surveyed. Four professional coping styles resulted from the overarching scales of professional commitment and resilience. The healthy type (high commitment, high resilience), the unambitious type (low commitment, high resilience), type A (high commitment, low resilience), and type burnout (low commitment, low resilience) differed in terms of threat appraisal, noise stress, voice and hearing problems, and noise-related burnout. Compared to the healthy type, the risk types – type A and type burnout – exhibited higher stress experience and were generally more susceptible to school noise than the healthy type. This is the first study to show that school noise is particularly hazardous for teachers with risky coping styles.

The second part of the third study focused on the impact pathways of school noise. Associations between teachers' individual characteristics and the consequences of school noise were hypothesized. Based on the simplified model of teacher stress (van Dick & Wagner, 2001), we examined 159 Bavarian elementary and middle school teachers to determine whether noise stress and vocal fatigue mediate the association between noise sensitivity and noise-related burnout. Results indicated that noise stress mediated the relationship between noise sensitivity and vocal fatigue; vocal fatigue mediated the relationship between noise stress and noise-related burnout; noise stress and vocal fatigue serially mediated the relationship between noise sensitivity and noise-related burnout. This is the first study to show links between noise-sensitive teachers and noise stress, voice problems, and noise-related burnout.

1. General Introduction

1.1.Introduction

“Students can be noisy. It distracts my concentration, takes time from the class, and, also, I am afraid someone else will hear the noise and think it’s disruptive or not a learning environment” (Blase, 1986, p. 32). This teacher statement from the 1980s illustrates well that noise was a major stressor in schools for various reasons. However, Blase (1986) was not the first researcher to identify school noise as a stress factor for teachers. Since the 1950s and 1960s, scientists have been addressing the issue of noise in educational institutions (Lane, 1957; Sanders, 1965).

Since then, of course, the teaching profession has changed a lot (cf. Perkhofer-Czapak & Potzmann, 2016). Examples include the form of teaching as well as the composition of the class (Laal et al., 2014; Werning, 2010). Whereas in the past, students were taught primarily in a frontal manner, nowadays open lessons or group work are increasingly used because of their positive effects on students’ growth of knowledge, self-esteem or even on the relationship between students (Laal et al., 2014; Laal & Ghodsi, 2012). In addition, with the UN Convention on the Rights of Persons with Disabilities, the goal of inclusive education came to the fore (cf. Hendriks, 2007). In line with the implementation of inclusive education, today’s classes often include students with quite different intellectual, social and emotional ability profiles, prior knowledge and social backgrounds (Werning, 2010). Despite some improvements due to these changes (e.g., Rafferty et al., 2003; Tolmie et al., 2010), school noise levels do not seem to have decreased as a result (cf. Galaterou & Antoniou, 2017; Sala & Rantala, 2016). Thus, school noise still is a central topic in educational research (Kyriacou, 2001; Nübling et al., 2008; Schönwälder et al., 2004) and, given the aforementioned changes (Laal et al., 2014; Werning, 2010), is perhaps an even more important issue today than it was then, as demands on teachers have increased (cf. van Droogenbroeck et al., 2014) and noise levels are still high (cf. Galaterou & Antoniou, 2017; Sala & Rantala, 2016).

Much of the focus so far has been on the negative effects that noise has on children's and adolescents' stress experience, cognitive development, memory performance, or academic achievement (Klatte et al., 2010; Klatte et al., 2013; Klatte et al., 2017; Lercher et al., 2003; Shield & Dockrell, 2008). As will become obvious below, fewer researchers have addressed the ways in which daily noise exposure affects teachers.

Some research has at least shown that teachers experience stress symptoms and health problems due to school noise (Enmarker & Boman, 2004; Kristiansen et al., 2014; Lin et al., 2020; Meuer & Hiller, 2015). Research on other occupational groups has already revealed noise-related psychological, physical and behavioral impairments at work as well as correlations to individual traits (Evans & Johnson, 2000; Golmohammadi et al., 2021; Kjellberg et al., 1998). Unlike these professions, teachers' performance (e.g., teaching behavior, assessments/grades), protective factors (e.g., coping styles, individual characteristics) and pathways of impact regarding noise have been largely ignored. However, since teachers often have to teach in noisy classrooms or work in other noisy environments (e.g., supervision during breaks), scientific knowledge on the issue of noise is also necessary in this professional field.

To the best of my knowledge, there is only one experimental and one quasi-experimental study that investigated the negative effects of noise on teachers' performance and showed that their cognitive performance suffered (Arezes et al., 2010; Enmarker, 2004). Another study examined impact pathways on female teachers and other female employees and elicited noise annoyance as a significant mediator between occupational noise exposure and auditory fatigue, with stress acting as a moderator (Fredriksson et al., 2017). Studies on how school noise affects teachers with different coping styles are completely lacking.

From my experience, there might be three reasons why there is so little research in this area. Firstly, it is generally legally difficult to conduct research in schools. Secondly, schools may even fear negative consequences due to the study results. Thirdly, a theoretical model

regarding noise on the basis of which hypotheses can be explicitly derived is lacking so far for the educational context.

Despite these difficulties, teachers' continuous noisy school life with its possible negative consequences (Kristiansen et al., 2011) emphasize the need for scientific investigations in this field. Resulting findings could help to shift the focus to the issue of school noise and recognize the importance of taking appropriate action. Therefore, the main objective of the present work was to investigate effects of school noise on (prospective) teachers' behavior, mental and physical health, to survey possible protective factors, and to identify impact pathways. To achieve these goals, two experiments on student teachers and a quantitative online survey on practicing teachers were conducted. These three studies are the subject of this paper.

In the first chapter, a detailed description of the theoretical models used in the studies is provided. After that, the theoretical background is explained in more detail. It briefly discusses the teaching profession, teachers' general stress responses, common factors that cause stress in the teaching profession, and possible protective factors. Subsequently, the term noise is defined and guidelines for noise exposure are analyzed. Thereafter, school noise is discussed in more detail, the relationship to noise sensitivity and coping styles is established and consequences of noise are discussed. Finally, a brief description of the study objectives is provided. While study 1 and 2 are presented together in the second chapter, the third study is presented separately by survey period and research focus in chapters 3 and 4. Since Study 3a has already been published, in this work only its abstract is presented. Finally, the fifth chapter summarizes the main findings and discusses practical implications for everyday school life as well as for future research.

1.2.Models

In order to be able to investigate the extent of the consequences of school noise for teachers, theoretical models are needed that make it possible to derive concrete hypotheses. In

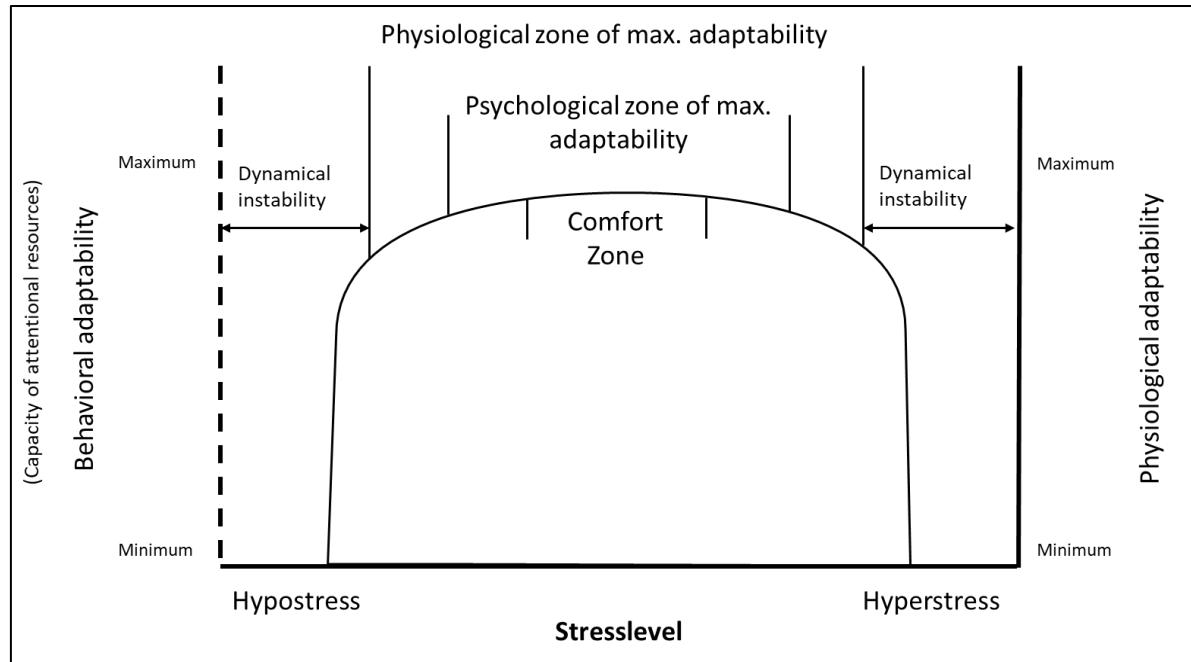
the following, four models are presented on the basis of which potential effects of noise on teachers' work performance or stress experience can be predicted.

1.2.1. Maximal Adaptability Theory

The maximal adaptability theory (Hancock & Warm, 1989, 2003) was developed to explain performance under various conditions and assumes that environmental factors have an impact on task performance. Thus, it has been tested not only with the environmental stimulus noise, but also by means of heat, cold, or pressure. As can be seen in Figure 1.1, the authors assume an optimal range, called the comfort zone, in which the individual performs best. Outside this comfort zone, the individual is in a dynamic instability, where performance is worse. The comfort zone is reached only when there is an optimal level of stress resulting from task and environmental demands. This optimal level of stress enables the body to adapt optimally to the requirements; i.e. it is in the zone of maximal physiological, psychological and behavioral adaptability. The physiological adaptability refers to the physical homeostasis, i.e. the body constantly tries to establish a balance by comparing actual and target values and, if necessary, initiating changes. One way to explain this physiological adaptability is with the following example (cf. Hancock & Warm, 1989, 2003): If a person hears noise during a task, their ears react with a protective reflex, i.e. the ears are *closed* somewhat in order to reduce the acoustic stress and to better isolate from the noise. The psychological adaptability comprises evaluation processes: If the person perceives the task processing in combination with noise as a challenge and estimates their own coping resources as sufficient, an optimal psychological adaptability prevails. Behavioral adaptability refers to attentional resources. Optimal behavioral adaptive performance occurs when the available capacity of attentional resources can be used optimally. Outside these zones, there is too little activation (*hypostress*) or too much activation (*hyperstress*), both of which cause instability of the system and a lack of optimal adaptation, which in turn has a negative effect on performance.

This can be illustrated by an example: If the individual is required to solve a monotonous task that activates poorly, additional noise may lead to an improvement in performance because the individual is approaching the comfort zone. If the individual is confronted with a very complex task and is highly activated, additional noise leads to poorer adaptation and thus poorer performance. This can also be applied separately to physiological, behavioral and psychological adaptability (cf. Hancock & Warm, 1989, 2003): If the individual is confronted with a monotonous task, they are probably barely activated (physiological) and likely to evaluate the task as unchallenging, perhaps even as irrelevant or boring (psychological), which also means that attentional processes are not optimally utilized (behavioral). If the individual works on a simple task and is additionally exposed to noise, the interaction of environmental and task demands leads to greater activation (physiological), so that the individual may experience the task as challenging (psychological) and attentional

resources are fully utilized for task accomplishment (behavioral). If the individual works on a complex task and is additionally exposed to noise, the interaction of environmental and task demands leads to excessive activation (physiological), so that the individual may experience the task as threat and perceive that their coping resources are not sufficient to cope well with the task under noise (psychological). In addition, attentional resources (behavioral) are not sufficient to master the task well. This model (cf. Figure 1.1) formed the basis for the hypotheses of study 1 and 2.

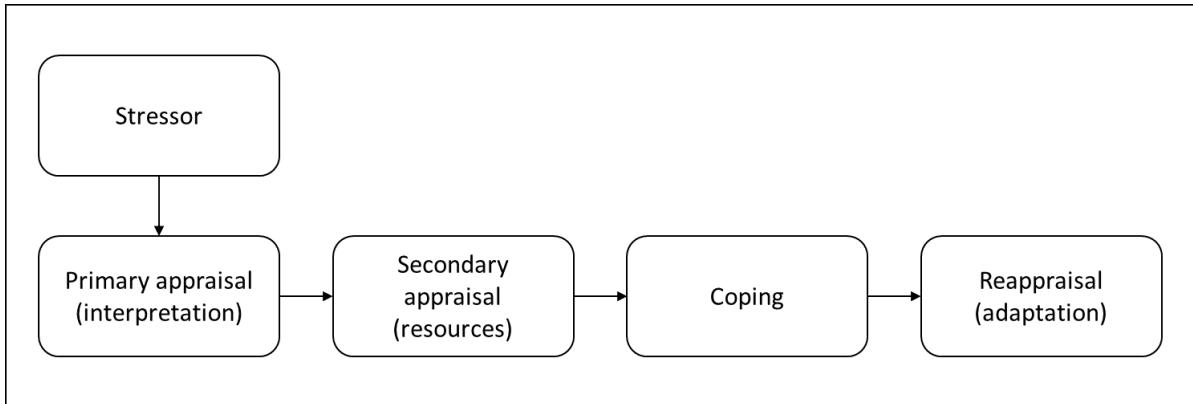
1.2.2. Transactional Stress Model

The transactional stress model (Lazarus & Folkman, 1984) is probably the best-known model in psychological stress research. The authors assume that stress experience arises from two cognitive appraisal processes (cf. Figure 1.2). A person is exposed to an internal (e.g., mental, pictorial) or external (e.g., from the environment, from another person) stressor, which triggers an unconscious evaluation process: First, the individual assesses whether the stressor is relevant or irrelevant. If it turns out to be relevant for the individual, then it assesses whether the stressor is threatening, harmful or challenging (*primary appraisal*). Second, the assessment of coping resources takes place: The individual assesses whether their own coping resources are sufficient to deal well with the stressor (*secondary appraisal*). The highest stress experience results from the assessment of the stressor as a threat or harm and from the experienced lack of coping resources (cf. Lazarus & Folkman, 1984).

According to Lazarus and Folkman (1984), reappraisal can result from coping with the stressor. For example, after successfully coping with a task during noise exposure, the individual might experience subsequent tasks involving noise as less threatening than before. However, if the noise lasts longer and is experienced as uncontrollable, coping attempts may fail, leading to stress or fatigue, which in turn has a negative impact on mental health (Eisenmann, 2006).

Indeed, noise is often experienced as uncontrollable (cf. Glass & Singer, 1973), chronic, negative, and intractable (Campbell, 1983). In addition, adequate coping with noise is limited (Lercher et al., 2000). According to the transactional stress model, these appraisals should result in severe stress experience (cf. Lazarus & Folkman, 1984). In line with this assumption, a study was able to show that individuals who are exposed to noise and know that it can be harmful are more likely to report noise stress (Crichton et al., 2015). The transactional stress model (Lazarus & Folkman, 1984) was used as the theoretical basis for deriving most of our hypotheses, except for the second part of the third study.

1.2.3. Stress-Strain Model

The third model used in the present work is the stress-strain model (Rudow, 2000). In order to explain this model (see Figure 1.3), it is necessary to first define the terms *demands*, *psychological stress* and *strain*:

Demands of a work action result from the work assignments and the working conditions. The demands define the regulation necessary to master a work action. Demands that exceed or fall short of the performance prerequisites can lead to overload or underload, respectively (cf. Joiko & Wolff, 2010).

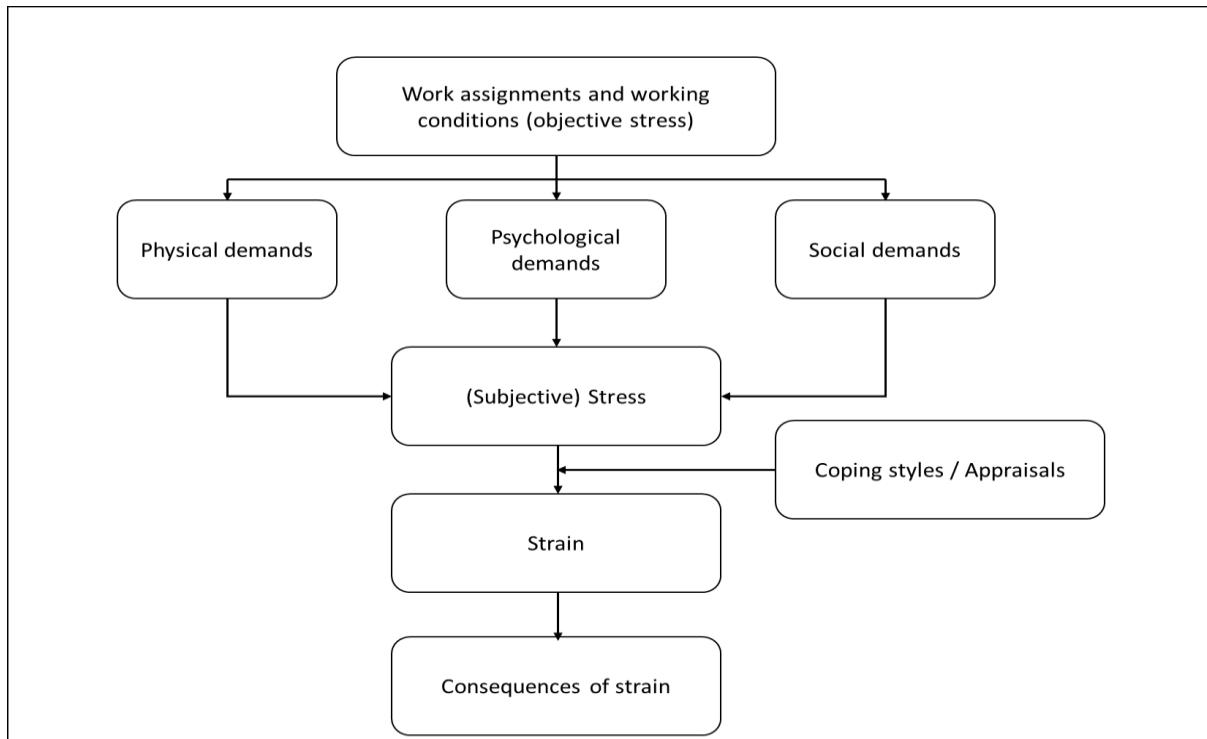
Psychological stress is the totality of all ascertainable influences that come from the outside and have a psychological effect on the person (DIN Deutsches Institut für Normung e.V., 2018).

Psychological strain is the immediate (not long-term) effect of psychological stress in the individual depending on her or his respective enduring and momentary conditions, including individual coping strategies (DIN Deutsches Institut für Normung e.V., 2018).

The stress-strain model (Rudow, 2000) appears to combine the maximal adaptability theory (Hancock & Warm, 1989, 2003) and the transactional stress model (Lazarus & Folkman, 1984): Environmental and task demands (objective stress) entail psychological, social, or physical demands to which the individual must adapt. High demands can lead to subjective stress, which can result in short-term strain and long-term strain consequences. Like the previously described theories, this model also assumes that appraisals and/or coping styles have an influence on the strain that results from the stress (Rudow, 2000). With regard to noise, the following can be concluded: Schools entail certain work assignments (e.g., break supervision) and working conditions (e.g., break noise). These pose primarily physical and psychological demands and lead to short-term subjective stress (e.g., threat appraisal). In the medium term, this subjective burden of noise leads to strain (e.g., hearing problems), which in the long term can lead to strain consequences (e.g., burnout) (Peeters & Rutte, 2005).

However, following the transactional stress model (Lazarus & Folkman, 1984), we assumed an influence of coping styles on all components (stress, strain, and strain consequences). Accordingly, we modified the stress-strain model (Rudow, 2000) shown in Figure 1.3. The model we used is described in more detail in the first part of the third study. Based on this modified model, the hypotheses of the first part of the third study were formulated.

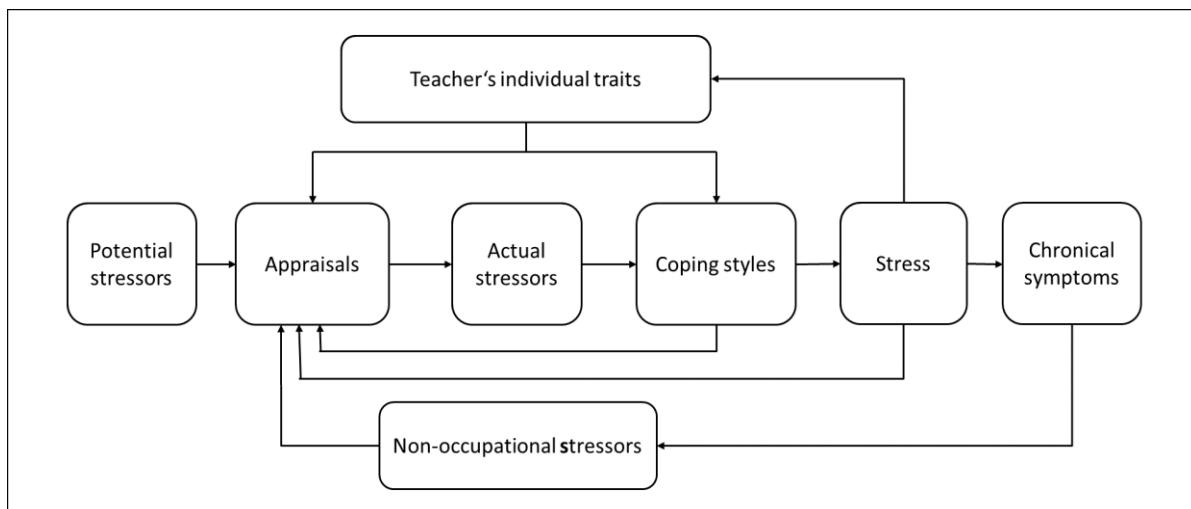
1.2.4. Model of Teacher Stress

Finally, the last model described (see Figure 1.4) is frequently used in the Anglo-American area. In this model, occupational stressors are distinguished from non-occupational stressors. Both types trigger appraisals (cf. Lazarus & Folkman, 1984), which can turn potential stressors into actual stressors. Mediated by individual coping mechanisms, the actual stressors can lead to stress and, in the long run, to chronic symptoms. Teachers'

characteristics influence both assessments and coping mechanisms in this process. In addition, feedback processes are hypothesized. Thus, chronic symptoms are assumed to have an influence on non-occupational stressors; experienced stress and coping mechanisms in turn affect appraisals. In addition, teachers' individual characteristics are influenced by perceived stress.

According to the model, noise is considered a potential stressor, which can become an acute stressor through the appraisals of the noise – influenced by teachers' individual characteristics, such as noise sensitivity. Teachers' coping styles have a critical influence on the degree to which stress, like vocal fatigue, is experienced. The resulting stress perception in turn is related to chronic symptoms, like noise-related burnout. Since the model of teacher stress is quite complex, we used the simplified form of van Dick and Wagner (2001) and adapted it to our research question. Based on this modified model, the hypotheses of the second part of the third study were formulated.

1.2.5. Interim Summary

Four models were presented from which hypotheses about the effects of school noise for (prospective) teachers were derived. To predict effects on teachers' work performance, the maximal adaptability theory was used (study 1 and 2). Hypotheses related to teachers' stress experience were derived based on the transactional stress model (studies 1, 2, and 3a). To make statements about influences of teachers' individual factors on noise effects, the stress-strain model (study 3a) and the model of teacher stress (study 3b) were used. In order to assess the impact of school noise on teachers, the following section takes a closer look at the teaching profession.

1.3.Teaching Profession

The teaching profession has always played a prominent role in society. No other occupational group has such a decisive importance for the education of our society (Shim, 2008). Therefore teachers have a major responsibility (Eacute & Esteve, 2000), which is also evident in their job description:

Teachers work at educational institutions, where they educate and teach students. In the context of education, they impart social behaviors and value systems and are contact persons for students in subject-related and personal matters. In teaching, they impart factual knowledge, subject knowledge as well as various skills and guide students to think and work independently. (Berufe-Lexikon, 2021)

An even more detailed description of teachers' responsibilities can be found in the Standards for Teacher Education from the Secretariat of the Standing Conference of the Ministers of Education and Cultural Affairs of the Länder in the Federal Republic of Germany (KMK, 2004/16.05.2019):

1. Based on scientific research, teachers have to plan, organize, reflect, assess, and evaluate teaching and learning processes.

2. Teachers have an educational task in school, should therefore cooperate with parents and find constructive solutions when educational problems arise or learning processes fail.
3. Teachers should be competent, fair, and responsible in their assessments and consultations.
4. Teachers should continuously develop their skills and participate in continuing education and training opportunities in order to incorporate new developments and scientific findings into their professional activities. In addition, teachers should maintain regular contact with other institutions.
5. Teachers should participate in school development, in shaping a school culture that is conducive to learning and in creating a motivating school climate. This also includes willingness to participate in evaluations.

From this description, it can be deduced that teachers, due to their duties, have to perform many different tasks in everyday school life, which by themselves can lead to stress (Brown et al., 2002).

1.3.1. Stress Responses

Therefore, teaching is considered a stressful profession (cf. Kyriacou & Sutcliffe, 1978), from which anger, anxiety, tension, frustration, or depression can arise (Kyriacou, 2001, p. 28). Such unpleasant, negative feelings, referred to as teacher stress (Kyriacou, 2001), are quite common in the teaching profession (Nübling et al., 2008; Nübling et al., 2012). For example, 20% of 257 teachers from England surveyed found their profession very stressful or even extremely stressful (Kyriacou & Sutcliffe, 1978). Due to this stress, approximately 66% suffered from chronic psychophysical complaints and regularly sought medical attention (Schönwälde et al., 2004). Furthermore, strong associations were found between self-reported stress in the teaching profession and somatic, depressive, and anxiety

symptoms (Kyriacou & Pratt, 1985). Long-term consequences of teacher stress include sick days (Howard & Howard, 2020), turnover (Harmsen et al., 2018), burnout (Ho, 2017; Kokkinos, 2007), and early retirement (Brown et al., 2006; Weber et al., 2005).

In addition to health, stress can also affect job performance at school (Asaloei et al., 2020). This manifests itself, for example, in the fact that stressed teachers' teaching ability is reduced (Blase, 1986), that teachers make more mistakes during work (Marwat et al., 2012), and that their teaching behavior (Harmsen et al., 2018) and productivity (Marwat et al., 2012) suffer. In the worst cases, teachers' stress or resulting impaired mental health even negatively impacts student-teacher relationships (Yoon, 2002), student achievements (McLean & McDonald Connor, 2015), and assessments of student behavior (Kokkinos et al., 2005). In addition, teacher stress also entails high financial costs, both to the economy and to the health care system (Wiley, 2000).

1.3.2. Stress Factors

As can already be surmised from the above-mentioned current job profile, the reasons for this teacher stress are manifold (cf. Kyriacou, 2001). Kyriacou and Sutcliffe (1978) earlier identified four overarching dimensions of teacher stressors in a factor analysis: Inappropriate student behavior, poor working conditions, time pressure, and low school ethos. These factors included, for example, too many lessons, too many organizational tasks, supervisory duties (e.g., break supervision), no recovery time between lessons, or maintaining discipline in the classroom (Kyriacou & Sutcliffe, 1978). Other more recent studies identified role conflicts, lack of materials, paperwork requirement, limited communication, heterogeneous learners, the urban setting, control of time or interference with instruction as subjects of stress in the teaching profession (Blase, 1986; Eacute & Esteve, 2000; Embich, 2001; Flores, 2018; Mérida-López et al., 2017; Shernoff et al., 2011).

One stressor that comes up repeatedly in both previous and more current research is school noise (Blase, 1986; Kyriacou & Sutcliffe, 1978; Shernoff et al., 2011). Therefore,

school noise, in addition to other occupational demands, seems to be a relevant stress factor. However, in order to address possible protective factors against school noise later on, teachers' general protecting factors will be briefly discussed first before turning to the topic of noise in detail.

1.3.3. Protective Factors

In addition to investigations on stress factors like noise, there is also increasing research on what factors can counteract them. Some of these protective factors, such as specific classroom management skills (Dicke et al., 2015) or the extent of pedagogical knowledge, that indirectly promotes mental health (Lauermann & König, 2016), can be learned. In addition, it has been shown that satisfied basic needs (cf. Deci & Ryan, 1985), such as relationships with colleagues (Bottiani et al., 2019), the experience of social support by the teaching staff (Wolgast & Fischer, 2017), or perceived autonomy (Skaalvik & Skaalvik, 2014), can attenuate stress responses. Beyond that, individual characteristics, such as learning goal orientation (Nitsche et al., 2013), experienced self-efficacy (Tsouloupas et al., 2010), optimism (Desrumaux et al., 2015), appraisals (Lambert et al., 2009), and coping strategies (Montgomery & Rupp, 2005) act protectively against teacher stress.

1.3.4. Interim Summary

Teachers are confronted with various demands and stressors in their profession, which can lead to psychological, physical and behavioral impairments. However, teacher stress research also points to protective factors that can mitigate the consequences of stress factors. One important stress factor in the teaching profession is school noise. Its characteristics, possible protective factors, and effects will be discussed in more detail in the following section.

1.4.Noise

Since teachers are confronted with noise for a large part of their working time every day (Kristiansen et al., 2011), it is not surprising that a survey found 80% of German teachers feel stressed by student noise (Schönwälder et al., 2003). Noise refers not only to the actual loudness, but also to the subjective experience (cf. Stansfeld & Matheson, 2003). Thus, all sounds that are perceived as unpleasant and interfering are referred to as noise (Babisch, 2011; Stansfeld & Clark, 2019). Accordingly, the term noise includes all sounds that lead to annoyance, disturbance, impaired performance, special accident hazards or damage to health (Maue, 2009, p. 17).

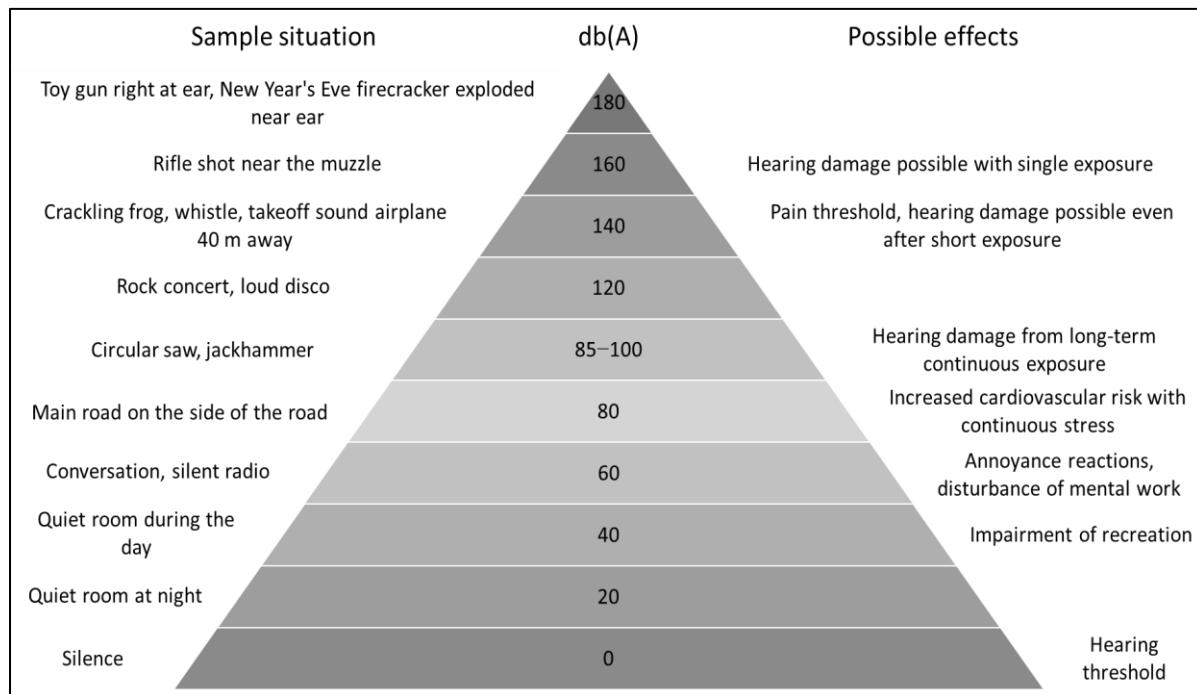
1.4.1. Noise Characteristics

General. In order to assess the extent of noise, the logarithmic unit of measurement decibel (db) is used. An increase of 3 db corresponds to a doubling of the noise source (Śliwińska-Kowalska & Zaborowski, 2017), like two students speaking instead of one. To the human ear, an increase of 10 db appears to be twice as loud (Suter, November / 1991). Since the human ear perceives low and high tones more quietly than medium frequencies, the determined sound pressure levels are converted and corrected that the subjective loudness is represented realistically. The resulting sound levels are given in db(A) (Bundesministerium für Umwelt, Naturschutz und nukleare Sicherheit, 2021).

Noise as a physical stressor can cause a variety of impairments (Clark & Paunovic, 2018). The duration and intensity are decisive for how and to what extent noise has a physical impact (Babisch, 2011). However, low sound levels can have psychological effects (cf. Ising & Kruppa, 2004). Figure 1.5 provides a good overview of exemplary noise sources and potential effects of various volume levels. It can already be seen that higher volume levels can lead to hearing damages and lower noise intensities are sufficient to cause cognitive as well as emotional impairments.

School Noise. In schools, the noise pollution results from external sources (e.g., neighboring schools), and internal sources, such as school buildings (e.g., insulation), human activities (e.g., chatting, yelling during breaks), or equipment (e.g., air conditioners) (Åhlander et al., 2011; Koszarny & Goryński, 1990; Puglisi et al., 2015). Preschool teachers cited indoor activities due to bad weather, insufficient space, reverberation, excited or misbehaving students, noise from outside, diverse activities (e.g., playing music), air conditioning, and alarm systems as reasons for noise (Grebennikov & Wiggins, 2006). While activity noise (e.g., chatter, scrapping chairs) was identified as the most annoying source of noise (Enmarker & Boman, 2004), schoolyards, classrooms and school hallways are perceived as noisiest (Eysel-Gosepath et al., 2012). Since several noise sources contribute to the respective loudness in schools, the term school noise is used non-specifically in the following.

Depending on the study, sample, and school situation, the noise levels that were recorded vary significantly. Within the classrooms, the predominant noise comes from children, whose volume can vary by approximately 20 db(A) from the quietest to the loudest activity (Shield & Dockrell, 2004), and range from 56 db(A) to 77 db(A) (Shield & Dockrell, 2004; Skarlatos & Manatakis, 2003). The background sound level is related to the number of children in the classroom. The more children there are in the classroom, the higher the background noise (Shield & Dockrell, 2004). For instance, a value of about 65 db(A) could be measured for 20 children and about 70 db(A) for 30 children (Shield & Dockrell, 2004). For sports and music teachers, the volume can be even higher due to the activities performed in class. For example, in one case study, a peak of 119 db(A) was measured in a gymnasium (Jiang, 1997). In music classes, a peak of 98 db(A) was recorded (Behar et al., 2004). High noise levels can also be reached outside the classroom, i.e. during breaks. Depending on the study and location (break hall or schoolyard), the values vary between 75.9 db(A) and 78.89 db(A) (Sarantopoulos et al., 2014; Skarlatos & Manatakis, 2003).

In order to limit these noise levels and possible resulting consequences, guidelines have been developed for various occupational groups (cf. Schwela, 1999). In the school context, WHO recommends 35 db(A) during teaching in classrooms and 55 db(A) in schoolyards (Schwela, 1999). To protect the voice and maintain concentration and attention, a milder guideline recommends values below 55 db(A) in teaching and learning rooms (Schönwälder et al., 2004). Apparently, however, even this milder limit for classrooms is commonly exceeded (cf. Schönwälder et al., 2004; Shield & Dockrell, 2004; Skarlatos & Manatakis, 2003).

Considering that noise levels in schools can reach the volume of a noisy main street (cf. Babisch et al., 2007; Grebennikov & Wiggins, 2006) and teachers are exposed to noise for 25% of their working time (Kristiansen et al., 2011), it is not surprising that one third of

teachers reported severe occupational noise exposure (Rezende et al., 2019) as well as mental and physical health complaints (Augustyńska et al., 2010).

However, since the objective noise exposure per week is only weakly correlated with the subjective noise exposure (Sjödin, 2017), it can be inferred that the consequences teachers suffer from school noise are not only objective but also subjective in nature (cf. Stansfeld & Clark, 2019). Accordingly, personal characteristics, like attitudes and individual differences, also seem to play a decisive role (cf. Kjellberg et al., 1996).

1.4.2. Personal Characteristics

According to Stansfeld et al. (2000), in addition to the experienced controllability of noise, noise sensitivity and coping strategies are important personal characteristics that can influence the effects of noise. Because the experienced controllability of noise in an educational context is likely related to other factors such as appropriate classroom management, only noise sensitivity and coping strategies are presented below.

Noise Sensitivity. Noise sensitivity is defined as an individual physiological and psychological constitution that generally increases the degree of response to noise (Shepherd et al., 2015). It often has a stronger influence on health than objective noise exposure (Stansfeld et al., 2000) and accordingly influences psychological and physical stress responses (Nazneen et al., 2020). Noise-sensitive individuals generally perceive noise as more stressful than less sensitive individuals (Belojević et al., 1992) and experience higher levels of strain (Sandrock et al., 2009). Accordingly, positive correlations could be found between individual noise sensitivity and perceived stress, irritability, concentration problems, fatigue as well as headaches (Baliatsas et al., 2016). In addition, there is preliminary evidence that noise sensitivity is associated with an increased risk of mental illness (Stansfeld & Shipley, 2015), such as depression or anxiety (Baliatsas et al., 2016).

In the school context, the characteristic of noise sensitivity has received less attention, although it has certainly been demonstrated that teachers are on average more sensitive to

noise than students (Schönwälde et al., 2004) and noise-sensitive teachers experience school noise as more stressful than less noise-sensitive teachers (Enmarker & Boman, 2004). Since individual noise sensitivity is strongly related to physical and mental health (Baliatsas et al., 2016), and more noise-sensitive teachers experience higher stress due to noise (Enmarker & Boman, 2004), the second part of the third study was to investigate how teachers' noise sensitivity is related to physical and mental symptoms.

Coping Styles. Similar to noise sensitivity, it is possible that individual coping styles have an impact on how noise affects teachers. Coping styles are understood as intellectual and behavioral resources that an individual employs to respond to stressful situations (Lerias & Byrne, 2003). Many studies have been conducted on teachers' coping styles (e.g., Antoniou et al., 2006; Stoeber & Rennert, 2008). For example, it has been shown that stress disorders can be reduced by proactive strategies (e.g., Pietarinen et al., 2013), and that other coping styles, such as emotional suppression, negatively influence the experience of stress (Griffith et al., 1999).

A very well-established classification of coping styles is achieved by the questionnaire work-related behavior and experience patterns (Schaarschmidt & Fischer, 2008). With this instrument, four coping styles – the healthy type, the unambitious type, the burnout type, and the type A – can be derived from the three dimensions of occupational commitment, resilience, and emotions (Schaarschmidt, 2006). Commitment is made up of the importance of the occupation, professional ambition, the willingness to spend energy and the striving for perfection. Resilience refers to the ability to distance oneself, the tendency to resign in the face of failure, offensive problem-solving, inner calm as well as balance. The third dimension of emotions comprises the experience of success at work, life satisfaction and the experience of social support (Kieschke & Schaarschmidt, 2008). The healthy type is per definition healthy, willing to perform and feels well; it shows high, though not too high, commitment with high resilience. The unambitious type protects itself from stress, feels relatively well, and

exhibits low commitment with high resilience. Type A exhibits over-commitment; its resilience, ability to recover, and well-being are limited. The burnout type feels unwell, shows little commitment, tends to have low resilience, high resignation and suffers from chronic exhaustion (Kieschke & Schaarschmidt, 2008). A study among teachers was able to show that the healthy type and the ambitious type suffer from only a few physical and psychological problems, while the type A and the burnout type complain about many physical and psychological symptoms (Bauer et al., 2006). Although coping styles have been shown to influence teachers' stress reactions (Bauer et al., 2006), there is a lack of research on how coping styles affect noise-related stress symptoms. How teachers' coping styles are related to effects of school noise is discussed in more detail in the first part of the third study.

1.4.3. Noise Effects

Despite possible individual protective factors, noise is considered a psychosocial stressor that, even at low doses, can cause maladaptive psychological responses and affect physical health via interactions between the autonomic nervous system, neuroendocrine system, and immune system (Clark & Stansfeld, 2007; Rylander, 2004). With regard to the consequences of noise, aural effects can be distinguished from extra-aural effects (Ising et al., 1996; Robert Koch Institut, 2020). While aural effects, i.e., hearing damage, depend on the duration and strength of the noise, extra-aural effects are more common and independent of duration and strength (Ising et al., 1996). The latter include communication problems, cardiovascular and physiological, mental health, and performance effects (Schwela, 1999).

For teachers, a negative correlation between noise and individual well-being was shown (Karjalainen et al., 2020). Furthermore, 25% of interviewed teachers mentioned complaints in the ear-nose-throat area, 10% reported cardiovascular complaints, 10% psychological and 10% neurological problems (Schönwälde et al., 2004).

Hearing Impairments. Noise causes various hearing problems (Themann & Masterson, 2019). This includes complete hearing loss (Themann & Masterson, 2019), which

can result from a single exposure to noise (e.g., from a gunshot) or from long-term exposure to noise at levels between 75-85 db(A) (Basner et al., 2014). These types of noise exposure damage auditory sensory cells in the cochlea to such an extent that they can no longer regenerate (Basner et al., 2014). From this, unusual volume perception (Berglund & Lindvall, 1995), perceived distortion (paracusis), or tinnitus, which is the subjective perception of a sound in the absence of an auditory stimulus, can arise (Themann et al., 2013).

A study among teachers revealed that daily exposure to noise can lead to short-term and possibly long-term changes in the outer hair cells (Novanta et al., 2020). Accordingly, teachers – due to constant exposure to sound (Jiménez-Tejada et al., 2012) and high level of occupational stress (Eysel-Gosepath et al., 2012) – complain of hearing problems, such as tinnitus, hyperacusis, and hearing loss, independent of their age (Meuer & Hiller, 2015; Novanta et al., 2020). Although teachers are exposed to noise in many school situations (Kristiansen et al., 2011), not all teachers suffer from hearing problems (cf. Novanta et al., 2020). Therefore, the question arises whether there are also personal factors that promote hearing problems. This has not been sufficiently investigated so far, which is why the first part of the third study aimed at clarifying whether coping styles are associated with hearing problems.

Communication Problems. Since hearing damages or impairments cause speech to be less well understood, they represent a major social handicap (Ciorba et al., 2012). Even minor impairments can have an impact on language comprehension, which in turn is often the cause of irritations, misunderstandings and relationship problems (Berglund & Lindvall, 1995). But even without hearing impairment, difficulties in understanding occasionally occur (Lin et al., 2020; Schick et al., 1999).

Thinking about the modern school day, it is obvious how such impairments can arise in the classroom: For instance, due to the newly established open teaching, a volume is quickly reached in the classroom that causes problems in communication and comprehension (Sala &

Rantala, 2016). In only a few classrooms studied were teachers and students able to understand each other acoustically well (cf. Sala & Rantala, 2016). Accordingly, 12% of American teachers expressed difficulty understanding their students (Lin et al., 2020).

To avoid speech intelligibility problems for the students (Schick et al., 1999), teachers automatically raise their voices in order to be understood (Sala et al., 2002), which increases vocal strain (Berglund & Lindvall, 1995). This phenomenon is called *Lombard effect* (Brumm & Zollinger, 2011). Accordingly, loud background noise is considered a risk factor for voice problems (Devadas et al., 2017). Almost 13% of American teachers reported that they had to raise their voices to be heard due to noise in the classroom, and 8.4% that they had problems with their voice (Lin et al., 2020). Compared to the general population, teachers suffer more often from voice problems (Angelillo et al., 2009; Roy et al., 2004), which in some cases also leads to more days of absence (Medeiros et al., 2012).

In summary, teachers have to raise their voices quite often in order to be understood (Sala et al., 2002). Nevertheless, there seem to be teachers who suffer less from voice problems (cf. Lin et al., 2020). Consequently, the question arises whether there are also personal variables that have an influence on teachers' voice. To provide an answer to this question, the third study examined how teachers' coping styles and noise sensitivity are related to voice problems.

Cardiovascular and physiological effects. Although the exact mode of action is still unknown, studies suggest that noise – mediated by the autonomic nervous system and endocrine system – can affect cardiovascular health (Themann & Masterson, 2019). For example, a connection to blood pressure and cholesterol levels could be shown (Kerns et al., 2018). The most likely explanation for these findings is stress (Berglund et al., 1999): In the short term, noise as an environmental stressor activates the autonomic nervous and hormonal system. This causes an increase in blood pressure, heart rate, and vasoconstriction, which in

turn can lead to the development of hypertension or ischemic heart disease, especially in susceptible individuals (Berglund & Lindvall, 1995).

Accordingly, a positive correlation between the intensity of school noise and heart rate was shown for individual teachers (Schönwälder et al., 2004). In addition, a reduction in classroom volume resulted in teachers' lower heart rates (Tiesler & Oberdörster, 2008).

Mental Health. The effects that noise has on mental health are explained via the stress-vulnerability hypothesis. This means that predisposed people develop mental illness more easily under stress than people who are not predisposed (Basner et al., 2014; Stansfeld & Clark, 2019).

On the biological level, noise leads to stimulation of the endocrine and sympathetic nervous systems (Babisch, 2002), which causes a release of stress hormones (Basner et al., 2014). Sustained activation of these systems (Babisch, 2002) is associated with an increased risk of mental illness (Stansfeld & Clark, 2019).

On the psychological level, when confronted with noise, one often experiences a feeling of annoyance, which has been found to be relevant (Guski, 1999). Accordingly, Hammersen et al. (2016) found positive correlations between the extent of perceived noise annoyance and the impairment of mental health. Consistent with this, noise has been shown to decrease frustration tolerance (Glass & Singer, 1973) and to promote psychological symptoms (e.g., feelings of anxiety), poor appetite, crying easily (Sygna et al., 2014), or depressed mood, which again stimulates the release of stress hormones (Clark & Paunovic, 2018).

Derived from this, depression (Seidler et al., 2017) or anxiety disorders (Hardoy et al., 2005) may develop in the long term. There also seems to be a correlation between the burnout syndrome and noise pollution at the workplace (Madvari et al., 2019). Burnout is defined as a syndrome that occurs primarily in individuals who interact frequently with others for work-related reasons. It is composed of the three symptoms: depersonalization, decline in performance, and emotional exhaustion (Maslach et al., 2001). Whereas depersonalization

describes indifference to other people, decline in performance manifests as perceived inadequacy at work, and emotional exhaustion manifests as low energy and fatigue at work (Maslach, 2003).

As can be assumed from the definition (cf. Maslach et al., 2001), teachers suffer more often from burnout already for professional reasons (García-Carmona et al., 2019). Accordingly, there exist assumptions about links between school noise and teachers' burnout (Schönwälder et al., 2004). In one study, for example, the interaction of noise and voice stress was a significant predictor of teachers' burnout (Nübling et al., 2012).

To summarize, teachers vary in their noise sensitivity (Enmarker & Boman, 2004) and are frequently exposed to noise (Kristiansen et al., 2011), causing them to suffer from both psychological and physical problems (Devadas et al., 2017; Meuer & Hiller, 2015; Nübling et al., 2012). To date, there is a lack of research combining such relations in a well-founded model. Accordingly, the second part of the third study was to examine, by means of a theoretical model, how teachers' sensitivity to noise and their mental and physical health are related.

Behavior. Although behavioral effects tend to be subtle, there is evidence that noise also affects human behavior (Jariwala et al., 2017). Cohen and Lezak (1977), for example, could show that noise is negatively related to helpfulness, which may be explained by the fact that cues, such as people's emotional states, are not sufficiently observed under noise. In addition, there are experiments that showed that uncontrollable noise leads to more aggressive behavior in already angry subjects. However, if the test subjects were able to influence the noise exposure, they behaved similarly to the subjects who were not exposed to noise (Donnerstein & Wilson, 1976). In the case of teachers, it has so far only been possible to show that they behave differently in class and, for example, take more breaks to speak (Crook & Langdon, 1974) or try to avoid noise (Bulunuz et al., 2021).

Performance. The effects of noise on performance are particularly noteworthy, as quite different findings exist. Noise-induced effects in performance depend on the difficulty of the task to be processed, the type of noise, the sound pressure level, and the duration of noise exposure (Jahncke et al., 2011; Monteiro et al., 2018; Nassiri et al., 2013). According to a meta-analysis (Szalma & Hancock, 2011), noise impairs performance in more complex tasks, such as cognitive and communication tasks, and primarily affects accuracy and less the speed of processing. Irregular noise and speech noise have slightly more negative effects than continuous noise and noise without speech components. Loudness levels above 75 db(A) have a greater impact than lower noise levels because resources are diverted from the actual task to compensate. Regarding duration, the meta-analysis indicated more severe effects of a shorter duration. However, the median across all studies was 1.1 minutes, indicating a rather short exposure in all analyzed studies. In summary, the findings largely indicate that it is primarily the amount of resources to be used that determines how noise affects performance (Szalma & Hancock, 2011).

Thus, noise may also positively influence performance on certain tasks (e.g., Broadbent, 1979; Smith, 1985). For instance, this is the case with performance in short vigilance tasks (Helton et al., 2009), simple tasks (Harrison & Kelly, 1989), and in tasks with only a brief exposure to noise (Hartley & Adams, 1974).

For prolonged noise exposure (cf. Broadbent, 1954) and for more complex tasks, noise appears to impair performance (Wickens, 2002) because more capacity is required for processing (Berglund et al., 1999). In addition, noise has impairing effects when constant vigilance is required, errors should be avoided, or time pressure is perceived (Ising et al., 1996). It also appears that it is primarily the experienced uncontrollability of noise that is associated with impairments (Glass et al., 1971). Speech noise is more disruptive and, accordingly, is associated with greater impairments in reading comprehension as well as in

proofreading performance (Martin et al., 1988; Oswald et al., 2000). In addition, it leads to attention deficits and impairments in episodic and semantic memory (Hygge et al., 2003).

This effect has also been shown in teachers (Enmarker, 2004): Meaningful noise had a negative effect on episodic memory and impaired the recognition of a text. In addition, a quasi-experiment exists that indicates impaired cognitive performance due to school noise (Arezes et al., 2010). According to self-reports, teachers experience both their teaching (Lin et al., 2020) and their work efficiency affected by school noise (Yassin et al., 2016).

Although there are no explicit research findings on teachers' work performance under noise yet, it is reasonable to assume that all of the above characteristics play a role in the school context, where noise is seemingly ubiquitous: For instance, while teachers' cognitive functions are heavily taxed in the classroom, teachers must also be constantly alert to prevent accidents during recess supervision in the schoolyard. In both situations, students' sounds also include verbal components, which might increase the distress. At the same time, teachers should avoid mistakes – for example, in correcting exams – and often hurry because they have to change classrooms between lessons. To validate these assumptions, the effects of short- and long-term noise exposure on prospective teachers' performance on different tasks were investigated in the first two experiments.

After-effects. In addition, various experiments showed that noise exposure in a first task did not lead to performance degradation until the subsequent second task (Glass & Singer, 1973). In his review, Cohen (1980) pointed out that immediate effects of noise are often missing and impairments can only be recorded retrospectively. He justified this by the fact that many resources are consumed during task processing under noise, so that it is more difficult to adequately cope with the following task. Thus, noise subsequently led to reduced frustration tolerance (e.g., in a puzzle), to poorer performance in proofreading, to an increase in aggressive behavior, or to a reduced willingness to help (Cohen, 1980).

These findings are crucial because teachers have to fulfill different requirements one after the other in their daily routine and often there is no time for a break in between to recover from the strain of the noise (Schönwälder et al., 2004). Suppose a teacher has planned a lesson with group work, which automatically results in higher noise levels (Sala & Rantala, 2016). And although the teacher may still be attentive and concentrated during the lesson, the question arises whether this is still the case after the noisy lesson. After this lesson, is it still possible for the teacher to correct an exam without errors or to participate in the teacher conference in a concentrated manner? Since there are no research findings on this so far, the results of two experimental studies (study 1 and 2) on prospective teachers should provide a first answer to this question.

1.4.4. Interim Summary

Noise can affect mental and physical health as well as performance in a variety of ways. The resulting effects on performance seem to depend on different factors, such as the task, the volume, the duration and the type of noise. The consequences on mental and physical health depend, in part, on individual factors such as noise sensitivity and possibly on coping styles. In order to be able to examine these effects in the school context, four theoretical models have already been presented, on which the following studies are based.

1.5. Studies and Aims

As is evident from the above, noise can lead to many different effects. While mainly negative consequences appear for the psyche, both negative and positive consequences might appear for performance. There seem to be both immediate and delayed effects for performance variables. Such consequences are especially crucial for occupational groups that are frequently exposed to noise, such as teachers (Kristiansen et al., 2011). Due to their daily exposure, they report significant psychological and physical impairments (Enmarker & Boman, 2004; Smith et al., 1998). Since teachers shoulder a major responsibility for the next

generation and their health is correlated with several student variables (Kokkinos et al., 2005; McLean & McDonald Connor, 2015; Yoon, 2002), it is even more important to study the impact of noise exposure on teachers. Only then long-term prevention and intervention programs can be developed and established to help mitigate teachers' risk of mental and physical illness and thus a potential negative influence on students. Although a variety of studies on teachers already exist, they mainly dealt with correlative relationships between noise and psychological and physical well-being. To date, there has been little research on the effects of noise on teaching activities or on teachers' performance variables. In addition, symptoms resulting from school noise have not yet been linked to teachers' stable coping styles. There is also a lack of research on possible pathways between noise sensitivity and relevant symptoms. These gaps should be at least partially filled by the present work.

The overall aim of the three studies was therefore to investigate the objective and subjective effects of school noise on prospective teachers' work performance and stress experience, as well as on practicing teachers' mental and physical health. The focus of the first two studies was on performance and stress. Because student teachers' results are comparable to those of practicing teachers in certain areas (e.g., Bekle, 2004) and because there was little opportunity to recruit practicing teachers for the experiments, the sample of the first two studies consisted of student teachers. In these two experiments, the effects of different durations of noise exposure and different concentration tests on student teachers' stress experience, as well as on their concentration ability and error-correction performance, were investigated. The maximal adaptability theory (Hancock & Warm, 1989, 2003) and the transactional stress model (Lazarus & Folkman, 1984) formed the theoretical basis for these two studies.

While the first part of the third study focused on coping styles when dealing with school noise and the resulting symptoms, the second part of the third study was designed to complement the previous findings with specific associations between teachers' noise

sensitivity and various symptoms. Therefore, we queried teachers in an online survey about noise and its effects. In the first part, the aim was to elicit differences in the physical and psychological effects of noise among four coping patterns. This was examined based on the transactional stress model (Lazarus & Folkman, 1984) and the stress-strain model (Rudow, 2000). In the second part, a focus was placed on examining associations between individual noise sensitivity and short- and long-term psychological and physical symptoms. This was done on the basis of the simplified model of teacher stress (van Dick & Wagner, 2001).

**2. Study 1 and 2: Effects of Student Noise on Student Teachers' Stress Experiences,
Concentration and Error-Correction Performance**

The first two studies have been published together in the journal *Educational Psychology*:

The abstract of the study is presented in this chapter.

Abstract of Study 1 and 2

Student noise can affect teachers' stress experience and work performance. Two experimental studies were conducted to examine these effects in more detail. Based on Lazarus' transactional stress model and the maximal adaptability theory, we assumed an increase in stress experience due to noise and stimulating effects of noise up to a point of maximal adaption before performance drops. The first experiment comprised 74 and the second experiment included 104 student teachers from a German university that were randomly assigned to one of three noise conditions. Participants were asked to complete a concentration test and correct a dictation. Results from analyses of variance were in support of our hypotheses. In both experiments, noise exposure increased stress experience. The first experiment showed positive effects and the second experiment negative effects of noise on participants' error correction. The results are discussed with respect to school noise affecting teachers' mental health and work performance.

Now that I have examined how noise affects student teachers' concrete work performance, I aimed to focus on practicing teachers and their individual characteristics. The following study therefore examined how teachers' different coping styles affect their experience of stress.

3. Study 3a: Relating Teachers' Coping Styles to Student Noise and Perceived Stress

The first part of the third study has also been published in the journal *Educational Psychology*:

The abstract of the study is presented in this chapter.

Abstract of Study 3a

School noise is a serious, inevitable problem that teachers experience as stress or strain. Coping styles have a huge impact on teachers' mental health and therefore might influence this daily stress experience. Based on the stress-strain model and the transactional stress model, we examined in an online study how 99 teachers with different coping styles reacted to school noise. Four professional coping styles were derived from the overarching dimensions of professional commitment and experience resilience. The healthy type, the unambitious type, type A, and type burnout differed in terms of threat appraisal, noise stress, voice and hearing problems as well as noise-related burnout. Compared to the healthy type, types A and burnout showed higher levels of stress. Teachers of the risk types turned out to be more vulnerable to school noise than teachers of the healthy type. Specific prevention programs may help to improve teacher resilience.

Now that I have examined teachers' individual coping styles, in the subsequent study I wanted to examine whether there are concrete pathways between teachers' individual noise sensitivity and negative psychological and physical consequences resulting from school noise.

4. Study 3b: Testing a Model of Noise-Related Stress in School Teachers

As already mentioned above, school noise to which teachers are exposed on a daily basis (Kristiansen et al., 2011) represents an objective and subjective risk factor (Berglund et al., 1999; Enmarker & Boman, 2004), from which both physical as well as psychological complaints can arise (Kristiansen et al., 2014; Medeiros et al., 2012). Although these negative effects partly depend on personal factors, such as noise sensitivity (Eysel-Gosepath et al., 2012), little is known about the concrete relationships between the variables involved in noise stress. One exception is a study by Fredriksson et al. (2017) who based their findings on a large sample of female preschool teachers and randomly selected women. Feelings of noise annoyance emerged as a significant mediator of the relationship between occupational noise exposure and auditory fatigue, while stress experience moderated this mediation process.

Apart from this, there is a lack of theoretically based studies on the relationships between teachers' individual characteristics and their physical and mental health. Based on the simplified *model of teacher stress* (van Dick & Wagner, 2001), we therefore intended to examine the way in which noise sensitivity, experienced stress, vocal fatigue, and burnout are related to each other.

A Model of Teacher Stress

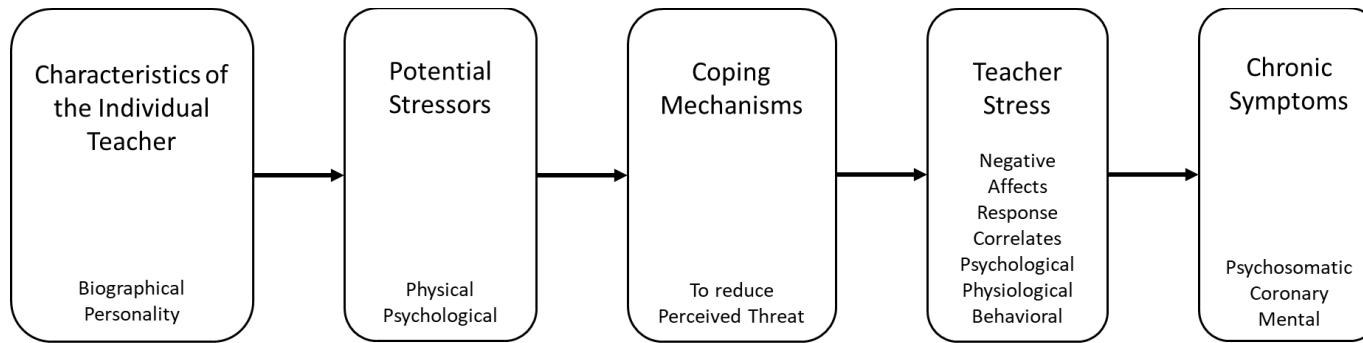
Some theories from general stress research have been transferred to the teaching profession and can explain teachers' stress experience (see e.g., Lazarus & Folkman, 1984). For our study, however, we selected a frequently cited model (e.g., Chan, 2006, 2011; Troesch & Bauer, 2017) that originates directly from teacher stress research. The model of teacher stress (Kyriacou & Sutcliffe, 1978) relies on the assumption that teachers' appraisals of potential occupational stressors become acute stressors and thus form the starting point of their stress response. Occupational stressors can be further divided into psychological (e.g., relationship with colleagues) and physical stressors (e.g., large class size, loudness). Both can trigger short-term psychological (e.g., negative affect), physiological (e.g., muscular tension), or behavioral stress reactions (e.g., days absent from work) as well as longer-lasting

psychosomatic or even chronic complaints. In addition to coping mechanisms, teachers' individual characteristics such as perceived support or self-efficacy may also have an influence on the experience of stress.

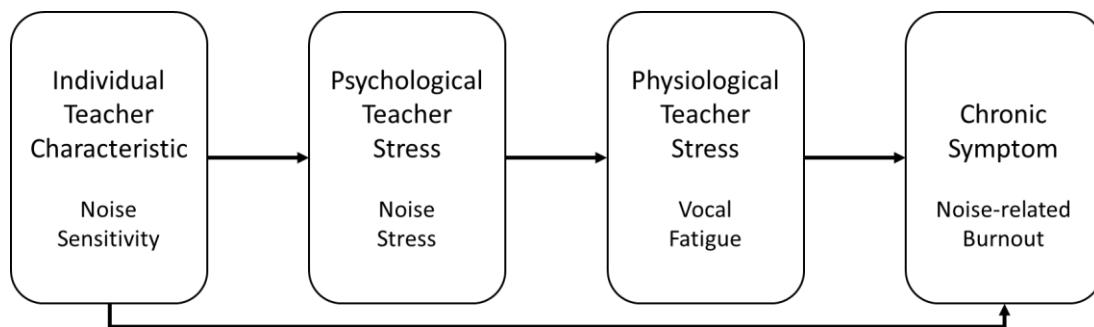
Since this model of teacher stress (Kyriacou & Sutcliffe, 1978) is not easily testable due to its complexity, the simplified model by van Dick and Wagner (2001; see Figure 4.1) served as our theoretical basis. This model shows a linear sequence of a just few factors: Individual teachers' characteristics take influence on occupational stressors, to which teachers respond by means of individual coping mechanisms to reduce their threat. In the long term, teacher stress may result in chronic psychosomatic or mental symptoms. Since the focus of the current study was purely on the relationships between sensitivity to school noise and short-term as well as long-term stress responses, we formed a model of teacher stress reduced to noise stress, that focused on the relationships important to us and left aside the component of coping strategies (see Figure 4.2). In agreement with van Dick and Wagner (2001), we assume that individual teacher characteristics contribute to psychological and physiological stress in response to school noise. Individual teacher characteristics may have an influence on the formation of chronic symptoms, either directly or mediated through the stress response, which may amount to permanent impairments of teacher health. In the following, the components of the model are described in more detail.

Noise Sensitivity

Noise sensitivity can be defined as an individual physiological and psychological constitution that generally increases the degree of reaction to noise (cf. Shepherd et al., 2015) and plays an important role in the individual stress process (Ellermeier et al., 2020). As an example, regardless of actual noise exposure, noise-sensitive individuals suffered more from psychological symptoms than individuals who rated themselves less sensitive (Baliatsas et al., 2016). In the school context, teachers' individual noise sensitivity is key to the frequency of stress symptoms and the expression of psychological complaints, such as noise annoyance or exhaustion (Enmarker & Boman, 2004; Nazneen et al., 2020).

Furthermore, according to Stansfeld and Clark (2019), links between noise sensitivity and mental illness can also be assumed. In a longitudinal study, noise sensitivity was found to be a significant predictor of mental illness (Stansfeld & Shipley, 2015). While this relationship is not directly applicable to the teaching profession, it underscores the importance of being sensitive to noise.

Noise Stress and Noise Symptoms

In the short term, noise triggers a feeling of annoyance with components of anxiety, helplessness, anger, and stress (Stansfeld & Clark, 2019), as has already become apparent in laboratory studies (Ljungberg & Neely, 2007), but also among teachers in everyday school life (Augustyńska et al., 2010). In the long term, perceived noise annoyance can result in psychological distress or even mental illness (Stansfeld & Clark, 2019).

In the medium term, physical complaints might be noticed (Stansfeld & Clark, 2019). For example, teachers complain of hearing (Sjödin et al., 2012) and voice problems (Munier & Kinsella, 2008), such as voice fatigue, sore or dry throat (Devadas et al., 2017). Psycho-emotional factors or psychological stress are considered risk factors for voice problems in this context (Devadas et al., 2017; Kooijman et al., 2006). Among Finnish teachers, stress had a stronger influence on the development of voice problems compared to physical illnesses (e.g.,

asthma) (Vertanen-Greis et al., 2020). In addition to the finding that voice problems in female teachers led to more days of absence (Medeiros et al., 2012), recent studies even suggested a link between teachers' voice problems and mental illnesses, such as burnout (Brito Mota et al., 2019; Marques da Rocha et al., 2015). According to our research, there is a lack of studies on how stress from school noise affects teachers' physical and mental health.

However, summarizing previous research, it is clear that day-to-day exposure to school noise is a stressor for teachers (Kristiansen et al., 2011), which can lead to psychological distress (Enmarker & Boman, 2004), physiological complaints (Devadas et al., 2017), and chronic health problems (Brito Mota et al., 2019). Individual sensitivity to noise forms an important basis that can have an impact on mental health in the short term (e.g., Nazneen et al., 2020) as well as in the long term (e.g., Brito Mota et al., 2019).

In view of potential connections between the serious effects that school noise can bring, the importance of studies on concrete relations increases. Since there has been little research on such relationships, the present study aims to fill this research gap based on the modified model by van Dick and Wagner (2001). We hypothesized relationships between teachers' noise sensitivity, experienced stress, vocal fatigue, and experienced burnout symptoms and formulated the following hypotheses:

H1: According to the model (van Dick & Wagner, 2001) and the relationships presented, we hypothesize that positive relationships can be found between noise sensitivity, experienced stress, vocal fatigue, and noise-related burnout.

H2: Since school noise can lead to psychological distress (Augustyńska et al., 2010) under the influence of noise sensitivity (Enmarker & Boman, 2004) and since this distress is associated with voice problems (Devadas et al., 2017; van Dick & Wagner, 2001), we hypothesize that experienced stress mediates the relationship between noise sensitivity and voice fatigue.

H3: While stress is a risk factor for voice problems (Vertanen-Greis et al., 2020), voice problems are positively associated with mental illness (Brito Mota et al., 2019). Accordingly, we hypothesize that voice fatigue mediates the relationship between stress and noise-related burnout.

H4: Concluding from Hypotheses 2 and 3, we speculate that stress and vocal fatigue sequentially mediate the relationship between noise sensitivity and noise-related burnout.

Method

Sample

One hundred and fifty-nine (80.5% female) German teachers participated in the online survey. The age of the 110 elementary and 49 middle school teachers ranged from 24 to 64 years ($M = 44.87$, $SD = 10.13$). Their average work experience ranged from one to 46 years ($M = 18.67$, $SD = 10.16$).

In the German school system, elementary school is compulsory for all students from the age of six and lasts four years. After elementary school, students can choose between middle school, junior high school and high school (secondary school), depending on their grades. In middle school, students are between 10 and 16 years old. Studies of potential noise differences at elementary and middle schools – likely due to differences in age and education – have yielded conflicting results (see Bhardwaj et al., 2013; Chan et al., 2015). To filter out whether elementary and middle school teachers differ with respect to school noise, we conducted an analysis of measurement invariance without formulating a specific hypothesis for it.

Materials

Noise Sensitivity

Noise sensitivity was measured according to the German version of Weinstein's noise sensitivity scale (Zimmer & Ellermeier, 1997). We selected three items and adapted them in the way that they related to student noise (e.g., 'I find it a burden when there is a lot of hustle

and bustle around me during break supervision'). The items were answered on a 5-point Likert scale from (1) *totally disagree* to (5) *totally agree* (see Appendix C; $\alpha = .85$).

Noise Stress

We measured noise stress according to Grebennikov and Wiggins (2006). For our study, however, we chose to focus on only one source of noise, that is, noise emanating from students (e.g., 'In terms of noise, I feel very stressed by restless students.'). Therefore, we used three items, answered on a 5-point Likert scale from (1) *totally disagree* to (5) *totally agree* (see Appendix C; $\alpha = .82$).

Vocal Fatigue

Vocal fatigue was assessed with six content adapted items (e.g., 'When I must speak against school noise, my voice feels quite stressed', $\alpha = .87$; see Appendix C) from the vocal fatigue index (Stappenbeck et al., 2017). They were answered on a 5-point Likert scale from (1) *totally disagree* to (5) *totally agree*.

Noise-related Burnout

Noise-related burnout was surveyed using nine content adapted items (e.g., 'Due to the high noise volume in my work, I'm emotionally ruined', $\alpha = .93$; see Appendix C) from the teacher burnout questionnaire (Schwarzer & Jerusalem, 1999). As in previous studies (see Keller-Schneider, 2018), only items of the emotional exhaustion scale were applied that have been answered on a 5-point Likert scale from (1) *totally disagree* to (5) *totally agree*.

Procedure

After approval by the responsible Ministry of Education, we made contact to the directors of Lower Bavarian elementary and middle schools. After their agreement, they were asked to send a web link to their teachers. The link to the 20-minute survey, which could be canceled at any time, was available to interested teachers for a period of two months. At the end of the survey, teachers were thanked and educated about the purpose of the study.

Statistical Analysis

For the basic descriptive analyses, we used IBM SPSS version 25.0, and for the more complex data analysis, we used the AMOS 25.0 program (Arbuckle, 2014). To make statements about the relationships among variables, we computed a structural equation model (SEM), which makes it possible to corroborate relationships among variables (Bollen, 1989; Bollen & Long, 1993). We analyzed the data according to the 2-step procedure for structural equation models (Anderson & Gerbing, 1988): After developing our theoretical model, we checked in a first step the goodness of fit for our model using confirmatory factor analysis (CFA). From the results of the CFA, we calculated in a second step the structural equation model, which consisted of four latent variables and a total of 21 manifest variables (see Appendix C), by the use of Maximum likelihood estimation. Using bootstrap analyses with 500 iterations, we estimated 95% confidence intervals with bias correction for the direct and indirect effects. To test the model's goodness of fit, we used the goodness-of-fit criteria by Hu and Bentler (1999) and Marsh (2007), respectively. A non-significant chi-square test indicates a good fit of the model. However, as the index quickly becomes significant in larger samples, it has limited power (Gerbing et al., 1992). Due to this limited informative value of the chi-square test, we relied on additional parameters, as is customary: The Comparative Fit Index (CFI; Bentler, 1990) and the Tucker-Lewis Index (TLI; Tucker & Lewis, 1973) indicate acceptable fit at values $> .90$ and good fit at $> .95$. According to the interpretation of the Root Mean Square Error of Approximation (RMSEA; Steiger, 1990), model goodness of fit is considered acceptable at a value $< .08$ and excellent at $< .05$. The quotient of the chi-square value and its degrees of freedom indicates a good fit at values < 2 (Kline, 2016).

In order to be able to exclude differences between elementary and middle school teachers, we additionally checked the measurement invariance according to the recommendation of Byrne (2010) within the framework of the confirmatory factor analysis. In the first step, we conducted a theoretically based confirmatory factor analysis for the two types of schools (configural invariance). To test metric invariance, the second step was to

equate factor loadings between groups. In the third step, scalar invariance was tested by equating the factor loadings and intercepts in the two groups and using the middle school teachers as the reference group. Scalar invariance is seen as a necessary condition for comparing the means of different groups (Vandenberg & Lance, 2000). In the fourth step, residual invariance was calculated by equating factor loadings, intercepts, and residuals and using middle school teachers as the reference group. For interpretation, we relied on the chi-square difference test. A non-significant p -value suggests a non-significant change in model quality and, accordingly, the presence of measurement invariance. We used Socscistatistics (<https://www.socscistatistics.com>) to calculate the significance value. However, the chi-square difference test is considered to be very sensitive (Weiber & Mühlhaus, 2014), so we additionally based our decision on the change in CFI (ΔCFI) and RMSEA (ΔRMSEA). According to Cheung and Rensvold (2002), a change in CFI ≤ 0.010 and according to Chen (2007), a change in RMSEA of < 0.015 indicates the presence of measurement invariance.

Results

Descriptive Statistics

Table 4.1 shows the descriptive parameters and correlation coefficients of the relevant scales. The large differences between means can be explained by the number of items in the scales. Since skewness and kurtosis for all scales were close to 0, normal distribution of the data can be assumed. As indicated, significant moderate-to-high relationships among the variables are in line with the first hypothesis (H1).

Confirmatory Factor Analysis

Before calculating the structural equation model, we ran a confirmatory factor analysis to test the convergent and divergent validity of the four latent variables. The initial outcome, $\chi^2(183) = 323.128, p < .001, \chi^2/df = 1.766$, CFI = .931, TLI = .921, and RMSEA = .070, already indicated acceptable model fit. Although the chi-square test proved significant, the other statistical characteristics indicated a good model fit. However, the modification indices revealed potential for improving the model fit by considering the covariances between the error terms of the variables BO1 and BO2, BO4 and BO8, and VF2 and VF3. Accordingly, we added these bivariate relationships to our model and obtained a good model fit, $\chi^2(180) = 263.980, p < .001, \chi^2/df = 1.47$, CFI = .959, TLI = .952, and RMSEA = .054. Since our presumed model proved to be acceptable, we next checked if there were any differences between elementary and middle school teachers.

Testing for Measurement Invariance

To check the similarity of the model for elementary school teachers and middle school teachers, we ran the described procedure to test for measurement invariance. The overall and comparative fit indices of the models explored can be seen in Table 4.2. According to the results, there was no significant deterioration in model goodness of fit between configural invariance, metric invariance and scalar invariance. However, when comparing the scalar invariance model with the residual invariance model, we obtained a significant result of the chi-square difference test. Although this test indicated a significant result in residual invariance, the changes in RMSEA and CFI were not large enough to be considered significant. Thus, measurement invariance for elementary and middle school teachers regarding the model of teacher stress can be assumed.

Structural Equation Modeling Analysis

Finally, to test whether noise stress is a significant mediator of the relationship between noise sensitivity and vocal fatigue and whether vocal fatigue is a significant mediator of the relationship between noise stress and noise-related burnout, we ran the hypothesized model, which was tested by SEM. It mapped our data well, $\chi^2(182) = 278.709, p < .001, \chi^2/df = 1.53$, CFI = .953, TLI = .945, and RMSEA = .058. Only the chi-square test was significant here as well, but the other more reliable statistical parameters indicated a good model fit. The total effect of each variable can be seen in Table 4.3.

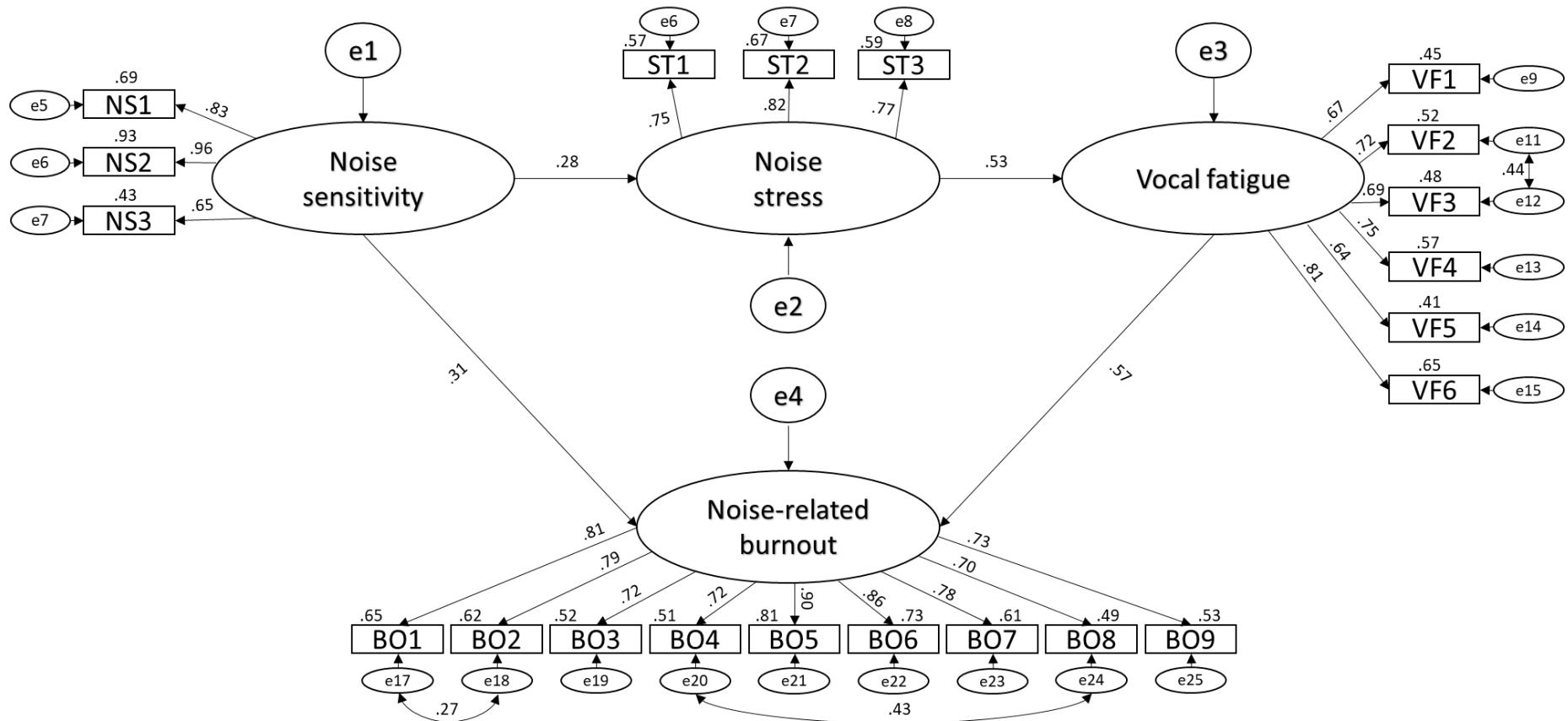
Figure 4.3*Structural Equation Model*

Figure 4.3 shows the standardized path coefficients. The results of the indirect paths are shown in Table 4.4. In accordance with our hypotheses, experienced stress turned out to be a significant mediator of the relationship between noise sensitivity and voice fatigue (H2). Voice fatigue mediated the positive relationship between stress and noise-related burnout (H3). Stress and voice fatigue serially mediated the positive relationship between noise sensitivity and noise-related burnout (H4). Table 4.5 shows the results of all direct paths, from which can be seen that there is still a positive direct relationship between noise sensitivity and noise-related burnout. According to the results, stress and vocal fatigue emerged individually and serially as significant mediators between individual noise sensitivity and noise-related burnout. Additional analyses revealed that stress contributed 7.80% ($p = .006$), voice fatigue 28.60% ($p = .005$), and noise-related burnout 48.00% ($p = .012$) to the explained variance of the hypothesized teacher stress model.

Discussion

The aim of this online study was to use van Dick and Wagner's model (2001) to identify concrete pathways between teachers' individual sensitivity to noise and the negative physical and psychological consequences resulting from school noise. All four hypotheses were supported by the data. Our results contribute an important part to current research by approving a theoretical model of the relationship between noise sensitivity and noise-related burnout. We demonstrated that (1) noise sensitivity, stress, vocal fatigue, and experienced burnout were positively correlated, (2) stress mediated the relationship between noise sensitivity and vocal fatigue, (3) vocal fatigue mediated the association between stress and noise-related burnout, (4) stress and vocal fatigue serially mediated the relationship between noise sensitivity and noise-related burnout, and (5) that the direct and positive relationship between noise sensitivity and noise-related burnout persisted. Taken together, these results provide empirical evidence for the relationship between elementary and middle school teachers' individual noise sensitivity and their experienced burnout.

As expected due to the theoretical model of teacher stress (van Dick & Wagner, 2001) and in accordance with our hypothesis, noise sensitivity, stress, voice fatigue, and noise-related burnout correlated positively with each other (H1). This finding is consistent with previous findings (cf. Brito Mota et al., 2019; Devadas et al., 2017; Enmarker & Boman, 2004; Nazneen et al., 2020; Stansfeld & Clark, 2019) and formed the basic premise for our further analyses.

Experienced stress acted as a significant mediator of the positive relationship between noise sensitivity and vocal fatigue (H2). Presumably, noise-sensitive teachers in contrast to less noise-sensitive teachers feel more stressed by student noise, which may contribute to more pronounced vocal fatigue. Previous research also found that individual noise sensitivity has an influence on noise annoyance or stress symptoms (Enmarker & Boman, 2004; Nazneen et al., 2020). Apparently, noise-sensitive individuals experience sounds as interfering and

unpleasant more quickly (cf. Stansfeld & Clark, 2019) than less sensitive individuals, which presumably also makes them feel stressed more quickly. In addition, earlier findings identified emotional and psychological factors as risk factors for the development of voice problems (Devadas et al., 2017; Kooijman et al., 2006; Vertanen-Greis et al., 2020). Teachers' voices are already under above-average stress due to their job (Bovo et al., 2007), which is why additional mental stress – triggered by school noise – further increases stress levels and subsequently has a negative impact on their voice.

As suspected and in line with earlier findings that stress causes voice problems (Devadas et al., 2017) and voice problems are related to mental illness (Brito Mota et al., 2019), voice fatigue was found to be a significant mediator of the positive relationship between stress and noise-related burnout (H3). Therefore, teachers who feel stressed by student noise seem to suffer more from voice problems, which in turn can contribute to their emotional exhaustion. Based on the diathesis-stress model (cf. Stansfeld & Clark, 2019), it is clear that impaired voice operates as a vulnerability factor and therefore can lead to other more serious complaints, such as burnout.

Merging the second and third hypotheses and in agreement with the original theoretical model (van Dick & Wagner, 2001), the assumed serial mediation also showed significantly: Stress and voice fatigue mediated successively the positive relationship between noise sensitivity and noise-related burnout (H4). This means that noise-sensitive teachers experience more stress due to school noise, thus have more voice problems, which in turn are associated with greater emotional exhaustion.

In addition to this indirect pathway, the positive direct relationship between teachers' noise sensitivity and their noise-related burnout remained. Accordingly, noise-sensitive teachers appear to be more prone to noise-related burnout in general, independent of noise stress and vocal fatigue. This direct relationship is meaningful because it is missing from the illustrations of previous models (cf. Kyriacou & Sutcliffe, 1978; van Dick & Wagner, 2001).

According to the diathesis-stress model, traits such as noise sensitivity can form a diathesis that can make people more susceptible to various ailments. The effects that noise can have on noise-sensitive individuals have been documented many times (e.g., Baliatsas et al., 2016; Nazneen et al., 2020), including reference to the possibility of developing mental illness (see Stansfeld & Clark, 2019). However, more detailed research is needed here to determine the direction of this association and other potential mediators or moderators.

From previous conflicting results (Bhardwaj et al., 2013; Chan et al., 2015), it was difficult to infer whether elementary and middle schools would differ with respect to noise. In our data, we found no differences between elementary and middle school teachers, suggesting similar impact pathways of elementary and middle school noise. The existing measurement invariance thus indicates a potential generalizability of our model, which should also be tested in future studies on junior high and high school teachers.

The simplified model of van Dick and Wagner (2001) was suitable for the construction of our structural equation model, which again underpins its importance in teacher stress research. Building on our model, future studies should use the full theoretical model as a foundation and include the variable of coping mechanisms as a mediator or moderator.

The elicited relations are of substantial importance for everyday school life, as they suggest for the first time that student noise appears to affect teachers' physical and mental health through different pathways. On this basis, future studies should analyze the exact effect mechanisms of the single pathways in order to gain even more detailed insights into the stress process triggered by school noise.

Although the results of our study help to explain the development of negative consequences due to school noise, there are still some limitations. First, the study was based on a cross-sectional design. Although theoretical derivation and computation of structural equation models make unidirectional associations likely (Bollen, 1989; Bollen & Long, 1993), causal statements about the associations are nevertheless limited. With the help of a

longitudinal study, it could be clarified whether the stress experience actually preceded the voice problems and the voice problems preceded the noise-related burnout. Second, our survey took place during a phase of the Corona epidemic when schools were just reopening. Prior to that time, the majority of teachers were working in their home offices and, consequently, had little exposure to student noise. This fact may have biased our results. Even if teachers were able to remember the times of school noise stress, they lacked current impressions that could ease to answer the items of the scales. Third, our study design only allowed to collect self-report data. Therefore, it could not be tested whether the reported voice problems corresponded to objective criteria such as hoarseness. Studies suggest a low correlation between perceived and actual voice problems (Cutiva & Burdorf, 2015). Accordingly, additional objective data should be collected in further studies in order to create a more holistic picture and highlight any limitations to the validity of our model. Fourth, as noted above, the validity of our model has only been demonstrated on elementary and middle school teachers, so future studies will need to test the model on junior high and high school teachers.

Conclusion

In summary, our results suggest that individual factors, such as noise sensitivity, play an important role in teachers' experience of psychological and physical stress and even in their mental health. In order to prevent teachers from health problems and to mitigate complaints, intervention and prevention measures are needed in the fight against school noise.

Basically, measures against the objective noise level can be distinguished from measures against the subjectively experienced noise level. With regard to objective school noise, school buildings form a first starting point. By making structural changes to classrooms and break halls, it would be possible to reduce the objectively measurable noise levels (Shield et al., 2015). Students themselves can also contribute to a quieter school day (Norlander et al., 2005): In an intervention study, relaxation training of students led to reduced classroom

loudness. In addition, there are already prevention programs aimed at increasing the noise awareness of student teachers in order to prevent, for example, physical complaints in their later professional life (e.g., Jiménez-Tejada et al., 2012). Improved classroom management skills could also help to prevent high levels of classroom noise (cf. Dockrell & Shield, 2006), which in turn could have a positive impact on teachers' stress experience and voice fatigue.

Beyond the objective reduction of school noise and with regard to subjectively perceived noise levels, the stress experience, especially for noise-sensitive teachers, should be reduced. For this purpose, mindfulness trainings (Roeser et al., 2013) or stress intervention programs (Ansley et al., 2021) are suitable. For example, in one online stress prevention program (Ansley et al., 2021), teachers were able to increase their use of functional coping strategies, like mindfulness and cognitive restructuring. In addition, this intervention helped increase their self-efficacy. Since it seems that both coping strategies and self-efficacy have a buffering effect on stress (cf. Lazarus & Folkman, 1984; Zee & Koomen, 2016), it would be quite conceivable to use such programs in the fight against noise stress as well. With the help of such programs, teachers can improve the way they deal with their daily professional demands and thereby maintain their mental and physical health.

5. General Discussion

5.1. Summary of Results

5.1.1. Study 1 and 2: Effects of Student Noise on Student Teachers' Stress Experiences, Concentration and Error-Correction Performance

The first two experimental studies were designed to investigate whether and to what extent noise during breaks affects student teachers' stress experience and performance. In the first study, 74 student teachers from the University of Passau were assigned in advance to one of three groups (no noise, brief noise, and continuous noise). They consecutively completed the short concentration test d2 (Brickenkamp, 2002) and corrected a dictation (Birkel, 2009). In between, the stress experience was recorded (Jacobs, 2014). The second study was similar to the first study, with the exception that more student teachers, numbering 104, attended and completed the longer concentration test KLT (Düker & Lienert, 2001). Our data were analyzed using ANOVAs, MANOVAs and t-tests. The findings were consistent with the transactional stress model (cf. Lazarus & Folkman, 1984) and the maximal adaptability theory (cf. Hancock & Warm, 1989, 2003) and are therefore in line with our hypotheses. In both experiments, there were no differences in performance on the concentration test, i.e., concentration performance was not significantly affected by the noise conditions. Nevertheless, in both experiments, subjects in the continuous noise group experienced more stress than the other groups. In dictation correction, the results differed between experiment 1 and 2. While in the first experiment a short concentration test under continuous noise led to improved performance in dictation correction, a long concentration test in the second experiment led to poorer correction performance in the short and continuous noise group. On the one hand, it was experimentally shown for the first time that under noise, the processing of tasks that occur in the teaching profession has a negative influence on the subjective stress experience. On the other hand, noise seems to have a positive and negative influence on the performance, depending on the context. These findings show the importance of research in this area, as noise might affect teachers' performance differently, but always has a negative

impact on the experience of stress. This could imply that it is reasonable for teachers to take a short break after a noisy task to recover and then continue working in a concentrated way.

5.1.2. Study 3a: Relating Teachers' Coping Styles to Student Noise and Perceived Stress

The first part of the third study aimed to examine whether there are differences between teachers with varying coping styles in terms of stress symptoms. For this purpose, 99 Bavarian elementary and middle school teachers participated in a 20-minute online survey. Using a short version of the questionnaire work-related behavior and experience patterns (cf. Menge & Schaeper, 2019) the teachers could be assigned to four different coping patterns by means of a latent profile analysis. Generally, the findings were consistent with the transactional stress model (cf. Lazarus & Folkman, 1984) and the stress-strain model (cf. Rudow, 2000) and therefore in line with our hypotheses. ANOVAs indicated significant differences between the professional coping patterns in terms of stress symptoms. The burnout type experienced more noise stress than the healthy type and felt more threatened by noise than the other three types. The at-risk types reported higher vocal fatigue than the two healthy types and more hearing problems than the healthy type. Type A, type burnout, and the unambitious type experienced more noise-related burnout than the healthy type. Moreover, our results suggest that short- and long-term effects of school noise are interrelated, and that these effects interact with teachers' individual coping styles. In summary, this is the first study to show that occupational coping styles may have an impact on short- and long-term stress symptoms caused by school noise. Therefore, they should not go unnoticed. The findings imply that teachers with risky coping styles are less able to cope with school noise than teachers with healthy coping styles. Therefore, it would be necessary to offer special trainings and interventions to teachers at high risk in order to prevent or avoid health impairments caused by noise.

5.1.3. Study 3b: Testing a Model of Noise-related Stress in School Teachers

The second part of the third study aimed to investigate how teachers' sensitivity to noise is related to psychological and physical stress symptoms due to school noise. Online data from a total of 159 Bavarian elementary and middle school teachers were used for the analyses. The findings were in line with our hypotheses and thus consistent with the simplified model of teacher stress (cf. van Dick & Wagner, 2001). By means of a structural equation model, it was shown that the variables noise sensitivity, noise stress, vocal fatigue, and burnout were positively correlated with each other. Furthermore, noise stress mediated the relationship between noise sensitivity and voice fatigue; voice fatigue mediated the relationship between noise stress and noise-related burnout; noise stress and voice fatigue serially mediated the relationship between noise sensitivity and noise-related burnout.

Additionally, it was shown that the direct association between individual noise sensitivity and noise-related burnout remained significant. In conclusion, this is the first study to show effect pathways between individual teachers' noise sensitivity and psychological and physical stress symptoms. Teachers' noise sensitivity seems to play a larger role than perhaps previously suspected. The findings imply, similar to the antecedent study, that there might be sensitive teachers who suffer more from school noise. From our model, it can be inferred that there are different ways to support teachers. On the one hand, it would be possible to identify teachers at risk and offer special support programs. On the other hand, it would be plausible to reduce the experienced noise stress or to prevent vocal fatigue. These aspects are possible starting points for intervention and prevention to reduce the risk of long-term illnesses such as burnout.

5.2. Implications

School noise continues to be a major stressor in the teaching profession. Daily exposure to noise can lead to short- and long-term impairments in teachers, which need to be studied more closely. To contribute to this effort, a total of three studies were conducted. The first two

studies took a closer look at the effects of noise during breaks on prospective teachers' stress experience and performance. The third study focused on potential preventive factors, namely coping styles and noise sensitivity. First, teachers' different coping styles were related to the effects of school noise. Second, effect relationships between individual noise sensitivity and psychological and physical symptoms were investigated. From the findings of the individual studies, implications for school practice and for future research emerge.

5.2.1. Implications for School Practice

The results of the first two experimental studies suggest that school noise has no immediate effects on teachers' (concentrative) performance. However, inferred from our findings, prolonged school noise may lead to after-effects in teachers' performance. For simple visual or short tasks, school noise might have stimulating and thus positive effects on teachers' performance (cf. Hancock & Warm, 1989, 2003). However, for more complicated tasks during prolonged noise exposure, teachers' performance may become increasingly impaired (cf. Hancock & Warm, 1989, 2003). While it seems that noise only subsequently affects objective work performance, it has an immediate and negative impact on the individual's stress experience (cf. Lazarus & Folkman, 1984).

In relation to the example explained in the theory section, it can be assumed that during a noisy but not very demanding group work in class, teachers work with concentration during the lesson. Depending on the task they have to perform within the lesson and the task that follows after the lesson, their performance might even improve after the lesson. However, if the lesson is noisy and persistently demanding, there is a high probability that the teacher will still be performing at full capacity during the lesson, but will have limited performance after the lesson. After a noisy and demanding lesson, for example, the individual will have more trouble correcting an exam without errors or listening attentively to the discussion in a teachers' conference.

Through the experiments, it became clear that the student teachers – even though no objective changes were yet apparent – felt stressed primarily by the continuous noise. Accordingly, school noise seems to have a negative impact on both objective behavior and subjective experience. On the subjective level, however, noise stress seems to manifest itself more quickly than on the objective level (cf. Matthews, 2001). In order to prevent such negative effects on teachers' experience and performance, it is essential to raise teachers' awareness of school noise and its consequences (cf. Jiménez-Tejada et al., 2012) and to develop ways to reduce noise exposure at school, both objectively and subjectively (cf. Norlander et al., 2005). In addition, breaks between classes and break supervisions should become mandatory for teaching staff.

The results of the first part of the third study imply that teachers with healthy coping styles suffer less from the psychological and physical negative effects and consequences of school noise than teachers with risky coping styles. Accordingly, risk-types should be identified and trained in more functional ways of coping with (noise-related) stress already during apprenticeship. This could help mitigate noise-related mental and physical illnesses.

The findings of the second part of the third study point to concrete effect pathways between teachers' individual noise sensitivity and various noise-related symptoms. There are several implications here. First, screenings could help to identify teachers at risk for burnout more quickly. This could be accomplished by regularly surveying noise stress and voice problems. Second, it would be possible to provide classroom management trainings to more noise-sensitive teachers to help them learn strategies to avoid agitation and noise in the classroom. Third, schools should provide prevention and intervention services especially for teachers at higher risk to prevent protracted or permanent impairments.

In summary, legislators, school administrators, and teachers must work together to reduce objective and subjective negative effects of school noise and prevent long-term impairments. This can be achieved by objectively reducing noise in educational settings and

improving teachers' classroom management and their individual coping with subjective noise-related stress. This could reduce the likelihood of noise-related mental and physical illness in later working life and potentially reduce costs to the economy and healthcare system.

5.2.2. Implications for Future Research

Since it has been shown that prolonged exposure to noise has a negative effect on subsequent task performance in student teachers, it would first be important to replicate these findings in a larger sample of student teachers. Thereafter, this experiment should be conducted on practicing teachers to determine if the results can be transferred from prospective teachers to practicing teachers. In the long run, field studies would also be needed. Here, teachers could be asked to correct exams after a noisy lesson or to reproduce the contents of a recorded teacher conference. In addition, one could also focus on other performance variables, such as teachers' classroom behavior or their performance during parent conferences. If similar results are found, mandatory breaks between school hours or break supervisions, for example, could contribute to a reduction of such negative effects. Studies on this would also be useful, for instance, to be able to determine the duration of the breaks. To make the stress experience objectifiable, cortisol concentrations using salvia measurements or other physiological stress parameters, such as skin conductance, could be measured during a school day.

The findings of the third study also require replication with a larger sample. After that, longitudinal studies would be necessary to determine possible risk or protective factors, such as coping styles and sensitivity to noise, even before entering the profession. Surveys at multiple measurement time points might reveal whether our findings are merely correlative or whether there are indeed causal relationships between teachers' individual factors and psychological and physical symptoms. Again, other indicators of stress, such as cortisol, pulse, or skin conductance, and also objective data on vocal strain or hearing problems (e.g., hoarseness, tinnitus, hearing loss) would be of interest. In addition, other risk or protective

factors may also contribute to the consequences of noise exposure. From the totality of these research results, it would then be possible to derive a unified theoretical model, on the basis of which more precise statements about the consequences of noise in the educational context would be possible. Individual characteristics such as coping styles and sensitivity to noise should also be integrated into this theoretical model. This allows predictions to be made about which teachers can identify with the statement quoted in the introduction (cf. Blase, 1986, p. 32) and thus have a higher probability of suffering physical or mental illness in the future. Identifying such at-risk teachers is, in turn, an important first step toward improving their health and ability to work.

Somit sind keine Rückschlüsse auf Schulmitglieder oder Unterrichtsstunden möglich. Diese Schallpegelmessung soll idealerweise im nächsten Schuljahr (September 2020) stattfinden. Wir wären Ihnen sehr verbunden, wenn sich an Ihrer Schule eine Lehrkraft freiwillig zur Verfügung stellt, das Schallmessgerät an einem vereinbarten Tag ab der großen Pause bis zur 4.
