The Chair of Market Research offers courses on the bachelor's level ("Market Research Methods"), on the master's level ("Advanced Methods of Market and Management Research"), as well as in the PhD program ("Latent Variable Modeling"). Overall, the students evaluated the courses positively – on a scale from 1 (excellent) to 5 (poor), the average satisfaction with the respective courses was:

- Market Research Methods: 1.63 (fall term), 1.61 (spring term)
- Advanced Methods of Market and Management Research: 1.59
- Latent Variable Modeling: 1.56

Market Research Methods - Fall Term 2012/Spring Term 2013

(37 students)

Market research methods translate data into useful information, thereby improving marketing managers' decisions and the company's market orientation. Market research projects provide answers to strategic questions, such as:

- Are the customers satisfied with the company?
- How do customers perceive the company and its products?
- Which instruments increase customer satisfaction?
- Which marketing activities pay off?

This course provides a sound theoretical and applied introduction to the methods of data generation and data analysis. Furthermore, the course enables participants to conduct market research projects and to critically evaluate market research findings of third parties (e.g., consultants). Moreover, participants will be familiarized with the limitations of the discussed methods.

Advanced Methods of Market and Management Research - Fall Term 2012

(52 students)

General managers, management consultants, investment advisors, brand managers as well as sales managers need an excellent knowledge of market and management research methods for at least three reasons:

- First, knowledge of analytical methods enables you to soundly answer crucial questions facing any business: How do our customers and employees perceive us? How do our activities influence customer and employee behavior? Thus, knowledge of analytical methods enables you to make better decisions.
- Second, knowledge of analytical methods enables you to back up your discussion position
 with empirical evidence and quantitative facts. In internal debates, those who are able to provide empirical evidence and quantitative facts typically have the most powerful arguments.
 Thus, knowledge of analytical methods increases your internal authority and enables you to
 better champion your ideas.
- Third, knowledge of analytical methods enables you to detect methodological flaws and to challenge false claims made by others (for instance, management consultants, market researchers, internal opposition). As Benjamin Disraeli has noted, "there are three kinds of lies: lies, damned lies, and statistics". Thus, knowledge of analytical methods enables you to defend against assertions and manipulative tactics.

Finally, the course is an excellent preparation for students who are considering a PhD thesis after their MSc studies.

PhD Program

Latent Variable Modeling - Spring Term 2013

The general latent variable model (or special cases of it such as ANOVA models, regression models, factor analysis models, structural equation models, etc.) is applied in almost every scientific study in business administration. A sound knowledge of the model and its underlying assumptions is crucial when you set up your studies, write up results in an appropriate way, defend your methodological approach against reviewers, and ultimately get your papers published.

Course objectives:

- The course provides a solid review of the statistical theory and the assumptions underlying the latent variable model. It should be noted that the statistical concepts are presented in an accessible way; graduate course work in advanced statistical methods is not necessary.
- Participants learn how to estimate latent variable models by means of the Mplus software program. Mplus is an easy to use software package for the estimation of general latent variable models. For further information visit: www.statmodel.com.
- Latent variable models are used in many scientific disciplines (e.g., psychology, sociology, and biology) and there are certain discipline-specific methodological paradigms and trends.
 The course covers modeling issues and trends that are specific to the area of business administration.

Causal Effects of Surveys on Customer Behavior

Second Supervisor: Ove Jensen, Chair of Sales Management and Business-to-Business Marketing

Any market researcher measuring customer satisfaction to predict future purchase behavior implicitly assumes that the act of measuring customer attitudes does not have an impact on customers. However, research on the mere-measurement effect has demonstrated that, contrary to this as-



sumption, surveying customers increases attitudinal and behavioral outcomes (e.g., amount of money spent, repurchase incidence). Since market research studies are obligated to neutrally gather insights, such effects are highly problematic and undesirable.

However, as previous studies have not accounted for noncompliance, that is, for the common phenomenon that some customers do not respond to the survey, the starting point of this dissertation is to investigate whether such causal effects of survey participation actually exist. As regards extending current research on survey effects, this dissertation also explores the heretofore uninvestigated effect of refusing to participate in customer surveys. Together, the results intend to provide a more comprehensive picture of the total effects of customer surveys.

Evidently, achieving the aforementioned objectives rests on methodologically accounting for noncompliance. Borrowing from econometrics, biometrics, and general statistics, this doctoral dissertation thesis will employ principal stratification (Frangakis & Rubin 2002), the framework of potential outcomes (Neyman 1923), and Rubin's Causal Model (Holland 1986) to estimate the causal effects (Angrist, Imbens & Rubin 1996; Imbens & Angrist 1994) of survey participation and nonparticipation in a large-scale field experiment. Moreover, laboratory experiments will be used to investigate the mechanisms behind the respective survey effects.

Impact of Corporate Social Responsibility on Consumer Behavior

Corporate Social Responsibility (CSR) is a concept that has received significant attention during the past decades. CSR can broadly be defined as a company's status and activities with respect to its perceived social obligations (Brown & Dacin 1997). Companies place more and more attention



to CSR on their corporate agendas because it has been shown that the communication of CSR activities not only boosts purchase intentions and loyalty but also enhances evaluations of the company or brand (Sen & Bhattacharya 2001). In addition to the beneficial outcomes associated with a positive CSR record, recent research suggests that CSR may not always be an asset. Specifically, when products are of high quality or associated with strength-related attributes, a positive CSR record can decrease purchase intention and product preference (Luchs et al. 2010; Sen & Bhattacharya 2001). This dissertation extends the existing literature and addresses two research topics:

- 1. The interactive effect of CSR and perceived innovativeness on brand attitude Although CSR and innovation play an important role in the quest for competitiveness, the two concepts have rarely been discussed in combination in the consumer behavior literature. Shorter product lifecycles and an acceleration in the rate of technological development force companies to focus on new product innovations. At the same time, consumers also expect companies to have a positive CSR record and to consider environmental ramifications of their activities. In this research, we explore whether CSR boots or reduces the positive impact of perceived innovativeness on brand evaluations and whether CSR- and innovation-related brand attributes can create a homogeneous brand image.
- 2. How does the framing of CSR messages influence consumers' perceptions of brands? According to construal-level theory, any action can be construed at different levels of abstraction (White, MacDonnell & Dahl 2011). Therefore, CSR initiatives can also be communicated and construed in abstract (e.g., "we are committed to protect the environment") and concrete ways (e.g., "we recycle 70% of our paper waste"). However, the ramifications of formulating CSR initiatives in abstract versus concrete ways have not yet been investigated and therefore, we explore the effect of CSR message framing on (1) a firm's social brand image and (2) consumers' general decision behavior (e.g., short-term versus long-term oriented decisions).
