


### Foreword

This is the 13th annual report of the Endowed Chair of Finance at WHU and provides you with all of the important information for the academic year 2011/2012. In addition to the chair's activities, a significant proportion of the chair's resources are also absorbed by the chairholder's appointment as Associate Dean of WHU – Otto Beisheim School of Management for 3 years starting in September 2011 and his continued role as Academic Director of the Master of Science (MSc) and Master of Law and Business (MLB) programs.

The MSc program has sustained its pattern of growth since 2011. This summer, the program received 188 applications from students, 107 of whom will be enrolled in the MSc class of 2014. This constitutes a remarkable increase compared to last year, when 132 applications were received and the intake amounted to 72 students. Compared to October 2010, when the chairholder assumed responsibility for the program with the objective of initiating future growth, the intake has more than tripled. Moreover, the synchronous increase in applications from non-WHU graduates and international students is particularly encouraging and emphasizes the attractiveness of the program in the market.

In recent years, the excellent performance of the MSc program in the Financial Times Masters in Management Ranking has been a testament to the quality



of the program and of the student body. As recently as 2011, the program was ranked number six among MSc programs worldwide. Unfortunately, the WHU is not eligible to participate in the 2012 Master's in Management Ranking since it surveys only Master's graduates from the year 2009. Due to the transition from the Diploma to the Bachelor and Master's programs in the course of the Bologna Process and the ensuing graduation of WHU's first MSc class under the newly established BSc/MSc structure in 2010. WHU did not graduate any MSc or diploma students in 2009. However, the MSc program will be again eligible for participation in the ranking in 2013, when WHU hopes to at least regain the outstanding position it achieved in last year's ranking.

In addition, the following developments and achievements at the Chair of Finance deserve special mention:

1. Two new research assistants joined the chair during the past academic year. Dipl.-Kfm. Sören Pippart, a graduate of Saarland University, was welcomed to the chair in October 2011. Jan Peter Schmütsch joined the chair in April 2012 after obtaining his MSc in Management from WHU.

2. During the preceding business year, five dissertation projects were completed:

"Essays on the Valuation of Commodity Derivatives" by Janis Back

"Asset and Liability Management with Jump Risks" by Mareen Benk

"Predictions, Nonlinearities and Portfolio

Choice - Applications of Artificial Neural Networks to German Market Indexes" by Friedrich Kruse

"Credit Portfolio Management - An Analysis of Credit Risk Drivers, Models and Risk Management Tools" by Christoph Pavel

"Customer Portfolio Management - An Application to Private Wealth Management" by Christian Zaum

The completion of the aforementioned dissertations also paved the way for some of the most recent publications and working papers at the chair. In August, a paper co-authored by Janis Back and Marcel Prokopczuk (Zeppelin University) entitled "Seasonality and the Valuation of Commodity Options" was accepted for publication by the Journal of Banking and Finance. Moreover, two further papers, "The Economic Value of Nonlinear Predictions in Asset Allocation" and "ETFs: Finding your Way Around Active Risk," were both published in different issues of Problems and Perspectives in Management. Finally, a paper with the title "Outcomes of Service Quality in Private Banking Business" was published in the International Journal of Business and Management. Furthermore, seven working papers were written and form the basis for future publications. Among them is a paper entitled "Seasonal Stochastic Volatility: Implications for the Pricing of Commodity Options," which was accepted for presentation at the Eastern Finance Association in Boston and is currently in "revise and resubmit" status at Management Science.

4. The third Private Banking Day was again a success. 106 participants came together at WHU on April 20, 2012. This continued last year's growth and indicates that the conference has established itself among private banking professionals, academics, and students in German-speaking countries. The next Private Banking Day will take place on April 16, 2013.

5. The results of the second issue of the WHU Private Banking Rating have been presented and were well received by the press. The analysis is based on a unique dataset of 559 questionnaires completed by private banking clients from 79 different providers.

The Chairholder continues to serve as co-director of the Bucerius Law School and WHU Master in Law and Business (MLB) - Joachim Herz program. This August over 40 students from 33 countries obtained their Master's degree when the sixth MLB class graduated from Bucerius Law School and WHU. They were the first to study under new study regulations and benefited from an improved course offering that enables students to better tailor their curriculum to their individual needs. In the coming academic year, the seventh MLB class - 51 students, 75% of whom come from abroad - will study at both universities while the program directors continue to explore options to further enhance the program.

7. Brain Capital GmbH has enjoyed further growth, as well. Dr. Marco Vietor and Johannes Frankenfeld, together with six associates, continue to direct the organization, which offers students a reverse generation contract. The total amount of funds managed by Brain Capital amounts to €38 Million. Today, about 600 students are supported by the reverse generation contract and around 200 students have already entered the payback period. The reverse generation contract pays students' tuition fees to their universities. In exchange the students pay a pre-determined fraction of their later income to a tuition fund managed by Brain Capital. The company collects investment money from private and institutional investors in order to finance the tuition of these students in advance.

The chairholder plays an active role in the Campus for Finance initiative. He heads the academic board and in this role advises the organization teams of the Campus for Finance New Year's Conference, Research Conference, and Private Equity Conference on guestions of content as well as the future development of the conferences. The thirteenth Campus for Finance New Year's Conference is scheduled to take place on January 17 and 18, 2013. On this occasion, international academics, professionals, and students will again convene at WHU to discuss highly relevant questions with high-profile speakers including Helmut Schmidt, former Chancellor of West Germany; Aleksander Kwaśniewski, former President of Poland; and Jürgen Fitschen, Co-Chairman of Deutsche Bank, Dr. Maximilian Zimmerer. Member of the Board of Management of Allianz SE, among others.

I wish to sincerely thank all those at the chair and associated with it who have contributed to the success of WHU – Otto Beisheim School of Management and

its Endowed Chair of Finance during the past business year. I would also like to express my appreciation for the contribution of Ms. Marianne Diel, who has been closely associated with the chair for 14 years. I equally value the input of Ms. Kirsten Schmitz, a member of the chair for three years now. I am very happy with the development of the chair and the achievements of its members and would like to express my gratitude and appreciation to all of them for their cooperation.

In closing, I wish to express my gratitude to the sponsors of the chair as well as the sponsors of the Center of Private Banking for their support and contributions. I especially would like to thank Allianz SE, which has been a very close friend and supporter of the chair for many years.

## The Center of Private Banking



The Center of Private Banking focuses on three core areas of activity: research, teaching and education, and dialogue. The goals of the center are to enhance WHU's research profile in the area of Private Banking; to increase the awareness of the public community, including wealthy private customers, regarding this topic; and to promote collaborative communication between Private Banking practitioners.

In our research we concentrate on the two fundamental areas of Asset Management/Products and Customer Relationship Management. For example, we analyze service quality and its effects, customer satisfaction and customer loyalty, from the perspective of both Private Banking suppliers as well as customers. Another research project covers aspects of customer portfolio management. In the area of asset management, focal points of research include alternative asset classes, measurement of customer preferences, and investment performance. We also examine aspects of behavioral finance.

We are able to increase the interest and enthusiasm of WHU students for Private Banking through lectures, talks with practitioners, and the supervision of Bachelor's and Master's theses.

For members of the Center of Private Banking, the individually designed training program has continued in 2012 with the three modules Private Banking Rating, Sovereign Risk, and Communication. The current program will end in September with an exam covering the modules of the course from 2011 and 2012. In total, 39 participants from different areas of the Private Banking units of the Center's members took part in this year's program.



Meeting Adivisory Board of the CPB in April 2012

Due to the high practical relevance of research in the area of Private Banking, the Center organizes meetings with all members on a regular basis. These meetings generate an intensive exchange between practitioners and researchers. The meeting held on February 10th, 2012 featured talks by Ruth Kümmerle (Illiquid Investments in a Portfolio Context) and Tim Krume (Private Banking Rating). The next meeting will take place on September 14th.

Our research results are also used to establish a rating system for the Private Banking market. The underlying database already comprises 559 data sets of private banking customers, and will be further expanded to approximate 985 data sets for next year's rating.

The Center of Private Banking additionally demonstrates its competence and engagement by contributing to scientific publications, organizing events, and providing speakers for several events. After the success of the past three annual Private Banking Days (2010-2012), the fourth Private Banking Day will take place at WHU on April 16th, 2013. Participants, who include both practitioners as well as members of the scientific community, will once again be offered a forum for exchanging valuable perspectives and insights into various aspects of Private Banking.

## Third WHU Private Banking Day in 2012



Welcoming Speech Prof. Dr. Markus Rudolf

Conducting a public dialogue about private banking related topics is one of the three core activities of the Center of Private Banking at WHU – Otto Beisheim School of Management. The WHU Private Banking day, launched in 2010, allows for this dialogue and provides private banking professionals, academics, and selected students with the opportunity to exchange information and insights about private banking and wealth management.

The third event in the successful Private Banking Day series took place on April 20th, 2012 at the WHU – Otto Beisheim School of Management in Vallendar. Fourteen well-known speakers discussed various current topics during eight presentations, a panel discussion, and a dinner speech.

The core issues discussed at the 3rd WHU Private Banking Day were regulatory requirements, increasing customer demands, pressure on earnings, and financial market uncertainty.

The first speech of the day was held by Andreas Brodtmann (Personally liable Partner at Berenberg Bank), who spoke on the topic "Concepts of a Private Bank in a Changing Environment". According to Brodtmann, the financial crisis has left its mark: regulatory requirements as well as high-quality customer advice have become increasingly important. A change of private banking business models will be the consequence.

The following presentation, by Til Klein (Principal, The Boston Consulting Group), provided an overview of current developments in the private banking market according to the latest BCG Global Wealth Report. He pointed out that not only earnings, but also costs increased throughout 2010.

In his presentation "Debt Crises and Growing Economies - The World is Changing," Dr. Josef Kaesmeier (Chief Economist at Merck Finck & Co, Privatbankiers) discussed different growth factors. He furthermore identified the links between politics and economy that favor the current levels of global indebtedness. Dr. Jochen Eichhorn (Partner, Lachner Westphalen Spamer) followed with a detailed report on the legal and regulatory environment of today's Private Banking Industry.

After lunch, Prof. Dr. Markus Rudolf (Head of WHU's Center of Private Banking) presented the WHU – Private Banking Rating. This report measures customer satisfaction solely based on customers' perceptions, independent of any banking institution. Prof. Rudolf highlighted the fact that customer satisfaction for the whole banking market only received an average grade. According to the 2011 report, private banks and independent wealth managers received the best ratings.

The CEO and Head of Private Banking Germany at Vontobel Europe, Frank Wieser, emphasized the necessity of a "culture of change" in private banking. According to Wieser this change is due to the pressure of client's expectations on the one hand and regulatory requirements on the other.

The afternoon session opened with a lively panel discussion about "Customer advice during times of crisis – how is the sovereign debt crisis transforming the private banking industry?" Dr. Jörg Richter (IQF) chaired the discussion of the following panelists: Prof. Dr. Teodoro D. Cocca (Johannes Kepler University, Linz), Dr. Peter König (Managing Director, DVFA), Prof. Dr. Alexander Kolb (CIO, Bolle Fonds), Håkan Strängh (Head of Private Banking, J.P. Morgan Germany & Austria) and Dr. Bernd Türk (Head of WM Sales Management & Head of Asset Management at Commerzbank).

The panel discussion was followed by a speech by Prof. Dr. Alexander Kolb (CIO, Bolle Fonds) about the competition between family offices, independent wealth advisors, and banks. He particularly stressed the fact that customers have to be aware of the trade-offs between seeking independent advisors are often smaller companies with only limited profitability.

The final presentation was held by Dr. Bernd Türk (Head of WM Sales Management & Head of Asset Management at Commerzbank). He pointed out that discretionary portfolio management might become increasingly important in the midterm due to the prevailing market conditions in the private banking industry.

The conference ended with a dinner speech by Michael Rüdiger (CEO Central Europe, Credit Suisse) entitled "Private Banking – Quo Vadis." For Rüdiger, further professionalization is essential for the whole private banking industry. In his speech he stated, "One has to decide which part of the value chain to cover. In the private banking industry this decision is crucial to attract and to hold customers."

Prof. Dr. Markus Rudolf is the Associate Dean of WHU, a position he has held since October 2009. In September 2011, the senate of WHU re-elected Prof. Dr. Rudolf for a further term of office of three years.

In his role as Associate Dean he has delivered addresses and given speeches on several occasions. At the WHU Private Banking Day 2012, he gave a speech on "Private Banking Rating". Prof. Dr. Rudolf was also a panelist at the WHU Family Business Conference in April 2012, where he discussed the stability, solidity and sustainability of family enterprises against the backdrop of the Euro debt crisis with former Federal Minister Hans-Dietrich Genscher as well as Jürgen Fitschen (Co-Chairman of Deutsche Bank's Management Board), amongst others.

Moreover, Prof. Dr. Rudolf continues to serve as Academic Director of the WHU Master of Science (MSc) program and as Co-Director of the Bucerius Law School and WHU Master in Law and Business (MLB) - Joachim Herz program, an office he assumed in 2006 and shares with Prof. Clifford Larsen (Bucerius Law School). The WHU MSc program is designed as a consecutive business science degree. It is tailored towards outstanding, performance-oriented students holding Bachelor degrees in the area of business studies, who are keen to expand into an international context. The program builds on existing business fundamentals and at the same time offers a pronounced focus on extensive practical experience.

The Bucerius/WHU Master of Law and Business is most suitable for international students whose first degree is in law or business with at least two years of prior working experience, but is open to students of other disciplines as well. The program aims to convey knowledge out of both branches of study in combined lectures on special topics. In addition to his role as Co-Director of the MLB program, Prof. Dr. Rudolf is responsible for the conceptual design and planning of those parts of the program which focus on management studies. The business faculty contains professors of WHU and further German and foreign universities as well as notable corporate lecturers. Substantial parts of the MLB program are taught on the campus of the Bucerius Law School in Hamburg. An additional two live-in weeks are scheduled on the WHU campus in Vallendar each year.

Furthermore, Prof. Dr. Rudolf acts as Academic Director of the Campus for Finance Association and heads the Center of Private Banking, which is associated to the endowed Chair of Finance.

During the previous budget year, Prof. Dr. Rudolf was a member of two search committees for academic positions at WHU. He headed the search committee for the Otto Beisheim Endowed Chair in Entrepreneurship and New Business Development, which led to the appointment of Prof. Dr. Christoph Hienerth. Prof. Dr. Rudolf was also a member of the search committee for the Roechling Assistant Professor of International Innovation Management, which resulted in the appointment of Assistant Prof. Dr. Anna Dubiel.

In addition, Prof. Dr. Rudolf is a member of three ongoing search committees. He is in charge of the search committee for the chair of finance and capital markets and is a member of the committees tasked with appointing the new Professor of Innovation and Organization as well as

the Assistant Professor of Production Management.

## Bucerius/WHU Master of Law and Business – Joachim Herz Program

Chairholder Prof. Dr. Markus Rudolf is the Academic Co-Director of the Master of Law and Business Program, a collaboration with Bucerius Law School in Hamburg that was launched in August 2006. He is responsible for the program's business and management curriculum.

The Bucerius/WHU Master of Law and Business -Joachim Herz Program aims to provide students with preparation in the fields of law and business studies by offering combined lectures on special topic areas. The target group consists of international students whose first degree is primarily in law or business and who have at least two years of work experience. The program's legal component deals with all key legal challenges confronting an internationally operating company. By applying a comparative law approach, the participants learn to analyze international legal questions by integrating the different perspectives of different legal systems. The business studies component of the program is primarily concerned with basic business management knowledge that is particularly relevant to commercial lawyers.

The specific focus of the program is to offer complementary law and business courses, taking an interdisciplinary approach to central issues in international business and using a lifecycle-based method. The program is also unique in offering internationally focused, comparatively-oriented classroom instruction with teaching staff from many countries as well as an internship, Studium Generale, Master's thesis, a Capstone course and a Social Project. All of these elements are integrated into one – very intensive – calendar year.

In addition to their law and business courses, the participants are taught practical skills, as well. The students receive writing courses in drafting English-language contracts, letters, and memos as well as courses in negotiation skills.

The program's students are characterized by their high degree of internationalism and diversity. The participants in the class of 2011 represent 30 countries on five continents. The program primarily takes place on the campus of Bucerius Law School in Hamburg, but the participants also spend time on the WHU campus – for example, for two live-in weeks, in some cases while writing the master's thesis, and for some student events.

With the successful completion of the program, the students are graduates of both WHU and Bucerius Law and they are very welcome to join both alumni networks. The commitment of the Joachim Herz Stiftung deserves particular mention; the German non-profit foundation has provided generous financial support to the MLB Program since 2009 to even further improve the program's already international character.



Certainly, this is at least partially due to three "virtual information days", during which Prof. Dr. Markus Rudolf offered insights into administrative and academic cornerstones of the program. Hitherto adds, that for the first time we saw an alternative selection process for international students in order to further encourage applications from countries outside of Europe, which in many cases would otherwise not have been feasible.



## **The Lectures**

## Foundations of Finance (Assistant Prof. Dr. Baedorf 2 SWS, 2 groups, BSc Program)

... is a compulsory course for Bachelor students. The lectures are held in English. The course covers the foundations of financial decision making. It focuses on investment decisions, first under certainty and then under uncertainty. It presents solutions to the optimal combination of risky assets in a portfolio and the determination of the market price of risk.


188 students passed the exam in Fall Term 2011 with an average grade of 2,49. The overall grade distribution is shown in the figure below.



## Foundations of Investments (Prof. Dr. Rudolf 2 SWS, MLB Program)

... is a lecture of the MLB Program. The course covers the foundations of financial decision making. The theoretical guidelines of the course are inspired by paradigms, neoclassical economics, and behavioral economics. The course provides an introduction to the basic concepts of finance. Investments under certainty, the valuation and risk assessment of bonds, and behavioral biases are all considered.


In Spring Term 2012, 30 students of the MLB program passed the exam with an average grade of 2,07. The overall grade distribution is shown in the figure below.



## Introduction to Modern Banking (Prof. Dr. Wieandt 2 SWS, BSc Program)

... is an optional course for Bachelor students. The course is offered by Prof. Dr. Axel Wieandt. The lectures cover essential aspects of financial intermediation, banking, and the functions, products, and services of banks. The course focus lies on two complementary objectives: analyzing the economic structures of the banking sector and communicating a basic knowledge of the activities, structure, and functions of banks. Descriptive case studies are used to deduce tendencies and strategies in the financial services sector. The lectures are held in English.


26 students of the BSc Program passed the exam in Spring Term 2012 with an average grade of 1,99. The overall grade distribution is shown in the figure below.



## Investment Banking (Prof. Dr. Achleitner 2 SWS, BSc Program)

... is a course offered by Prof. Dr. Paul Achleitner for students in the third or fifth semesters of their Bachelor studies. The products and services as well as the actual trends in the M&A business are presented. The focus lies on the analysis of the strategic drivers, capital market drivers, and company-specific drivers of the M&A business. The course furthermore deals with the market for company controls.


In Fall Term 2011 there were 65 students of the BSc Program who passed the exam with an average grade of 2,34. The overall grade distribution is shown in the figure below.



### Sovereigns as Counterparties (Prof. Dr. Rudolf 2 SWS, MSc Program)

... is an optional course for Master's students. The lectures examine the course of the financial and economic crises from with the subprime crises in 2007 until the sovereign debt crises starting in 2010. This entails analyzing several different types of risks that seemed to be very unlikely to happen, but which then occurred very unexpectedly. The first risk that materialized was in the subprime mortgage market and the associated structured products such as CDO's and MBS's: the market for these structured products is the starting point of the lectures. Then the financial system became increasingly unstable, raising questions about the adequacy of financial regulation and about system stability in general. Therefore, regulatory as well as systemic issues are next addressed in the lectures. Finally, some countries and their respective currencies became unstable as well - starting with Iceland and the UK, and spreading very quickly to the Eurozone countries Ireland, Greece, Portugal, Spain, and Italy. Therefore, the series of lectures will wrap up with an overview of measuring and calculating sovereign risks.

25 students of the MSc Program passed the exam in Spring Term 2012 with an average grade of 2,28. The overall grade distribution is shown in the figure below.



#### Asset Management (Dr. Leser 2 SWS, MSc Program)

... enables students to understand the structure of, and current issues in, active and passive asset management services and their relationship to a number of concepts of capital market theory. After completing the course, students will be familiar with the various styles, tools, and techniques of real-life asset management.

Part I of the lecture series revisits important elements of capital market theory with a special emphasis on those aspects of model architecture which are not usually covered in textbooks. Part II explains the basic structure of the asset management industry by deviations from the perfect world of theory. It analyses the tools and techniques applied by real world asset managers as well as the role of investment consultants. In addition, the demand side of the market is analyzed by describing the methodologies and tools of institutional investors.

In Spring Term 2012 the lecture Asset Management was succeeded by 11 students with an average grade of 1,88. The overall grade distribution is shown in the figure below.



## **Course Evaluations - (DOBES)**

Student course evaluations are carried out each semester in order to encourage the continuous improvement of teaching quality. Students are able to anonymously evaluate the quality of the courses after each lecture period via the DOBES system (DOzentenBEwertungsSystem).

The evaluation of the courses is based on a questionnaire that measures the quality of different course criteria (lecturer, course structure, student input, reasonable requirements). Generally, courses with 15 or more attendees are evaluated.

For the BSc and MSc Programs grading is from 1 ("strongly agree") to 5 ("strongly disagree").

The courses offered by the Endowed Chair of Finance all received a very good rating in the range between 1,36 and 2,28.

The "Investment Banking" lecture for the BSc Program, held by Prof. Dr. Achleitner in Fall Term 2011, was graded 1,36. The lecture "Introduction to Modern Banking" offered for the BSc Program in Spring Term 2012 by Prof. Dr. Wieandt received a 1,61.

Due to his sabbatical term Prof. Rudolf only held the lecture "Sovereigns as Counterparties" during this reporting period. This course was offered to students in the MSc Program for the first time in Spring Term 2012 and obtained a grade of 1,74.

Moreover, Assistant Prof. Dr. Baedorf held the compulsory course "Foundations of Finance" for the first time completely for both groups of the BSc Program and was thereby graded with 2,28.

For the remaining courses held in Spring Term 2012, DOBES results were not yet available at the editorial deadline.

The objective of this research project is to analyze risk preferences in a laboratory experiment. Experiments with about 100 participants have been conducted in the WHU Behavioral Lab and in the BonnEconLab in order to gain a deeper understanding of third-order risk preferences, such as preferences for skewness and prudence. A preference for skewness is relevant for example in a portfolio context. as returns of most asset classes are not normally distributed - as traditionally assumed - but skewed. The chosen experimental approach ensures that the analysis is not just based on economic theory, but comprises empirical data obtained by individual decision making under uncertainty.

According to Obstfeld & Rogoff (2001, "The six major puzzles in international macroeconomics: is there a common cause?" in: Bernanke, Rogoff (eds.): NBER Macroeconomics Annual 2000, Vol. 15. MIT Press, pp. 339-412.), home bias is one of the "six major international macroeconomics puzzles." There is growing behavioral evidence that the fear of the unknown plays a role in investors' portfolio decisions. Whereas the empirical literature used proxies for perceived ambiguity, attitudes towards ambiguity are overlooked. Hence, with data from a worldwide survey, we fit a three-way fixed effects panel model to investigate whether investors have aversion-to-ambiguity preferences. Further expanding on this point, the second project uses an experiment to shed light on the question of whether variables frequently used to proxy for perceived ambiguity, such as familiarity (measured via the distance between two countries) or patriotism, reduce investors' perceived ambiguity or if there are preferences for familiarity/patriotism per se.

The dissertation looks at strategic asset allocation for high net-worth individuals and the characteristics of alternative asset classes relevant to them. Risk is described in a more accurate way than from a normal distribution by considering fat tails and asymmetry as well as adjusting for illiquid/smoothed returns (autocorrelation). Expectations deviating from the historic development are flexibly included into robust return estimates using "entropy pooling". Additionally, the approach approximates the long-term portfolio development and analyzes scenarios like a crisis on the stock market

A float adjustment is carried out to assess both, the extent and development of bilateral home bias on an international basis. Furthermore, the impact of concepts from the neoclassical and behavioral finance literature on equity home bias is tested.

This PhD project therefore develops a quantitative empirical model that allows an investigation of the influence of relevant determinants on the default risk of a country in the Euro zone. Because of the variety of considered economic and political risk determinants, the analysis of the risk factors is carried out using a structural equation model.

Thus, securities prices reflect investors' over- and under-estimation of future (state) probabilities. Evaluating robust option implied state probabilities across markets and time, this thesis aims at developing a novel option implied sentiment index and examining its characteristics across industries and across time. Further, this index will be compared to other forms of sentiment indices not directly derived from financial time series but, for example, from questionnaires. Another part of the research will center on the question of whether an investment in options exbiting a strong sentiment will exhibit inferior returns.

Topic: Measuring the Cost of Equity Capital – A Call for Approaches Beyond the CAPM

Measuring the cost of equity capital plays an important role in finance theory and practice. Practitioners rely heavily on the Capital Asset Pricing Model (CAPM), although the evidence suggests that it does not provide reliable estimates of the cost of equity capital. Based on an extensive review of the CAPM, we introduce several alternative and more sophisticated methods that comprise CAPM-related as well as implied-cost-of-capital methods. While such models seem to provide more accurate estimates, no method is seen as dominant. We conclude that practitioners are advised to employ more sophisticated models and that further practical research in this field is required.

Topic: Determination of Robust Portfolio Structures – Asset Allocation in a "New World Order"

The Markowitz mean-variance optimization framework clearly constitutes one of the most important theoretical, quantitative portfolio construction methods in modern asset allocation. However, several weaknesses associated with the approach have prevented its extensive application in practice to date. The main shortfall is the high sensitivity of both the portfolio structure and the portfolio performance to estimation errors in input parameters. The bachelor thesis presents, evaluates, and compares different robust portfolio construction methods which have the objective to mitigate these weaknesses of the mean-variance framework. Finally, a conclusion is derived with regard to the effectiveness of the different approaches.

Topic: Effectiveness of Quantitative Easing

Based on an extensive literature review, the unconventional monetary policy approach of the U.S. Federal Reserve during the recent financial crisis, also known as quantitative easing, seems to indeed have lowered long-term interest rates mainly by reducing supply of safe and non-substitutable assets such as U.S. Treasuries. Whereas historic interventions, e.g. in the U.S. during the early 1960s or in Japan during the 2000s, were not viewed as a success, time will tell whether the Federal Reserve is able to avoid inflationary tendencies inflicted by such expansionary measures by unwinding their massive private and public debt holdings.

Topic: Welche Sachwerte bringen den besten Inflationsschutz? – Bringen Sachwerte überhaupt Inflationsschutz? – Beispiele aus der Historie

It is a widespread belief that exotic tangible assets are a good hedge against inflation, outperforming traditional investment classes. However, most empirical research suggests that exotic tangible assets indeed protect against inflation but do not achieve higher yields than equities. One explanation is that art and other collectibles carry an aesthetic yield. As a result, the financial yield is lower compared to purely financial investments. Most papers examine the hedging potential against inflation of only one asset class.
