Preface of the Chairholder

Dear Reader of this Activity Report of the Chair of Marketing and Commerce,

The university year 2015/2016 was especially marked by external developments of The Otto Beisheim Endowed Chair of Marketing and Commerce due to the tremendous increase of our media presence in a wide array of topics and the surge in guest speeches. Both these external activities allowed us to enhance our reach of influence on fellow scholars' and practitioners' perceptions by actively combining practice with theory. Therefore, I can proudly say that in my 13th year as a chairholder we did not only achieve to live up to our claim "We inspire marketing" within the WHU community, but also in a broad audience. For the upcoming year 2017 it is our goal to further strengthen this claim in all our activities.

Human resource matters were a major success factor in the past university year. As several internal doctoral team members progressed in their dissertation procedure, they changed to the external status and were replaced by new team members. Also, we were pleased to hire one new external doctoral student so that the overall team size rose to six internal and eight external doctoral students from various backgrounds and research foci. This growth in our headcount reflects our steadily rising activities and engagements on the one hand, but also on the other the great interest by young scholars to become part of the fruitful and inspiring environment at our chair.

This activity report provides an overview of the major happenings of the university year 2015/2016, where we have actively pursued all three pillars that make up the foundation of my chair, namely **Research**, **Teaching**, **Practice & Theory Transfer**.

In terms of Research, there have been various publications in international peer-reviewed journals and we presented the current state of our research projects at several international conferences. A major recognition of the work at our chair was achieved by the selection of the paper "Product Newness: Determinants and Outcomes from the Consumer's Perspective at the Point-of-Sale" as one of the 20 best papers based on a doctoral work in the renowned EMAC conference. Furthermore, after one and a half years of hard work, the 4th edition of the textbook "Price Management" by Professor Dr. Dr. h.c. mult. Hermann Simon and myself was published in August 2016. Also, we are happy that during this university year two dissertation projects were successfully completed at my chair. After mastering the challenging journey of achieving a doctoral degree, I personally wish Dr. Unterhuber and Dr. Kluge a bright future career.

Teaching in 2015/2016 comprised ten courses as part of the Bachelor, Master, diverse MBA or EMBA programs. All of these classes received very positive formal evaluations by the individual participants. Like previous years, I had the honor and pleasure to teach the course "Luxury Brand Management" once again as part of the Kellogg-WHU Executive MBA Program and as a guest professor at the HEC Lausanne Master Program. Furthermore, the M.Sc. Management Program at WHU was further extended to include the course "B2C Price Management" for the first time, which took place in the spring semester. Overall, my teaching concept combines teaching the theory, engaging in active class discussions and providing the students with an application of their acquired knowledge in the business field. Therefore, every course is enriched by various guest speakers and real-life cases, which amplify the learning experience not only for the students but also for myself.

Regarding **Practice & Theory Transfer**, we were delighted that our academic opinions is increasingly valued for providing a deeper understanding to practical issues through interviews, press comments and articles, by acting as a jury member or by giving speeches and lectures for practitioners. Also, we hosted the 7th WHU-Campus for Marketing under the motto "Relevance Rocks" in June this year. Here 95 participants and guest speakers discussed the importance of relevance in today's digitalized and fast-moving environment. However, for strategic purposes this event was relocated to the WHU campus in Düsseldorf for the first time and from now on will be organized only every other year. So we will be delighted to welcome you in 2018 again.

Our claim states "WE inspire marketing". Therefore, the activities of this chair do not stand for me, as the chairholder, exclusively but for a combined team effort. Accordingly, I would like to cordially thank my personal assistant, Ms. Stephanie Krause, as well as all my doctoral students and research assistans for their work and support during this unversity year. I am looking forward to grow the brand "Professor Fassnacht and Team" together with you in the future.

Subsequently, I am delighted to share an overview of our activities and achievements of the university year 2015/2016 with you. We as "Professor Fassnacht and Team" will continue to strive to inspire marketing in whatever we will do.

I hope you will enjoy reading this year's activity report.

Research Foci and Projects

The chair's scientific projects focus on the following fields of research: Price Management, Retail Marketing, Brand Management and Social Media, Market-Oriented Corporate Management and Luxury Brand Management.

Research Focus - Price Management

M.Sc. Dominic Bergers

Dissertation Project: Individual Differences in the Susceptibility of Biases in Pricing



In pricing theory, there are several frameworks that describe how to set prices optimally. Current studies suggest that few companies seem to implement strategies recommended in the pricing literature. This discrepancy between theory and practice is attributed to three main reasons: complexity, inaccurate

information and a lack of responsiveness. Similar reasons also cause other areas of marketing to make incorrect decisions, but they prevail in pricing much more. It is striking that these reasons are also influential when people display irrational behaviour. The PhD project of Mr Bergers focuses on the susceptibility in pricing to irrational decision-making behaviour through biases and heuristics. It will also be examined to what extent individual differences such as personality characteristics have an impact on the susceptibility of relevant biases and heuristics.

M.Sc. Simon Sang Hoon Childs

Dissertation Project: Dynamic Pricing: Conceptualization and Customer Outcomes



Online retailers have increasingly adopted dynamic pricing algorithms thereby allowing high-frequency price variations. In contrast, the application of dynamic pricing in offline retailing has long been questioned due to high menu costs. More recently, however, offline retailers have increasingly replaced

traditional paper price tags by electronic shelf labels. These allow instant price changes resulting in an enhanced feasibility to deploy dynamic pricing at the physical POS. In this vein, it has been reported that few offline retailers run experiments to test dynamic pricing in local stores. Despite these developments in retail practice, it remains unclear, how customers react when being confronted with dynamic pricing based on intertemporal and interpersonal price differentiation, both, in online and offline environments. Therefore, the goal of Mr. Childs' PhD project is to examine psychological and behavioural customer outcomes in response to dynamic pricing.

M.Sc. Jonas Schütz

Dissertation Project: Price-value communication – An OEMs' premium customer journey in the digital world



The ongoing process of digitalization revolutionized the international retail market. Although, the number of online purchases significantly increases and huge online retailers like e.g. Amazon are incredibly successful, the car industry is rather stunted. Cars are still sold offline by authorized dealers, who are rela-

tively free in their scope of action, e.g. in terms of price setting, marketing, etc. Hence, in case OEMs want to implement a standardized online sales platform they have to serve both parties interests.

Additionally, the emergence of price comparison platforms like for example TRUECar.com drastically increased the price transparency on the market. Therefore, OEMs and their dealers feel powerless to resist this perceived growing price pressure. The dealers barely succeed to assert the MRSPs, which the OEMs set, and therefore frequently grant large discounts. This circumstances often ends in a downward spiral of prices and thereby endangers the positioning of especially premium and luxury car manufacturers. The dissertation of Jonas Schütz is going to focus on the premium sector.

In order to ensure an OEM's premium position it needs to create and communicate value to its customers, because value is the only instrument to differentiate from those platforms which have the cheapest price as their USP. Hence, a premium CJ should contain elements which positively affect customers' perception, increase customers' willingness-to-pay, and by that justify premium level prices. Consequently, the aim of the dissertation is to identify key elements of OEMs' premium customer journeys, with a special focus on price and emotional stimuli like pictures, videos, sound, and so on.

Dipl.-Kfm. Markus Szajna

Dissertation Project: Cross-Channel Free Riding at Brick-and-Mortar Retailers



No technological invention had such a severe effect on the brick-andmortar retail environment than the establishment of the internet and online shopping. Whereas in the past, brick-and-mortar stores in general had to compete against each other (and only to a smaller extent against other sales channels

like catalogue, TV, etc.), the advent of the internet and its importance as a sales channel has provided consumers with opportunities that are advantageous in many ways compared to offline purchasing. As a result, many brick-and-mortar retailers struggle to compete with online shops.

Recently, many customers have adopted a behavior that is known as cross-channel free riding in scientific

literature or showrooming in practice-oriented context. This represents the action when a customer visits a brick-and-mortar store in order to examine products or to obtain advise by a salesperson but does not intend to purchase anything. His very intention is, however, to buy the chosen product online from another retailer, usually at a lower price. With the growing popularity of smartphones, it is even easier for customers to investigate the lowest prices and to order online, after receiving advice from the salesperson in a brick-and-mortar shop. This results in an even greater threat for brick-and-mortar retailers.

The aim of the dissertation project is to contribute in finding measures how brick-and-mortar retailers can face cross-channel free riding and transform customer with cross-channel free riding intentions into buyers. Some of the possible measures are service, engagement and sales performance provided by salespeople as they are the ones that interact with customers and therefore have the opportunity to influence their behavior. But also price discounts and commissions are subjects of investigation.

Research Focus - Brand Management and Social Media

M.Sc. Modan Huang

Dissertation project: Perceived newness from the shopper's perspective at the POS



The focus of this dissertation is on how specific verbal and non-verbal packages elements of FMCG products as well as its interactions impact on the perceived newness from the consumer perspective. Whilst companies are trying hard to continuously launch and re-launch 'new or 'innovative' products into consumers' attention, consumers are walking on a hedonic treadmill with the constant search for 'new' products to fulfill their underserved needs. It is, therefore, in the greatest interest of companies to find out what drivers really trigger consumers to perceive a product as 'new' at the point-of-sale (POS) and to what outcomes the perceived newness leads for consumers as well as for firms.

Research Focus - Market-Oriented Corporate Management

M.Sc. Jonas Lechermeier

Dissertation Project: Essays on the effects of customer feedback on employees in an online services context



The digitalization led to several changes for service firms. Customers seeking information or shaping their purchases via interactive dialogues on the internet also increasingly share their service experiences online, making customer feedback crucial for every company success. This feedback

until now is mainly gathered at an organizational level,

used for continuous process improvement or regularly supervisor feedback sessions, when related to service quality issues. If customer service quality feedback is directly provided to employees, it constitutes a kind of individual performance feedback for them. By conducting a field study within the recent service-extension app-chat, the already established feedback characteristics source, valence and timing should be tested in a completely new context also challenging previously suggested relationships. Finally, contributions to service as well as human resource management literature streams should be provided.

18 Research Focus – Luxury Brand Management

Of focal interest to the research at our chair is identifying the specificities of marketing luxury as opposed to non-luxury brands. Traditional marketing principles do not equally apply to luxury brands. Rather than driving sales at any price, marketing luxury goods requires specific principles to enhance and preserve the image of finest quality, exclusiveness, and hedonic value.

MSt. (Oxon.) Dominic Krätz

Dissertation Project: Luxury e-commerce: Online assortment strategies and their impact



The development of luxury e-commerce has been significant throughout the past two years. Luxury sales realized online have reached nearly 14€bn in 2014 increasing by 50 percent from 2013. The digital presence of luxury brands has become paramount not only in retaining current customers but also

in acquiring new potential customers. More than 45 percent of luxury purchases are influenced by what consumers can find within the digital universe. Luxury brands have historically been very cautious with respect to digitalization and e-commerce in particular. The reluctance of luxury brands to adapt online channels has led to a gap between what consumers are looking for and what luxury brands are delivering. Yet, it still remains unclear to what extent luxury brands should embrace the various opportunities provided by the digital world. One of the pressing questions in this respect is the product offering and range of goods to be sold by luxury brands in the internet. Luxury brands can ensure with their own assortment the existence of authentic products in the internet. They remain in control of the brand, its prices and storytelling. Neglecting the internet as a sales channel leaves the door wide open to unauthorized e-retailers which regularly source products on the grey market (e.g. counterfeits). Although e-commerce strategies have become part of most luxury brands' management agendas, only little conceptual and empirical evidence exists as to what product range should be sold. Whereas luxury brands offer a broad variety of products in their brick-and-mortar stores, it remains unclear whether their digital points of sale should include a similar product range. That is, because the internet dilutes essential characteristics of luxury brands, amongst others, exclusive distribution, rarity, and the general luxury service experience. This dissertation projects aims to explore various online assortment strategies, thus contributing to the understanding of luxury e-commerce.

M.Sc. Annabelle C. Scharwey

Dissertation Project: Social Distance in Luxury Customer-Employee Interactions



Social distance is commonly believed to have a negative effect on the formation and quality of social interactions as well as on their outcomes. This especially applies to socially diverse environments and interactions of individuals with different social backgrounds. Luxury retail is such a diverse environment:

the consumption of luxury goods is strongly associated with the maintenance or the achievement of status ("conspicuous consumption") and, therefore, social distance can easily occur between luxury customers and their sales counterparts. However, especially in luxury retail, a high quality of service interactions between customers and sales employees is indispensable in order to justify and legitimate high-end prices, create rarity and exclusivity and animate repurchase intentions. The opposition of the need for high quality service relationships in luxury on the one side and the occurrence of social distance on the other side provide the starting point for this dissertation project.

On August 2nd, 2016, final results on the research topic of "Product Newness: Determinants and Outcomes from the Consumer's

Perspective at the Point-of-Sale", co-authored by MSc. Modan Huang, Prof. Dr. Martin Fassnacht and Prof. Dr. Christian Schlereth, was presented at the new Beauty Care Lighthouse of Henkel's headquarter in Düsseldorf. Ms. Marie-Eve Schröder (Corporate Senior Vice President Henkel Beauty Care) as a member of the Advisory Board at Henkel Center for Consumer Good and Dr. Nils Daecke (Corporate Vice President of Digital Marketing International Henkel Beauty Care) took part in the meeting, where both supported and coordinated the research project throughout the last three years. As part of the dissertation project of Modan Huang, the key focus of this project is on the visual and verbal package attributes that per se may have novelty arousing effects on the perceived newness of a product by a consumer. The intention is to investigate the drivers and outcomes of perceived newness in the context of consumer packaged goods and ultimately, examine how the drivers impact on consumer choices. Implications for both marketing and product managers were derived.

The meeting was rounded up by a personal tour in the highly innovative Beauty Care Lighthouse that was newly opened at the end of July, 2016. The Lighthouse is usually targeted at specific retailor clients and we had the privilege to be one of the first to be guided through themes ranging from R&D, product innovation, sustainability to digital marketing. Above all, Prof. Fassnacht and Modan Huang, received a personal presentation about the future digital pathways that Henkel Beauty Care pursues by three WHU students, Lisa Schulz, Laura Kirchkamp und Katharina Rosenthal, who are currently doing their internships at the department. By visiting test hair salons, trying out the latest Virtual Reality Glasses, Schwarzkopf App and digital gadgets, the tour was indeed interactive, vivid and eye-opening.

7th WHU-Campus for Marketing

This year's WHU-Campus for Marketing treated the thesis "Marketing: Relevance rocks!". The hosts Prof. Dr. Martin Fassnacht, Scientific Director of the Center for Market-Orientated Corporate Management (CMM) and holder of the Otto Beisheim Endowed Chair of Marketing and Commerce at WHU – Otto Beisheim School of Management, and Prof. Dr. Dr. h.c. mult. Hermann Simon, Chairman of Simon-Kucher & Partners and chairman of the Advisory Board of the CMM, welcomed top-class speakers from diverse corporate sectors to discuss this controversial and wide-ranging thesis. The conference took place for the seventh time and was held at the Düsseldorf Campus of WHU – Otto Beisheim School of Management for the first time. In a pleasant atmosphere 100 representatives from the marketing practice experienced exciting speeches and benefited from inspiring discussions as well as new stimuli around the theme of marketing.

Prof. Dr. Markus Rudolf, dean of WHU, warmly welcomed the representatives and provided a short overview of WHU, the competitive environment as well as the current strategy of the university, which is further developing positvely.

In his welcome speech at the beginning of the oneday conference, Professor Fassnacht outlined that the boundaries between different industries and competitors are increasingly shifted owing to the internet. This strengthens the customers' power through all phases

of the purchasing process. Immediate satisfaction of needs and an integrated shopping experience become more important. In this context the customers' smartphones is a strong "weapons". Many retailers incrementally implement omnichannel-strategies and the separation between online- and offline-channels is blurring. Relevance plays an important role in this context. Only if relevant, one can be recognized by customers and withstand the competitive pressure.

On that note, Prof. Dr. Fassnacht led over to the first speech held by Mr. Kussai El-Chichakli, Director Marketing at Coca-Cola Erfrischungsgetränke GmbH. Impressively, Mr. El-Chichakli pointed out how Coca-Cola successfully became relevant to a wide range of customers with its lines extensions Coke Light and Coke Zero. "A brand needs to pick up social topics and cause discussion", El-Chichakli explained. Mr. El-Chichakli illustrated with different commercial clips of Coke Zero how to implement this in practice. Coke Zero is addressed to a male target group, which also discovered the trend of a calorie-conscious nutrition. However, Coke Light is not relevant in this context, as it addresses a female target group. Coca-Cola solved this challenge through line extension - Coke Zero. The product was advertised in the German market by means of a known campaign with the testimonial Manuel Neuer and the topic football. Core of the commercial message is making the impossible possible. Referring to El-Chichakli, addressing the need of self-realisation is the "olympus of brand communication". A proof that this has been quite successful for Coke Zero are the several imitations of the TV-spot with Manuel Neuer.

Following, Roland Auschel, Chief Sales Officer and member of the board of adidas Group, outlined his ideas under the topic: "The digital shoemaker – transformation to an omni-channel leader". At the very beginning he presented the most important standard of adidas Group: "Give every consumer what he needs." Adidas especially focuses on the generation Z. This is a target group being regarded as "creators", which thus want to fulfil itself in a brand and are looking for individual design possibilities. As a result, digital topics, such as online communities, gain relevance. Adidas already picked this up by taking ideas from online communities into account when designing shoes. Nevertheless, customized products in real-time are a major challenge in the future referring to Mr. Auschel. The manufacturer, who will implement this as the first, will get a huge competitive advantage. After giving an overview of the diverse digital initiatives of adidas Group, Mr. Auschel outlined the most relevant themes for the (digital) future. Thereby, it is of utter importance to achieve an even stronger connection of all channels, to dissolve functional allocations, and to increase speed. "Digital transformation will never come to an end. Nobody will be able to escape this topic. Without digital strategies, companies in fast moving industries will not be viable", he concludes.

The following speaker Andre Alpar, founder of AKM3 GmbH, pointed out the foundations of search and content marketing in the online marketing mix. Referring to his thesis "pull is the new push", he firstly demonstrated interesting aspects of consumers' search behaviour in the internet. The search process is not as deterministic as many think. Most consumers have a need but do not have predefined criteria where and how to satisfy this need. This represents a huge opportunity for marketing. However, marketing has to be adapted to the search engine area with the background information that different types of searches take place at different points in time. For example, price search engines are not used until the customer knows exactly what he wants, which is why they are placed at the end of the search process. Two thirds of all quests are generic ones which take place before the customer has made a decision. With search and content marketing exactly these customers need to be attracted. Doing so, content marketing can raise new customer needs. By an elaborated offer of relevant topics for consumers, it serves as a pull strategy for customer acquisition.

After the lunch break Prof. Dr. Martin Fassnacht moderated an interactive panel discussion as in the previous year. At the beginning participants discussed vividly to what extent companies have a defined target group profile and are satisfied with this one. Representatives from different companies gave assessments referring to their companies and branches. All agreed that heterogeneous customer needs hamper a target group definition. Subsequently, the panellists discussed marketing organization in companies. At this point, the discussion focused on the question which portion of marketing's value creation can and should be outsourced. Regarding this question, the present representatives took different positions. Disadvantages of an in-house solution were seen in the fact that the exogenous input would miss, what bears the risk of just dealing with own ideas. A main downside in outsourcing was seen in the risk of being overrun and losing control. In this context, hybrid models could be beneficial. Third topic of the panel was the change from offline- to online sales. Thereby, the participants worked out that impulse buying is hard to realise online and distributors have to come up with new strategies in this regard. Stationary retailers, which are surrounded by an increasing number of online competitors, have to think about how to become more relevant. One opportunity could consist in the growing positioning of own brands. Finally, the topic customer journey was discussed. Modern technologies connect both worlds, online and offline. This means that transactions can be satisfied immediately when needs occur. An example for this is the Amazon dash button. In this context, companies have to ask themselves how present they are in their customers' everyday life and what needs to be done to be relevant in the moment the need occurs. Prof. Dr. Martin Fassnacht summed this inspiring panel up with the statement that life and thus questions and answers become more complex. Companies need to handle numerous different communication and sales channels and apply them correctly.

The next speaker, Ulrich Selzer, Global Sales Director of SEAT S.A., gave an insight about the relevance of

the brand SEAT, which could be massively increased over the past years. Fundamental for this success was the premise that every brand needs a home. SEAT was successful in emotionalizing its brand by relating its communication to its home Barcelona. Mr. Selzer illustrated essential success factors of brand relevance using the example of SEAT. The main focus is on the product. A car benefits from the fact that it is immediately emotionalizing and therefore relevant. Inevitable for relevance but difficult to implement is a consistent communication in all countries because customers in the automobile industry are not becoming more heterogeneous but rather homogeneous. SEAT focuses on an orientation along customer needs. Offering its customers higher price transparency through an own price comparison site contributes to higher customer satisfaction. In addition, employees have to be integrated as well in order to make a brand more relevant. Employees are the ones who create the product and sell it to the customer. Therefore, their impact should not be underestimated.

After a short coffee and communication break it was Dr. Frank Breitschwerdt's turn, CEO of CHECK24. The first speaker who did his doctor at the chair of Prof. Dr. Martin Fassnacht. The inspiring talk of Dr. Breitschwerdt was about "relevance in the marketing-mix in an online comparison portal". First, he presented the structures of CHECK24 to the audience. Every product, for example insurances or journeys, is controlled by an own team which works totally autonomous. Through many small entities, there is less need for coordination and decisions can be made faster. CHECK24 is not only competing with other comparison portals but also with insurance companies and Google. In this field of tension only the one with the best product will prevail in the long run. CHECK24 tries to differentiate from its competitors by contacting customers with relevant occasions and relevant points in time.

The last speech at this year's WHU-Campus for Marketing was given by Erik Friemuth, Group Chief Marketing Officer of TUI Group, who talked about "building a

powerbrand - same smile, so much more...". During his speech he outlined the process of harmonization of the brand TUI in the international market. TUI chose a risk averse approach. The rebranding started in one market, in this case the Dutch one. A crucial success factor for brand migration has been brand awareness because uniting many brands in one group entails the potential risk of becoming irrelevant for the end customer. TUI prevents this by building a unified brand image. One step to success hereby has been the emotional charge of the brand by means of social media. Furthermore, to the internal communication was paid particular attention. Mr. Friemuth emphasized that within brand migration employees often fear losing too much of the own identity. Therefore, a cultural change should not be executed too fast.

In his closing remarks, Prof. Dr. Martin Fassnacht summarized the basic ideas of the conference. He particularly claimed that the topic "Marketing: Relevance rocks!" is not only of enormous importance for companies but also for the marketing function itself. Marketing in the future has to sell itself better. Especially in comparison with other divisions, just by doing so, the own relevance can be build and strengthened. Taking into account the relevance of marketing for corporate success this is of particular importance. With the closing get together in a convivial atmosphere, the successful seventh WHU-Campus for Marketing came to an end.

Annual Board Meeting of CMM 2016

On June 22th the annual advisory board meeting of the Center of Market-Oriented Corporate Management (CMM) took place at WHU Campus Düsseldorf for the first time. The center acts as an exchange platform for science and practice focusing on market-oriented questions.

International Summer Courses for MBA & Bachelor 2016

As every year, Professor Fassnacht taught various lectures taking place in the context of the European Summer Institutes and other European Programs between March and June 2016. WHU and its international partner universities collaborate each year to organize those programs taking place in Vallendar for international Bachelor and MBA students. The political and economic environment in Europe and the impact on business relations in this region provide the thematic focus of the program. Professor Fassnacht's lecture "Luxury Brand Management – A European Phenomenon" sharpens students' knowledge in marketing by contrasting traditional versus luxury-specific marketing principles.

In March/April 2016, 10 MBA Students of the Tepper School of Business at Carnegie Mellon University visited WHU in Vallendar. During their lecture and casework in "Luxury Brand Management" the students deepened their knowledge about European luxury brands and their specific management. Additionally to the lecture at the WHU Campus, the students were able to have a company visit at Leica in the firm's headquarters in Wetzlar. Here they got insights into the management and marketing of luxury cameras and they received an introduction to the world of Leica. Moreover, the students enjoyed a guided tour through the Leica park and explored the firm's museum.

In May and June 2016, four further courses took place. 30 BSc MBA students from the Stephen M. Ross School of Business at the University of Michigan got to know the European business environment and learned about the specificities of luxury marketing in Professor Fassnacht's class. Furthermore, the participants went on a company visit to the Westerwald Brewery, where they learned about the marketing of luxury beer, got a tour of the brewery and enjoyed a beer sommelier tasting.

Also, 91 international MBA students of WHU's partner universities took part in the two-week WHU European MBA Summer Institute on "The Changing Environment for International Business in Europe". In both sessions students learned about luxury brand management and applied their knowledge in several mini case study sessions. Their theoretical knowledge was complemented by a company visit to Robert Weil vinery and to Brabus. Robert Weil serves as a symbol for the German Riesling culture and Brabus is one of the most renowned luxury automotive tuning companies, especially for Mercedes-Benz models.

The last program took place in May/June 2016 with 21 students of the European Bachelor Institute who participated in the two-week course "The Business, Political and Cultural Environment in Europe". After having heard the theory of Professor Fassnacht's "Luxury Brand Management" lecture, the participants also went to the Westerwald Brewery and enjoyed the same company visit as the students from the European Program.

Practical Cooperation with BMW



From April to October 2016, a team of research assistants and doctoral candidates consisting of M.Sc. Jonas Lechermeier as project leader, M.Sc. Dominic Bergers and M.Sc. Jonas

Schütz, conducted a cooperation project with the German car manufacturer BMW on the subject "Price management in the online channel". The overall aim of this scientific consultation was to apply the theoretical pricing knowledge that the chair of Prof. Dr. Martin Fassnacht is known for on the practical challenges of OEMs related to their online sales. During the processing time of the project the team had a variety of regular meetings with the representatives of BMW. This allowed them not only to develop a suitable solution for BMW, but also to gain deeper insights into the company. A visit of the BMW headquarters, the BMW World and the production plant in Munich deepened these insights.

Overall, as the project was a complete success for both parties a subsequent and profound cooperation with BMW is planned for next year.



Everything that a successful player does is investigated by competitors. Thus, competitors try to match price decreases of Aldi. [...]. In general, manufacturers want to graw. Aldi Süd and Nord have about 4.000 stores. It is highly attractive to work with such a player for manufacturers."

Aldi Süd: new look – new prices?

"Customers are more demanding. The competitors of Aldi invested a lot into the store design. Aldi needs to follow in order to satisfy customer demands. [...]. Regarding the new store concept of Aldi, it shows that Aldi approaches supermarkets, however, not too strong in order to still appear as a discounter from a customer perspective. [...]. As Aldi started to increasingly list new brands a highly intensive price battle incurred. Any player undercut its competitors. As a result, consumers benefited at the expense of the gross margin of retailers."
