Preface of the Chairholder

2013 was a special year for me – I celebrated my **10th anniversary** as chairholder at the WHU. More than **60** publications in journals and books, **15** successfully finalized dissertation projects, **1** successfully finalized habilitation project, **14** current dissertation projects, a couple of scientific awards, over **140** supervised bachelor's and master's theses, around **70** given courses in Bachelor-, Master-, various MBA- and (former) Diploma-Programs, around **100** hosted guest lectures and real-life cases and **30** speeches and lectures for practitioners. This is – the way I see it – a great list of achievements of 10 years "Otto Beisheim Endowed Chair of Marketing and Commerce" at WHU. For sure, these are many reasons to celebrate and thank all the people involved in this great success. I am really proud to see the results of the last ten years and at the same time to know that there is still a lot to come in future.

This activity report reflects the university year 2012/2013. The three pillars my chair grounds on – **Research**, **Teaching**, **Practice & Theory Transfer** – have been pursued in a straightforward manner.

Research has been marked by an increased number of publications in national and international peer-reviewed journals. The attendance of the EMAC in Istanbul was one of this year's highlights. The Price Management book by Professor Simon and me was published as an Italian version and an English special edition of the book is planned. I am especially proud to be the current chairperson of the "VHB – Wissenschaftliche Kommission Marketing" and am looking forward hosting the Comissions-Conference in January 2014 at the WHU-Campus in Vallendar.

Teaching in 2012/2013 comprised 12 courses in the Bachelor-Program and diverse MBA-Programs, all evaluated very positively by the students. Luxury Brand Management has been established as part of the Kellogg-WHU Executive MBA-Program with great success: due to the high number of participants, the course has been taught twice this year. I also had the chance to teach the course "Luxury Brand Management" at the HEC Lausanne. Due to the positive feedback, this course will be continued next year. A great part of my teaching concept is to connect students and practitioners: numerous guest lectures and real-life cases enriched the theory taught in these courses. My students as well as myself appreciated the opportunity to learn from experts.

In the context of a **Practice & Theory Transfer**, we have been interlinking theory and practice. This is done by transferring and applying our theoretical knowledge to recent practical problems by giving interviews, writing press comments and articles, acting as jury member or by giving speeches and lectures especially for practitioners. One major event in this context is also our annual marketing conference "WHU-Campus for Marketing". The conference in September 2013 was a great success with several high-profile speakers and around 120 participants representing the consumer goods industry, retailing and the service sector. I would like to invite you to save the date for the 5th WHU-Campus for Marketing on June 26, 2014.

Unfortunately, the last year did not only have positive peaks. I was deeply sorry to hear about the death of my chair's patron Professor e. Dr. h.c. mult. Otto Beisheim (January 3,1924 – February 18, 2013). Without his interest and dedication to achieve highest levels of teaching and research my chair would not exist in the way it does today.

04 Furthermore, the unexpected death of Professor Dr. Dr. h.c. Dr. h.c. Erich Greipl (September 2, 1940 – July 2, 2013), the Chairman of the WHU Foundation, meant a great loss both for WHU and for me personally. We as chair and as part of the university will aim to continue their work and live up to their vision.

In this context I would like to cordially thank my assistant Stephanie Krause and all of my doctoral students. A chairholder is only as good as the team surrounding him. The next year will be marked by a great change within my team: five new doctoral students will join my team. I am looking forward to the new impulses they provide and the next projects such as new research topics, the English special edition of the price management book and many more.

On the following pages, I am happy to share an overview of activities and achievements during the last year with you. We as chair will pursue our strategy in the year to come – I already have a lot in mind and I am looking forward to it.

I hope that you will enjoy reading this year's activity report.

Research Focus - Price Management



Dipl.-Kffr./MBA Evelyn Friedel

Dissertation Project: Price Elasticity – Research on Magnitude and Determinants

Price management has a high importance within the marketing field. The price response function and the price elasticity are the essential elements of pricing. The price elasticity indicates how sensitively consumers react to price changes. Price is a fundamental profit-driver. It is by far the most sensitive profit lever that managers can influence. Very small price changes translate into enormous changes in profit.

Not only the knowledge about the magnitude of the price elasticity but also the knowledge about the determinants influencing the price reaction is essential. It is fundamental for the development of a successful marketing strategy to understand how price elasticities vary with market and product characteristics. A better understanding of the price elasticity concept could enhance managerial decision making.

The aim of the research is to enhance the knowledge about customers' price reactions and thus to yield critical information for designing professional pricing strategies. Reflecting the academic and managerial need, the objective of this research is to gain a more comprehensive understanding in two main areas, the magnitude of price elasticity and the determinants of price elasticity.

- The first objective is to expand the knowledge on the magnitude of price elasticity.
- The second objective is to expand the knowledge on determinants of price elasticity.

Given the relevance of this topic and addressing the research gaps identified, the knowledge expansion is aimed for in the following ways. Two data sources

are examined: academic publications and consulting project data. New data sources, such as survey data, are utilized to enhance the understanding of price elasticities. Compared to previous research, price elasticities are explored in further detail, and a broader range of products and industry settings are covered. In addition, the focus is on regular prices and long-term price changes, which addresses another research gap as current price elasticity research is primarily based on promotional price changes and short-term effects. Concerning determinants of price elasticity, new variables are assessed regarding their influence on price elasticity.



Dipl.-Kffr. Eva Köttschau

Dissertation Project: Price Increases at the Point-of-Sale

Of all marketing tools only the price has a direct effect on a company's profits. Already small price changes can have a dramatic impact on the profitability of a retailer. Retailers are regularly confronted with the necessity to change the prices of their products. In some situations price increases are unavoidable for instance when firms face increased costs, competitors' pressure or the need to increase revenues. However, this strategic move can lead to negative consumer reactions. A price increase is only successful if it is accepted by the consumer and leads to higher profits in the longterm. Although price changes, especially price increases, are of enormous relevance for researchers and managers, the topic of price increases is rarely addressed in marketing literature. The aim of this dissertation is to examine consumers' reactions to price increases and identify under which conditions price increases can be implemented most successfully at the point of sale.



Dipl.-Kffr. Stefanie Wriedt

Dissertation project: Essays on Price Tiers

Price tiers, quality tiers, brand tiers, any tiers!? Tiering is known in many industries such as airline ticketing with usually first, business, and economy class or hotels with different room categories like superior room, deluxe room and suite. Researchers use price, quality and even brand tier interchangeably. In this research we concentrate on price tiers and define a price tier as the grouping of prices within a market (Murphy/ Dawes 2004), or more specific the price points standing in a competitive context to each other. Sethuraman, Srinivasan, and Kim (1999) have found strong evidence that brands compete more closely with other similarly priced brands, compared to those further apart in price. For this research, associated brands and quality are just secondary of interest. For simplicity reasons, price tiers are often divided into two to six segments, called such as cheap/expensive or low/medium/high.

Paper 1 gives a comprehensive review of the literature on price tier research and related concepts and theories. Paper 2 and 3 evaluate the competitive context within (intra-tier) and between (inter-tier) different price tiers, especially in regards to the price tier presentation in retailing. After conducting interviews with retailers and consumer studies; the next step will be to develop experiments to evaluate whether consumer change their buying behavior due to an adapted price tier system and presentation.



Dipl.-Kfm. Sebastian Unterhuber

Dissertation Project: Channel-based Price Differentiation

The growing popularity of the internet as a shopping channel for consumers initiated many traditional brickand-mortar retailers to expand their businesses through online shops and turn themselves into multi-channel retailers which offer their consumers the opportunity to buy products online or offline. Because online and conventional retail channels differ in various aspects, such as convenience, risk or service level, consumers develop heterogeneous channel preferences which lead to different channel evaluations and price sensitivities. Differences in consumer perception of channel performance and heterogeneous willingness-to-pay can offer multi-channel retailers the opportunity to engage in channel-based price differentiation and charge different prices across channels for the same product. Although potential to increase profit through channelbased price differentiation is recognized, there is little evidence of its occurrence in reality and managers of multi-channel companies often argue for channel price integrity in order to avoid customer irritation. The aim of this dissertation project is to explore whether and under which circumstances consumers accept price differentiation across online and offline channels and how multi-channel companies can successfully engage in channel-based price differentiation.

Research Focus – Retail Marketing



Dipl.-Kfm. Jerome Alexander Königsfeld

Dissertation Project: Essays on the Effectiveness of Advertising and Promotions

The investments of companies in advertising and promotion have significantly increased over the last years. Against the backdrop of the increased investments in these popular communication instruments, a controversy in research and managerial practice has started, whether companies are earning an adequate return on investment on their communication initiatives. As a result an increased demand for marketing accountability has evolved, requiring marketing managers to more effectively allocate their marketing expenditures.

The impact of price promotion and advertising on sales and profit is influenced by multiple determinants. Taking these determinants (e.g., brand characteristics, store characteristics and advertising medium) into consideration is crucial to be able to accurately predict consumer response to the advertisement or promotion and hence be able to anticipate whether a particular promotion or advertising will be financially attractive to the company.

The dissertation project aims to contribute to the literature by providing new insights on determinants of advertising and promotion effectiveness. On the basis of a review of prior literature conceptual models for analyzing determinants of advertising and promotion effectiveness will be developed. Hypotheses will be tested on the basis of two comprehensive datasets collected in cooperation with a market research company and a globally leading car manufacturer.



Dipl.-Kfm. Jürgen Pannek

Dissertation Project: Customer-oriented Assortment Management for Brick & Mortar Stores – A Behavioural Analysis of the Effects of Selection and Point of Purchase Communication

With globalization, the variety of goods has increased significantly and therefore the purchase options for consumers. Because consumer purchase power has not followed the development, demand keeps with exceptions constant and has only reallocated according to the preferences on more products (substitutes). The on-going trend is a challenge especially for stores with a full-range strategy. These stores have more and more difficulties to redeem their "one-stop-shopping" promise. They have been successful as long as the diversity of the offer was less differentiated. In the past, department stores have often displaced small retailers from the inner cities. Today they are cannibalized itself by "Category killers" in the city outskirts. Due to their specialized offer "Category killers" are much more able to meet differentiated customer needs. The perceived lack of competence of department stores is further enhanced by, for example, professional product lines that are offered exclusively through selected distribution channels. In particular, non-food department stores have recently attracted attention by aggressive pricing and promotional activities than through differentiated and customer-oriented offerings. With this practice, short-term market share has been increased. But longterm this strategy was not sustainable because sales were purchased with cherry pickers and loyal customer base has not been increased. Currently, the dilemma is intensifying by the Internet and the increasing popularity of mail order. Online shops are able to offer a wide range of variety at reasonable prices (due to cost advantages compared to brick & mortar stores). Today they offer a lot of additional product information, customer reviews and there is no limit by opening times. To compensate for the structural disadvantages, brick & mortar stores need to focus on their core competencies and advantages for customers. Due to the decreasing delivery times, product availability loses its relevance. Retailer must therefore pay close attention to customers, offering target group-oriented product ranges and improve customer service. The main challenge seems to be to identify alternatives or additions to the labour-intensive (one of the biggest cost drivers) customer service.

The primary goal of the dissertation is to determine the effect of the little discussed factor information (focussing on silent consultants) on the purchase decision and the assortment evaluation. For this purpose, new insights into the search behaviour of customers in front of the shelf as well as into the assortment perception are gained. Experiments are conducted to reveal the relationship between the two factors: selection and point of purchase communication. The insights gained are intended to enable retail managers to plan and present their assortments customer-oriented and sustainably increase sales.



Toni Schmidt, M.A. HSG

Dissertation Project: Shopper behavior at the Point of Purchase (POP) – essays on the role of in-store and out-ofstore factors in decision-making and on the determinants of choice satisfaction in a highinvolvement product context

Interest from researchers and practitioners in the POP is high because many purchase decisions happen in the store. The dissertation contributes to the growing stream of POP research with several essays that have their empirical foundation in an eye-tracking field experiment and analyze various aspects of in-store attention and decision-making. In addition to contributing to a relevant research stream, the dissertation also strives to derive helpful, actionable insights for practitioners, mainly of visual marketing, at retailers and manufacturers.

The research project focuses on two main issues: (1) The drivers of attention and evaluation at the POP, hereby covering the early and central parts of in-store decision-making that take place while the shopper is at the POP; and (2) the determinants of choice satisfaction, thus including a later, almost ex-post stage of the decision-making process. The following two paragraphs provide a short overview on both issues.

Regarding issue (1): Despite the relevance of the topic for researchers and practitioners alike, attention patterns in decision-making processes at the POP concerning high-involvement products are still little understood. The dissertation project seeks to contribute to a better understanding of what drives attention to and evaluation of high-involvement products at the POP. Our research includes several independent variables from both classes of potential determining factors: instore factors (e.g., the products' placement on the shelf, number of offered products), and out-of-store factors (e.g., favorite brand, market share of brand). In addition to the direct link of these factors to attention and evaluation, we also research potential mediated effects by attention on evaluation of in-store and out-of-store factors as well as interaction and moderation effects.

Regarding issue (2): This research effort investigates a set of potential determinants of satisfaction with a high involvement product choice to find out what can lead to a satisfactory choice. One goal is to find out whether different degrees of attention at the POP have an influence on choice satisfaction. The other goal is to research the role of individual factors (e.g., perceived search costs, anticipated regret) and factors of the choice set (e.g., assortment size, assortment attractiveness) in determining shopper choice satisfaction.



Dipl.-Kffr. Eva Schuckmann

Dissertation Project: Shopping Enjoyment

Increasingly intensifying competition but also a progressive development towards changing and demanding consumer types transform the conditions of the retail business and hamper the possibilities of creating a unique selling proposition. Market saturation tendencies lead to increased dynamics of retail business models, thereby changing their relevance in the market. Thus, business activities in terms of assortment, store design and service offerings gain in importance. Focusing on pricing activities only often is not sufficient to obtain a unique selling position in the market. Consumers who are increasingly pursuing other than utilitarian shopping interests expect the satisfaction of significant hedonistic motives when purchasing or shopping. Changed socio-demographic characteristics of the "new consumer" contribute to the need to create a stimulating environment triggering emotional stimuli and increasing the lifetime quality while shopping. Customers make high demands on the design of customer-oriented marketing tools when they're up to store decision as well as buying transactions. The aim of this dissertation project is the development of the determinants and thus options for retailers to enhance the perceived level of shopping enjoyment. In addition, moderating effects are to be measured using an appropriate model on these interrelationships and effects on both observable and non-observable customer behavior.

Research Focus – Luxury Brand Management

Of focal interest to the research at our chair is identifying the specificities of marketing luxury as opposed to nonluxury brands. Traditional marketing principles do not equally apply to luxury brands. Rather than driving sales at any price, marketing luxury goods requires specific principles to enhance and preserve the image of finest quality, exclusiveness, and hedonic value.



Philipp Nikolaus Kluge, M.Sc. CEMS

Dissertation Project: Specificities of Marketing Luxury Brands

Marketing luxury brands aims at evoking perceptions of scarcity. Scarcity, i.e. a shortage in supply, enhances a brand's desirability. Evoking and preserving consumer perceived scarcity entails using rare materials crafted by few, superbly skilled workers, limiting production capacity, setting high-end prices and selling through a limited number of selected point of sales. In other words, luxury stratifies the society and sets the upperclass apart from the mass.

This fundamental function of luxury has been challenged by the emergence of the internet. The digital mass medium is associated with low prices and worldwide availability rather than a selective distribution of scarce goods that are reserved for the happy few. Kapferer and Bastien call this inconcsistency the "Internet dilemma" for luxury brands. Using expert interviews, field studies and experiments the proposed dissertation project investigates how luxury brands may preserve their perceptions of scarcity in the digital space.

Research Focus – Brand Management and Social Media



Dipl.-Kffr. Daniela Götz

Dissertation Project: Vertical Extension of Brands

Brands are one of the most valuable assets of a company. Therefore, it is appealing for managers to leverage the value of existing brands. Managers can do so in various ways, but never without the risk to dilute the existing brand equity. Hence, it is highly important to protect the existing parent brand. That's why the presented dissertation project investigates on the basis of a broad literature analysis, social science theories and experimental studies: (1) the effect of extension direction, extension degree, and brand concept on parent brand evaluation after introducing new products in the same product category of higher or lower price and quality levels, (2) the impact of subbrand name choice on parent brand equity, and (3) strategies of how to move up a whole brand portfolio in terms of price and quality levels.



Dipl.-Kffr. Carina Simon

Dissertation Project: Essays on Online Brand Communities

The Web 2.0 and the steadily growing number of social media have changed dramatically consumers' communication and information behavior. The almost unlimited access to information and the rise of new online communication tools have empowered consumers such that they desire and demand an increasingly more active role in the exchange relationship to companies and their brands. In this new environment, social networking sites such as Facebook have been established as particularly influential online platforms. Companies use Facebook to build online brand communities in the form of brand pages.

Brand pages offer a valuable platform for consumercompany/brand as well as consumer-consumer value creation. Online brand communities on brand pages support the brand in creating and fostering relationships to potential and existing consumers. Brands are able to communicate with their consumers one-on-one, spread information on the brand and its products, and skim invaluable consumer knowledge. At the same time, consumers are actively integrated in brand development. The community character of Facebook brand pages allows consumers to connect to others who share the same interest and favors for the brand, and to actively contribute to the brand's evolution. Both among practitioners and academicians, online brand communities on brand pages are viewed a fruitful vehicle to create brand awareness, strengthen relationships, and sustain and increase brand loyalty.

Albeit many companies possess a Facebook presence, a major part struggles in building an active and vivid online brand community. Thus, many discussions about brand pages center on consumer engagement that is consumers' active participation in online brand communities on brand pages. Marketers are searching for answers to how to engage and influence consumers on their brand page. The present research project deals with this question and focuses on consumer engagement with Facebook brand pages. A series of studies analyses which factors influence consumer engagement with online brand communities on brand pages, and how consumer engagement impacts consumer behavior and attitude toward the brand. The basis for this dissertation project is a consumer survey of brand 'fans' on Facebook.

Research Activities of the Chair Members

16th Doctoral Colloquium with Simon-Kucher & Partners

Strategy & Marketing Consultants Nikolaus Klug

Nikolaus Kluge was invited to participate

in the 16th Doctoral Colloquium with Simon-Kucher & Partners (SKP) on September 3 and 4, 2012 in Bonn, Germany.

Ten doctoral students were selected to present and discuss their dissertation projects in the field of marketing with the founder and chairman of SKP Prof. Dr. Dr. h.c. mult. Hermann Simon, the two CEOs of SKP Dr. Klaus Hilleke and Dr. Georg Tacke, a Partner of SKP Dr. Georg Wübker as well as two consultants Dr. Sina Henningsen and Dr. Nils Wagner.

Philipp Nikolaus Kluge gave a presentation on the research project "Pricing Luxury Brands: Specificities, Conceptualization, and Performance Impact" which he co-authored together with Professor Martin Fassnacht and Dr. Henning Mohr. First, the authors contrast traditional versus luxury-specific pricing procedures based on the four integral parts of the pricing process framework: strategic direction, analysis, decision, and implementation. Second, they conceptualize the luxury pricing process and empirically test its performance impact based on unique survey data among managers of 114 European luxury brands. The project was accepted for publication by the Marketing ZFP – Journal of Research and Management in June 2013.

The two-day research colloquium was a valuable opportunity for networking with other doctoral students as well as to get in contact with SKP as consultancy which uniquely combines scientific approaches and specialized expertise in strategy and marketing.

International Summer Courses for MBA & Bachelor

Each year, from March to June 2013, Professor Fassnacht teaches various lectures taking place in the context of European Summer Institutes and other European Programs. WHU organizes in collaboration with its international partner universities those programs taking place in Vallendar for their Bachelor and MBA students. The political and economic environment in Europe and the impact on business relations in this region provide the thematic focus of those programs. Professor Fassnachts lecture "Luxury Brand Management – A European Phenomenon" sharpens students' knowledge in marketing by contrasting traditional versus luxury-specific marketing principles.

In March 2013, 35 MBA students of Tepper School of Business at Carnegie Mellon University visited WHU. During two days lecturing session and two mini case studies the students deepened their knowledge about European luxury brands and luxury brand management.

In May 2013, three further courses took place.

35 Bachelor students of the Stephen M. Ross School of Business at University of Michigan got to know the European business environment and attended Professor Fassnacht's course.

The WHU European MBA Summer Institute in Vallendar also offered two sessions of a two-week course on "The Changing Environment for International Business in Europe" for about 90 MBA students of WHU's partner universities.

Both sessions learnt about Luxury Brand Management and applied their knowledge successfully in mini case studies. This theoretical knowledge was complemented by a fascinating company visit of the two prestigious Kempinski hotels located in Königstein-Falkenstein, Taunus, close to Frankfurt am Main. First stop was the Falkenstein Grand Kempinski, a 5-star superior hotel with historical background, therefore combining tradition with first class service. Second stop was the Villa Rothschild Kempinski, Kempinski's smallest hotel with only 22 rooms. The charming boutique hotel is housed in a building with a remarkably rich tradition and students were impressed to learn about its historic meaning.

At the end, Lars Leyendecker – Director of PR & Marketing – gave an inspiring presentation about Kempinski's philosophy and interpretation of luxury.

The last program took place in June 2013, the European Bachelor Summer Institute – a two-week course on "The Business, Political and Cultural Environment in Europe" for undergraduate students of WHU's international partner universities. After having heard the theory of Luxury Brand Management, the 26 students went on a company visit to the Westerwald Brewery learning about their luxury beer strategy and enjoying a beer sommelier tasting.
