1 Preface

2 Teaching







2.1 Courses, Fall Term 2011

Bachelor of Science

Microeconomics II

The course built on the course "Microeconomics I" and presents detailed studies on different basic topics in microeconomics that are important for business students. The course is lectured in two groups. The topics covered are general equilibrium analysis, oligopoly theory, game theory, issues of asymmetric information---e.g., moral hazard and adverse selection---and the economics of externalities and public goods.

2.2 Courses, Spring Term 2012

Master of Science

Strategic Competition

This course is the only mandatory course in the Master of Science Programme. It covers a broad range of topics on competition and pricing tools that familiarizes business students with how competition in the market emerges and plays out and what are tools for firms to increase their profits. The detailed topics covered in the course are product differentiation, both horizontal and vertical, network effects, collusion, and bundling, all associated with case studies. In addition, the course contained a presentation by a representative of E.ON. on smart networks. 2 SWS – 3.0 ECTS
