


#### Ass.-Prof. Dr. Carolin Decker | Assistant Professor

#### **Bachelor of Science**

#### Business game Prof. Dr. Andreas Hack

The participants learn to put into practice and enrich their knowledge in strategic and operational management. To this end, a market situation will be simulatetd with various companies which compete with one another. The companies make decisions in the areas of procedurement, production, distribution and finance over several periods.

#### Distinct questions of family firms Prof. Dr. Sabine Rau

Family firms are prevalent around the world. In Germany they represent more than 50% of GDP and workforce. Family influence makes a firm special therefore to manage a family firm or work with it as a supplier, banker or consultant is different. In this course, we will explore these differences by looking at the family firm from a systemic point of view. The subsystems of family, ownership, leadership and the business itself will be in our scope of work. Related theories as well as practical implications will be discussed.

#### Management abroad course Dubaí Ass.-Prof. Dr. Carolin Decker

The Management Abroad Course Dubai combines elements of a seminar on international business with personal experiences with and insights into life and work in the United Arab Emirates. In addition to presentations held by company representatives and lectures provided by local professors, the course places students' personal insights into the different national and cultural environment center stage. Moreover, a day trip to Abu Dhabi will be offered. The course starts in Vallendar with an intense preparatory course on economic, political and cultural issues pertaining to Dubai.

#### Master of Science

#### Managing the family business

#### Prof. Dr. Peter May

The Students acquire in-depth knowledge concerning major concepts and instruments needed for the successful management of family businesses (discipline-specific knowledge and competence) and will learn how to analyze family and firm structures to develop a sound corporate and family governance (management-specific skills). They learn about the complexities of managing the family firm and the owner family (global business environment) and the classes will be very interactive. Students have to solve case studies and are provided with numerous practical examples (Teamwork and responsible leadership). We teach critical thinking and problem solving skills. The Students have to analyze complex situations and consequently develop recommendations and will learn to recognize and deal with the advantages and challenges of family firms with the help of examples and case studies (managerial and entrepreneurial practice).

#### Institutions in contemporary society with special focus on family firms Prof. Dr. Sabine Rau

Society is guided by major institutions such as the family, democracy, bureaucrazy, free markets, and religion alike. Issues like isomorphism, institutional ent-repreneurship, legitimacy, resistance, and change will be integrated in a specific institutional approach to family firms.

#### Case studies in family businesses Prof. Dr. Andreas Hack

By developing case studies in cooperation with large German family enterprises, students will gain insights into the application of economic and managerial models and principles in the context of the entrepreneurial everyday life. An emphasis will be placed on corporate governance aspects. Students learn how to collect data and how to filter and analyze key information in a complex managerial context.

#### Cooperative stategies and networks Ass.-Prof. Dr. Carolin Decker

In this seminar, we focus on topics pertaining to all stages of the alliance management process. We start with issues related to the alliance formation stage, such as partner search and selection, and continue with alliance governance and design, such as contract design choices and formal and relational mechanisms for the coodination of collaborative interfirm relationships. Popics referring to the postformation alliance stage are then, e.g. interfirm knowledge transfer and alliance evolution. A critical issue in alliance management research ist the measurement of the performance outcomes of interfirm partnerships. So, concerning alliance termination, we discuss issues alluding to alliance success and failure.

Students will learn to critically analyze and discuss a selected issue in the field of inter-organizational relations, in general, and the management of alliances and networks, in particular. Thereby, all issues associated with cooperative strategies and networks will be discussed with special reference to transaction cost economics and a network perspective on inter-organizational relationships.

#### Survey methods II Ass.-Prof. Dr. Carolin Decker

In this seminar, we focus on topics pertaining to a specific component of overall survey research, namely methods for data collection. The impact of data collection techniques on data quality and survey costs will be reviewed. In particular, this course reviews the literature on survey design decisions and data quality in order to sensitize students to alternative data collection methods and their impact on the data obtained from surveys and subsequent data analysis. Group exercises and assignments are used to help students to make appropriate design decisions for data collection.

The objective of this seminar is to provide students with the skills to design, conduct and publish excellent survey research, i.e., research in which high-quality data are used based on a carefully selected sample of individuals or businesses by means of appropriate data sources and methods for data collection. More precisely, alternative sources and methods for data collection will be presented. Thus, the course refers to different types of data (primary, secondary, cross-sectional, longitudinal) and sources for data collection (e.g., knowledgeable individuals, public databases) as well as various approaches including, e.g., interview techniques, observations, and standardized questionnaires. We will discuss biases that can occur, such as measurement error, nonresponse bias, common method bias, and social desirability bias, and potential remedies. Moreover, we will examine data collection issues alluding to longitudinal surveys and discuss the collection of panel data.

#### Mechanics of Writing Prof. James Combs Ph.D.

Mechanics of Writing was a series of lectures that guided students through every stage of the process of writing for scholarly publications in business. Students learned to identify a theoretical contribution and different ways to make a theoretical contribution. Each section of an empirical scholarly publication was examined for its content and structure, including the abstract, introduction, literature review, hypotheses development, method, results, and discussion. With each section, students learned about what content of that section, how it should be organized, and what the writer needs to acomplish. Finally, time was spent discussing best reviewing practices and best practices for responding to reviewers in the revision process.

## The Elephant in the Room and the Allocation of Named Professorships in Management: Revisiting the Glass Ceiling in a Non-Corporate Setting

#### Prof. David Balkin Ph.D.

Using the glass ceiling metaphor, we examine the differential allocation by gender of endowed chairs to faculty in management departments of Tier 1 U.S. research universities. We form hypotheses that allow us to distinguish between competing explanations for the glass ceiling, namely the information deficiency view with its emphasis on bounded rationality and the social processes approach, with its emphasis on social biases. The results support the social biases explanation: Female faculty face a lower probability of holding a named professorship than male faculty after controlling for unambiguous performance data and other factors. The adverse gender effect for women is stronger for internal candidates than for external candidates. Evidence of willingness to move to accept a named professorship more positively affects a female faculty's probability of attaining a named professorship compared to a male. We discuss the practical implications and directions for future research.

#### Valuation of Family Firms | Ahlers / Hack / Kellermanns

These days, succession of family firms within the family becomes increasingly challenging. As a result, the sale of the family firm as an alternative succession solution increases in importance. During the complex sale process, the family values and objectives often stand in sharp contrast to those of financial investors who would be willing to acquire the firm. The research project investigates specifics of the sale process. The different stages of the sale process which will be investigated are (1) valuation of family firms, (2) negotiations between buying and selling side, and (3) elements of due diligence that precedes negotiations.

#### Innovations in small and medium-sized family firms and the influence of family-induced TMT diversity | Kraiczy / Hack

Small and medium-sized firms are a prevalent organizational form in Germany. Their importance for the German economy is indisputable. Most of them are global market leaders in their niches and are considered to be a force for innovation in the German economy. The ability to be innovative in niche markets has been identified as the antecedent of their strong, or even dominant, competitive positions in their industries. These firms are also well known by the term "Hidden Champions," which describes successful German small and mediumsized enterprises, 70 percent of which are family firms. The driver of this innovation success may well be the family, which distinguishes family firms from non-family firms. But how can a family influence innovation in a family firm and does this influence have only positive effects? The dissertation project tries to answer this question by focusing on the impact of top management teams (TMTs) on innovations interacting with family firmspecific TMT diversity.

## Family firms' ability to attract new talent: who is attracted and under what conditions? I Hack / Hauswald / Kellermanns

It is now widely recognized that for all organizations attracting job seekers is a key human resource practice that significantly affects organizational performance (Turban & Cable, 2003). Based on the person-organization fit literature, we know that job seekers' decision making is influenced by organizational image perceptions which are formed by any messages and information that the organization sends to applicants during the recruitment phase (Cable & Yu, 2006). In the case of family firms, HR professionals often face uncertainty of whether to openly communicate their level of family influence to job seekers, as it may impact job seekers' image beliefs (Micelotta & Raynard, 2011). Surprisingly, little is known about the relationship of portraying an organization as a family firm and job seekers' decision making. We want to take a first step in addressing this gap by investigating the influence of job seekers' perceived family influence on job seekers' long-term commitment. To reflect the heterogeneity in job seekers' decision making role of job seeker's individual needs in different economic environments (hostile vs. benign) and job seeker's personal values. We test our hypothesis through a conjoint experiment that examines how individual needs in different economic environments (hostile vs. be-nign) and personal values influence and job seekers' perceived family influence and job seekers' ers' long-term commitment.

Family Offices: an in-depth conceptual and qualitiative study of a secretive organization I Wessel/ Decker/ Hack (Universität Bern)/ Lange (Surrey School of Management, UK)

Entrepreneurs disengage themselves progressively from the classic concept of transferring the entire family business to the next generation and instead explore alternative succession routes. In this context, the family may elect someone to establish a family office to manage and coordinate the family wealth and perpetuate the family legacy. In the context of three studies, I first aim to develop a framework specifying different family office types. Drawing on case evidence, I will elucidate the goals that families behind these family office structures pursue and the differential reliance of control mechanisms to ensure achievement of these goals. Third, I will examine the causes and effects of conflict contingent on different FO structures.

Succession in Family Businesses Revisited: Current Knowledge and Future Directions I Heinrichs / Rau / Decker

We systematically analyze conceptual and empirical studies addressing succession in family businesses that have been published since Handler's (1994) seminal literature review. Our findings are structured according to five stages, namely preparation, the choice of a successor, exploration and implementation, the incumbent owner-manager's withdrawal, and the post-succession stage. We further consider six possible levels of analysis. Our review shows that research lacks an overarching theory that succeeds in addressing all stages and levels of analysis. The article concludes by identifying salient gaps and suggesting promising avenues for future research with a special emphasis on the owner family's impact on succession.

#### The Paradox of the Schizophrenic Organization | Rau

In this paper, I put forward the concept of co-existing logics *within* a single organization over a longer period of time where the contest of logics is deliberately used by the upper echelon of the organization to outperform competitors which follow a single logic. By that, the noxious co-existence of logics within the organization leads to a competitive advantage which is labeled the paradox of the schizophrenic organization. Illustrating the schizophrenic organization in higher education helps to better understand why the co-existing logics within one organization pose a major problem for this organization's legitimacy as well as for the employed mechanisms. A research agenda to further investigate schizophrenic organizations and their effects on the field, on employees, as well as on customers is proposed.

Conflicting family and market logics are considered to be at the core of succession problems in family firms. Based on 37 interviews in 21 German wineries, we find four different ways business-owning families draw on family and market logics and that a particular way often changed from the last to the current succession. Not only the particular way in which families draw on family and market logics appears to be related to succession problems but also changes to that way. We suggest that societal changes to the functions of families may help explain why many family firms have changed their succession approach. Societal changes might also explain why family goals influence succession approaches in family firms less often nowadays even though this is associated with more succession problems.

#### Contextualizing Organizational Boundary Decisions: Management Consulting in Family Businesses | Rau / Hanisch

In this project, David Hanisch and Sabine Klein develop a boundary decision model taking a capability perspective based on resource-based view of a decision to use management consultants in a multi-dimensional organizational context of family businesses. We empirically test this research model using a metric conjoint analysis experiment based on a data set of 1,760 decisions of top managers in large German family businesses. Results indicate that organizational context influences boundary decisions: Family businesses depending on level of family influence, generation of family involved, and degree of business complexity place different emphasis on decision-attributes used. However, influence of context is specific on context variable used and decision-attribute under research. Implications for theory are discussed.

#### Family Values and their Impact on Family Business Peformance I Rau / Siebke

Research identifies the particular role of family values in order to explain why family firms behave differently than non-family firms. Shared values among family members and the family's involvement in the firm can reduce agency costs, thereby enhancing the firm's performance. As such, this dissertation puts forward a theoretical framework examining the family as both an institution transmitting values to its members and as itself subject to normative influences. I propose that each family's response to such influences can be different, resulting in family specific values that are a salient feature of a family's distinct identity. As the family and the business are closely connected, distinct family values influence the importance put on different performance measures, thereby affecting organizational decision-making and identity. The degree to which this interwoven family business identity stays consistent over time depends on the transgenerational stability of each family's value system. Thus, family firms are not only different from non-family firms, but also differ from each other. This dissertation demonstrates that the family, in particular the family specific value system, does have a significant impact on the overall family firm's performance, thereby considering the heterogeneity among family firms.

#### Successor Legitimacy in Family Firms | Rau / Rettenmeier

This dissertation project examines whether the resource allocation decision of important audiences depends on the legitimacy assigned to the successor. Combining Signaling Theory with research on legitimacy we treat legitimacy as a multidimensional construct and propose five dimensions of successor legitimacy – *normative* (based on norms and values), *regulative* (based on existing laws and regulations), *pragmatic* (based on personal abilities, experience and network ties), *cognitive* (based on taken-for-grantedness) and *relational* (based on the quality of interpersonal relationships). We model the influences of each of these dimensions on the resource allocation decision of important stakeholders and argue that successor characteristics provide signals about the quality of potential future business relationships. One of the main tasks of this dissertation project is to develop a measurement instrument to capture legitimacy on an individual level.

#### IPO financing of family firms | Rau / Leitterstorf

Although research on family firms has grown significantly in recent years, IPOs of family firms have rarely been explored. This is remarkable given an increasing number of family firms actively considering an IPO. Several questions arise concerning IPOs of family firms:

- What are currently existing theoretical and empirical findings concerning family firm IPOs?
- How can family firms decide whether to conduct an IPO or not?
- How does an IPO compare to other (capital market) financing alternatives of family firms?
- How should family firms prepare an IPO (compared to non family firms)?
- Do family firms have higher IPO underpricing than non family firms? (Why?)
- What are the consequences of an IPO for a family firm?
- How do family firms perform (compared to non family firms) after their IPO?

Several of the questions outlined above will be investigated in separate research papers. The concept of socioemotional wealth (SEW) will be the overall theoretical construct for this dissertation project. Both theoretical and empirical analysis will be conducted.

#### The Sale of Family Firms: A Holistic Perspective | Decker / Rau

This study focuses on the question of how and why family firms are sold. Drawing on qualitative data from nine firm sales in four European countries, we specify different patterns of firm sales in the family business context. While the sale as an entrepreneurial project and the strategic sale are well planned, hardly afflicted with conflicts and generally result in sellers' satisfaction, expropriation is problematic and destructive for the family and the business. We contribute to family business research by showing that the family and the business are intertwined. The interplay of their underlying logics affects the process and the type of firm sale. Three patterns of firm sale are specified that have different implications for owner families, individual family members, and the family firm.

#### CEO Succession Events as Antecedents of Business Divestiture

Decker / Bresser (FU Berlin) / Mellewigt (FU Berlin) Wessel/ Decker/ Hack

Business divestiture has implications for a firm's corporate strategy. Two types of divestiture are distinguished: those that involve strategic change and those that are status quo-preserving. This study investigates the impact of CEO succession on status quo-destroying versus status quo-preserving business divestitures under conditions of voluntary versus involuntary CEO turnover, declining performance, strategic dispersion, and different degrees of managerial discretion. Based on a sample of CEO succession events and subsequent business divestitures of German corporations from different industries in the time period 1998-2008, our results suggest that neither voluntary nor involuntary CEO turnover is relevant to business divestiture. In contrast, outsider succession significantly affects the likelihood of status quo-destroying business divestiture, while a corporation's performance does not moderate this relationship.

Bringing Family Offices into Organizational Studies: Insights from the Public Sphere I Decker / Lange (*Surrey School of Management, UK*)

In our study, we adopt a content analytical approach that helps understand wealth owners' and relevant audiences' views of family offices. By analysing articles from Financial Times, Financial Times Deutschland, and the Wall Street Journal in the time period 2000-2010, we assume that these newspapers generate a reliable picture of what we know about family offices, because the daily business press is likely to regularly report on this topic and generate public awareness and helps us compare data from different contexts. With our study, we contribute to research in two ways: First, we add to the literature on the development and impact of organizational forms by defining what a family office is. Second, based on our findings, we suggest an agenda for future research on a confidential organization that traces promising avenues for future studies spanning different but complementary disciplines, e.g., corporate governance, family dynamics, international business, or wealth management.

#### Looking Behind the Scenes: The Impact of Conflicting Identities on the Sale of Family Firms I Decker / Rau

This study focuses on the question of what influence dual identities exert on the likelihood and process of the sale of family firms. Drawing on findings from three selected cases of involuntary firm sales, we analyze the antecedents, processes and outcomes of sale and actors' identity expressions. The selected firm sales are destructive for the family and the business, because they result in former owners' expropriation and jeopardize the firms' survival. Even in the presence of corporate governance systems, if family and business identities are contradictory, the likelihood that external actors will be able to promote a firm sale and simultaneously alienate the owner family from the business will increase.

## One Size Does *Not* Fit All: Entrepreneurial Families' Reliance on Family Offices I Decker / Wessel (WHU) / Lange *(Surrey School of Management, UK)* / Hack *(Universität Bern)*

This study suggests a three-dimensional framework for classifying family offices that are dedicated to the management of entrepreneurial families' private wealth. Based on agency theory and our framework, we analyze family offices in terms of goals and control mechanisms. Family-dominant management and private client structures involve stronger emphasis on non-financial goals in single and multi-family offices than in non-familydominant management and open client structures. Variations in family involvement, ranging from family dominance to the complete absence of family ownership and/or management, and diverse client structures justify the differential reliance on formal and informal control mechanisms.

#### Costs of Partner Search and Selection in Strategic Alliances I

#### Decker / Mellewigt (FU Berlin)

This study empirically examines the costs of alliance partner search and selection from the alliance-initiating company's perspective. Drawing on transaction cost economics and the network perspective on interorganizational relationships, the findings based on a sample of 83 alliances in the German telecommunications industry reveal that search and selection costs are closely connected but differentially affected by task- and company-related factors. When firms have to make alliance-specific investments, they search more intensively for an appropriate partner. Moreover, an alliance-initiating company's high market performance signals legitimacy and attractiveness in the marketplace and hence decreases search costs, but it does not affect selection costs. Finally, the number of current alliances decreases the initiating company's selection costs and thus supports learning and capability arguments.

## Exploring Forms of Inter-Cluster Collaboration: Applying a Network Approach to Governance I Decker / Lerch (HSU Hamburg) / Schüßler (FU Berlin)

In this study we elaborate on inter-cluster collaboration as a specific type of governance of inter-organizational relationships, that spans organizational and regional boundaries. We develop a conceptual framework that embraces four levels of analysis and their interplay: the organization, inter-organizational networks, the regional cluster, and networks among clusters. Drawing on five empirical cases of inter-cluster collaboration from different industries and regions we derive three governance types: cluster alliances, interconnected clusters, and inter-organizational networks across clusters. We outline distinctive dimensions and attributes of each of these types and discuss mechanisms of governing inter-cluster collaborations at and across different levels.

Costs of Turnaround in German Family-Influenced Small Companies: The Savings Banks' Perspective I Decker / Eiben (Bayern Consult, München)

We examine the costs of turnaround in German family-influenced, small- and medium-sized companies. Drawing on transaction cost economics and organizational learning, the findings based on a survey of corporate advisors in German savings banks reveal that ex ante- and ex post-turnaround costs are differentially affected by firm-specific and environmental uncertainty. Behavioral uncertainty does not exert any influence on turnaround costs, while learning capacity significantly decreases them. Our findings provide insights into the contingencies surrounding turnaround processes and the relationship between family-influenced small and mediumsized enterprises that aim at restoring their economic viability and savings banks as a salient stakeholder group.



#### 2. Konferenz deutschsprachiger Zentren für Familienunternehmensforschung

On March 1/2, 2012, the INTES Institute had the pleasure to be the host of the 2nd Conference of German speaking Centres for Family Business Research. The positive feedback of last year made twelve German speaking Centres and chairs where Family Business Research is done come to Vallendar and discuss current and recent developments on this field of research. Co-host of the conference which was created by the Wittener Institut für Familienunternehmen (WIFU) and the INTES Institute for Family Businesses was the Center for Family Business (CFB) of the University St. Gallen, Switzerland. They will host the conference next year.

Each participating institute had the opportunity to report on the developments that had been made during the past 12 months. Current research projects were presented as well as helpful suggestions about enhancements could be taken home. On the opening day Prof. Franz Kellermanns gave a review of the status quo in the field of family business research in the international context which put the discussions of the single projects on an appropriate large scale.

#### Summer Program

#### Succession in family firms—The RAU case Prof. Dr. Sabine Rau

Succession remains "the" strategic event in a family firm's life time. In the summer program for BA and MBA students from the University of Alberta, Hubertus Rau and Prof. Dr. Sabine Rau present the 2nd to 3rd generation succession in the Walter RAU Lebensmittelwerke. Focussing on the strategie as well as on the family-related and individual aspects, the siblings high-light learnings from a process which ultimately led to the sale of three independent family companies over a tome span of nearly a decade.

#### 7th Family Business Conference

#### "Building knowledge through practice!

Family Business Conference combines politics with real-world practice and academic research

On April 27 and 28, 2012, some 140 family entrepreneurs, young professionals, students, academics and politicians, met together at WHU to learn how realworld businesses can benefit from the latest results of academic research. Under the patronage of Heinrich Otto Deichmann, the latest conference in the Family Business series explored the theme of "Building knowledge through practice" and introduced a new focus in the process: knowledge transfer will now become an integral part of the event, a feature that sets it apart from other business conferences in Germany.

"Family businesses are among the great strengths of the German economy – the envy of our overseas competitors," emphasized conference patron and 'family entrepreneur by conviction' Heinrich Otto Deichmann in his address. He noted that this was especially evident during the financial and economic crisis: family businesses not only held onto their workforces, but compared to DAX-listed companies, actually took on significantly more new employees. Deichmann called for a greater emphasis on ethics both in business management studies and in the corporate world.

In a series of presentations on the topic of "Who needs who? – Germany, Europe and family businesses", former Federal Minister Hans-Dietrich Genscher, together with Jürgen Fitschen (Member of Deutsche Bank's Board of Management), Lutz Goebel (President of "Family Entrepreneurs"), Dr. Peter Bartels (Member of the Board of Management, PwC) and WHU Professor Markus Rudolf all discussed the stability, solidity and sustainability of family enterprises against the backdrop of the Euro debt crisis. Especially impressive was the presentation by Hans-Dietrich Genscher, who celebrated his 85<sup>th</sup> birthday last month. Asked how one maintains one's presence and intellectual incisiveness at an advanced old age, the former Foreign Minister responded with ready wit: "Use it or lose it".

In his presentation Karl Matthäus Schmidt – founder and CEO of quirin bank, a specialist in fee-based consulting – called for a transformation of the banking sector. "Trust is the basis for every banking transaction," he asserted, and went on to underline the enormous damage that banks' reputations have suffered as a result of the financial crisis. In his view, the banking industry must refocus on core competencies by learning to put customers first again, supporting SMEs and family businesses by adding value and lending to real businesses.

Prof. Dr. Sabine Rau, who holds the Chair in Family Business at WHU, used her presentation to update the audience on current research into successful succession planning in family businesses. Entitled "Avoiding Dallas and Denver", her talk introduced a number of key governance mechanisms. "The most important thing is to clarify the family's identity – that is, clarify what the family stands for, what matters to family members in the long term, what the family believes in," she explained. A family's sense of identity is dynamic and undergoes regular change. "Governance mechanisms must adapt to these constant shifts in a family's sense of identity." She went on to describe how experience shows that family identity is anything but a luxury – it has a tangible impact.

Delegates welcomed the new conference format with its new emphasis on knowledge transfer in accompanying workshops. "I think the workshops based on real -life scenarios are particularly useful: I believe this combination of practical experience with research is very important," explained Lutz Goebel. Dr. Josef Rettenmeier (Rettenmeier Holding AG) also praised the new format: "I took away plenty of ideas and information that I'm going to find very helpful in my daily work."

A festive dinner at Besselich monastery gave conference delegates a wonderful opportunity to network, sample a variety of culinary treats, and enjoy a top-flight entertainment program hosted by well-known comedian and improvisational actor Chin Meyer. The dinner also provided an opportunity to experience the proverbial WHU spirit: the business school's *a cappella* student ensemble "Commercial Harmonists" kept the audience asking for more as they performed a selection of vocal numbers.

The next Family Business Conference will take place on April 26-27, 2013.









## Community Outreach I Events

#### Forum Mittelstand at WHU (November 9, 2011)

Some 40 family business owners and managers attended the conference at WHU and discussed the topic "Turnaround management in family businesses" together with scholars and experienced turnaround managers. The chair of Prof. Dr. Andreas Hack and die Chamber of Commerce and Industry Koblenz hosted this event.

More specifically, a real turnaround of a family business was discussed by the owner (Robert Mürdter, Managing Partner of Mürdter Unternehmensgruppe), the involved bank (represented by Martina Rabe) and the turnaround consultant (Dr. Holmer Glietz, Managing Partner of Bonnio GmbH). This way, three different perspectives of the same turnaround were analyzed. Furthermore, Prof. Hack and his team presented current scholarly studies on the topic of early warning systems, crisis prevention and turnaround management in family businesses. Probably every entrepreneur and every manager was concerned with this turnaround issue at least once. As a result there was a productive working atmosphere in which the contributors went into details, talked about the auditorium's own experiences and gave specific recommandations. The request of the conference guests to extend the schedule reflects the relevance of this topic.

After the official part of the conference the participants met in the Open Space of the building to conduct bilateral conversations and let the day end as harmoniously as it has begun.

## Unternehmer-Erfolgsforum (November 15, 2011)

On November 15, 2011 the "Unternehmer-Erfolgsforum" again took place at Schloss Bensberg in Bergisch Gladbach, an event that enjoys great popularity within the jungle of events concerning family businesses. So every year you can see well-known faces as well as completely new participants.

The official motto of the 2011 Erfolgsforum was "Makers, brands and meanings– entrepreneur's denomination and awarenesses". But the non-official motto was, maybe more to the point "To learn from the champions". In the interest of this headline John Elkann, Franz M. Haniel, Markus Langes-Swarovski, Berthold Leibinger, Stefan Messer, René Obermann, Maria-Elisabeth Schaeffler and others discussed fundamental entrepreneurial challenges and responsibility. "And the decision to work with an external manager is no easy combination. This particularly applies to the fact that Heinz Gries enabled Andreas Land to become a ahareholder and partner of the company."

#### impulseWissen

The economic journal "impulse" – a business campaign for family firms and medium sized businesses – will already be published for the second consecutive year. Four times a year, the magazine will issue special editions under the title "impulse Wissen" (knowledge stimuli), refining the best research results of the topics management, innovation and entrepreneurship to make them vivid and interesting to the public. "With "impulse Wissen", we are the first to institutionalize the transfer of knowledge between universities and companies with a high level of practical relevance," claims Dr. Nikolaus Förster, chief editor of "impulse". The goal is to combine ambitious science with high quality journalism.

The editorial staff is hereby supported by a board of advisors, consisting of numerous partners, including the University of St. Gallen, the Vienna University of Economics and Business (WU), the RWTH Aachen, the private University Witten-Herdecke, the Zeppelin University, the Fraunhofer Academy and also the WHU – Otto Beisheim School of Management, represented by Prof. Dr. Andreas Hack, Head of the INTES Institute, respectively by Prof. Dr. Sabine Rau since July 2012. The scientific board of advisors is controlling the quality of all publications of universities and institutes concerning the topics management, innovation and entrepreneurship as well as the journalistic implementation.

The variety of articles is hereby distributed from tangible case studies to journalistically refined presentations of research results, interviews and columns. Each issue is topped off with a short overview of the best scientific essays and new publications from the universities.

#### Jury Familienunternehmer des Jahres

The "Familienunternehmer des Jahres" – Award (Family Business Entrepreneur of the Year) was invented in 2004 by INTES and "impulse" and is supported by the Hauck & Aufhäuser Privatbankiers, Ernst & Young, the HannoverFinanz Group, Die Familienunternehmer – ASU, the WHU – Otto Beisheim School of Management as well as the Financial Times Deutschland. Its goal is to honor entrepreneurial performance that serves the long-term survival of family firms. In this context, only shareholders and/or managers of family firms can be chosen.

An independent jury, consisting of representatives of the initiators and supporters, carries out the choice of the "Familenunternehmer des Jahres". Prof. Dr. Andreas Hack represents the WHU – Otto Beisheim School of Management as member of this jury. The criterion for the award is outstanding performance in the areas business strategy and/or family strategy. However not only entrepreneurial lifeworks, but also exemplary changes in the way of thinking towards recent topics are honored.

In the year 2011, Heinz Gries and Andreas Land, managing partners of Griesson – de Beukelaer, were awarded as "Familienunternehmer des Jahres 2011".
