C. Teaching

International capital market and derivatives (BSc Program. Prof. Wang, 2 SWS, Fall 2014 and Spring 2015)

This course introduces markets of bond, derivatives and equities, with their related international aspects. We discuss the underlying risk factors and pricing of bonds. We also introduce the characteristics, applications and pricing models of derivatives, including forwards/futures, swaps and options. Finally, we examine the arguments supporting and against international diversification.

Behavioral and Emotional Finance (Prof Wang & Prof. Johanning, MIF Program, 2.5 SWS, Spring 2014):

This course discusses important topics in Behavioral Finance, including non-expectedutility theory, heuristics and biases, heterogenous beliefs, anomalies such as equity premium puzzle, momentum, and bubbles. The goal is to understand various perspectives in the behavioral finance research and its practical relevance. In Emotional Finance psychological and neural aspects of financial decision making are explored, especially the role of emotions such as joy, trust and fear.
