Teaching at WHU

WHU-Otto Beisheim School of Management has established an outstanding position in the European business school market and is committed to high quality research as well as excellence in management education. While the research output of WHU faculty members is documented in detail in the WHU Research Report, the present report elaborates on WHU faculty members' accomplishments in the classroom.

Teaching is a core activity at WHU and we aim at developing future leaders not only by focusing on academic and practical aspects of business, but by encouraging students to internalize our core values *Passion, People*, and *Performance*: First, we promote entrepreneurial, innovative thinking and action through an intellectually stimulating and creative environment characterized by the engagement and commitment of all involved (*Passion*). Second, we encourage and stimulate students' personal development and social responsibility through mutual trust, support, and respect within a community of students, alumni, and faculty (*People*). Finally, we encourage excellent performance and are committed to providing our students with outstanding internationally oriented and up-to-date training and education programs, which build on WHU's own research (*Performance*). The WHU Teaching Report is based on students' evaluations of our undergraduate and graduate courses and provides evidence that WHU successfully delivers excellent performance and meets students' expectations across all academic programs. Although the report captures students' direct experiences in the classroom and thus an important correlate of teaching quality, it certainly cannot summarize the numerous initiatives and attempts of the WHU community to generate excellent study conditions. For example, our faculty is very active in publishing top-quality learning material which is not only used at WHU, but also at other business schools and universities in Europe. Moreover, three working groups are currently devising strategies to further improve teaching quality at WHU. From that perspective, the positive results documented in the WHU Teaching Report should be considered as manifestations of an organization-wide commitment to provide excellence in management education at WHU.

WHU at a Glance

WHU – Otto Beisheim School of Management is an internationally oriented and privately financed business school. Founded in 1984, WHU is now one of the most renowned German Business Schools with a high international reputation. In fall 2012, WHU opened the WHU Campus in Düsseldorf.

Since its establishment, WHU has proved itself to be a paragon of future-oriented research and teaching in business administration. The range of courses includes a Bachelor and Master of Science Program, a Full-Time MBA Program, a Part-Time MBA Program, the Kellogg-WHU Executive MBA-Program, and the Bucerius/WHU Master of Law and Business - Joachim Herz Program (MLB). The School now attracts 1079 participants in all programs each year as well as 257 participants in the Doctoral Program. In addition to these courses, WHU offers customized programs for management which are tailored to the needs of the particular enterprise. WHU's international network includes nearly 200 partner universities on all continents with which there are exchanges of lecturers and students, as well as cooperation in research in Germany and worldwide. WHU is regularly certified by EFMD (EQUIS), FIBAA and AASCB and awarded FIBAA System Accreditation in April 2012, which guarantees the excellent standard of research and academic programs as well as a high degree of internationalization. In both national and international rankings WHU – Otto Beisheim School of Management continues to occupy leading positions.

In the future, WHU will continue to pursue a strategy of growth. WHU's ultimate aim is to strengthen its position among the top business schools in Europe.

Teaching Evaluation at WHU



WHU-Teaching Report and the Principle of Excellence in Management Education

All our actions at WHU are guided by the notion of *Excellence in Management Education.* Excellence in education quality is ensured in three ways: by careful selection of our instructors based on their teaching skills, by accreditation of study programs on a national and international level, and by seeking regular feedback from our students. For us, excellence in teaching means offering courses that reflect modern practice in terms of content and methodology and that discuss topics from an international point of view. The results documented in the *Teaching Report* suggest that we are successful in doing so from the perspective of our students. From 2013 onwards, the *Teaching Report* will be published on a regular basis to inform current and prospective students as well as instructors and program coordinators about the quality of all courses offered at WHU. The results include objective and quantitative measures as well as personal and subjective feedback from the students to provide a comprehensive picture of all programs and courses offered at WHU.

Teaching Evaluation System

As one of the first universities in Germany, WHU developed and established a measurement and evaluation system for teaching quality in 1994. This system is used as the main source for course and program improvements, as well as teaching award decisions.

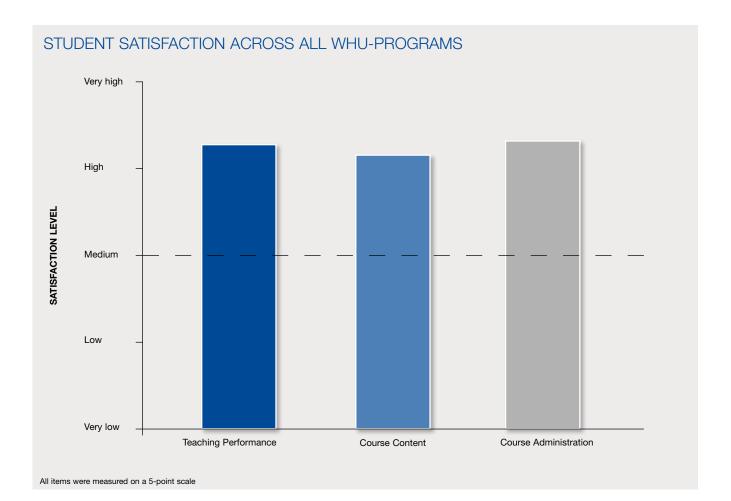
The teaching evaluation system has been tailored to the special requirements of all our different programs at WHU. Students evaluate each course based on teaching

performance, course content, as well as course administration. Additionally, students are invited to provide feedback regarding strengths and weaknesses of the courses. Evaluations take place at the end of the courses and are published at the end of the semester. For all courses the data is systematically analyzed and results are summarized in a feedback document for the instructors.



Overall Results for the Academic Year 2012/13

Items of the teaching evaluation system were grouped into three general categories: teaching performance, course content, and course administration. The figure below shows students' average evaluations of the three performance categories across all academic programs at WHU.



The positive results of the category "teaching performance" show that our professors not only seek to convey a maximum of knowledge, but do this in an entertaining and inspiring way. In many programs, participants are especially happy about the thorough consideration of their questions and about the interactive discussions of course topics. The high scores on "course content" reflect an appropriate balance of theoretical aspects, academic challenge, and practical aspects of each topic. Furthermore the selected course contents are considered highly relevant for the future career of our students. The smooth course administration at WHU is also valued highly and guarantees that students can fully concentrate on the development of their skills and abilities. Although the overall results for the academic year 2012/2013 are rather positive, quality management at WHU is considered a continuous and iterative process of planning, implementing, monitoring, and improving. This implies that we will continuously improve teaching performance, course portfolio, and course organization until all students are satisfied with the study conditions at WHU - Otto Beisheim School of Management.

Best Teacher Awards

Based on students' evaluations WHU honors outstanding teachers in each academic program with the Best Teacher Award. Although all instructors at WHU deliver excellent performance in their courses, award recipients were especially successful in tailoring the characteristics of their courses to students' expectations and needs. Professors receive the Best Teacher Award at the graduation ceremony of the respective program.

Top-level Business Education in an International Setting

The Bachelor in International Business Administration at WHU is an undergraduate university degree that addresses highly-qualified, committed high school graduates interested in a comprehensive, international study program. The program offers a large science-based curriculum with 150 courses that convey solid academic expertise, a comprehensive business mindset, and promote personality development as well as problem-solving skills.

In the academic year 2012/13, 540 Bachelor students were enrolled at WHU and enjoyed outstanding study conditions, such as learning in small teams and an excellent studentto-faculty ratio (11 Bachelor students to 1 professor). The Bachelor program at WHU fosters the development of mindful generalists and uniquely prepares the students for operating in international companies. The development of foreign language skills, a semester abroad at one of nearly 200 partner universities and an internship abroad are fundamental program elements. Students also gain international experience through the daily interaction with exchange students, as well as through the opportunity to participate in a "Management Abroad Course".

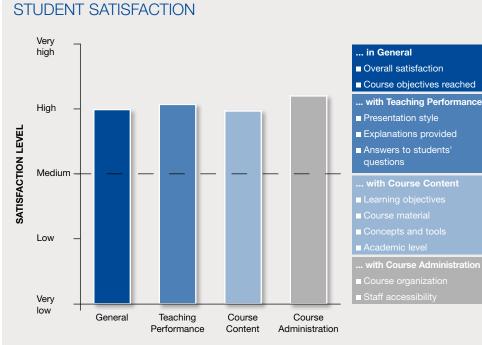

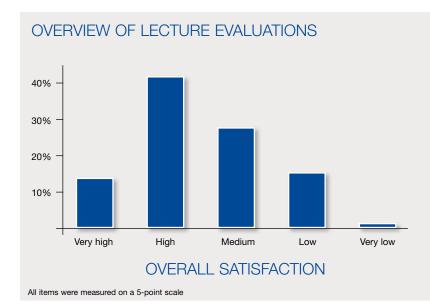

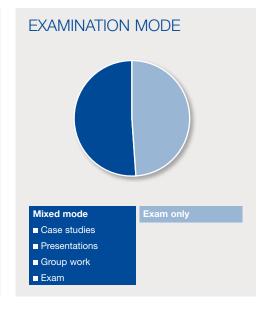
High Student Satisfaction



All courses in the WHU Bachelor program are evaluated by our students on four dimensions: general satisfaction with the course, teaching performance of instructors, course content, and course administration. All items were measured on a 5-point scale





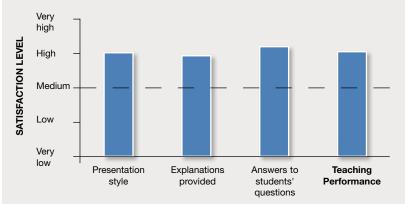
Overall, our Bachelor students seem to be highly satisfied with the courses offered at WHU. More than 55% of the lectures achieve very high or high satisfaction levels. However, there is still room for improvement for some of the courses.

At WHU, we assess our students' knowledge and competence not only by means of written exams. In more than 50% of our courses, we apply modern assessment methods such as case studies, presentations, and group assignments, which foster longlasting learning success.

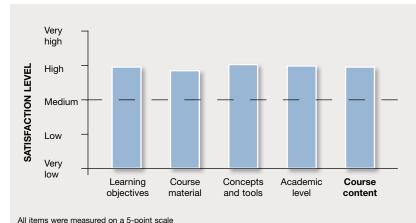

Teaching performance is rated with regard to presentation style, explanation of course content, and answers to students' questions. High satisfaction levels are achieved on the three facets of teaching performance. Furthermore, an analysis of qualitative comments suggests that students value the interactive and interesting way in which contents are presented.

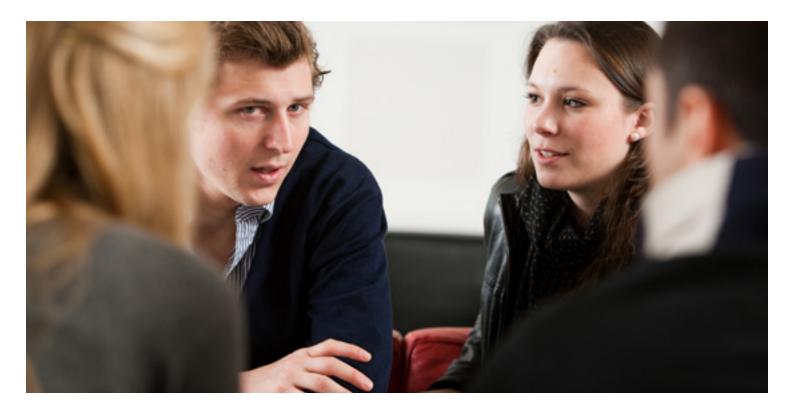
Future of the Program

New Bachelor Track - Entirely Taught in English

Starting in 2014, WHU will add a new Bachelor track to its portfolio. In addition to the well-established 180-credits and 210-credits tracks, we will newly offer another 180-credits track, which will be taught in English. In contrast to the

present study tracks, in which the first semesters are partly taught in German, knowledge of the German language will no longer be required for studying the Bachelor program at WHU.

Master in Management



Master in Management (MSc) Unfold Your Ambitions. Develop Excellence.

WHU's Master in Management program is designed for recent graduates with an excellent first academic degree in a business-related field of study. The Financial Times Master Ranking rated WHU's Master program as the best in Germany and third-best in the world. The Master in Management program offers the opportunity to develop expertise in all key areas of business administration. It is completely taught in English and allows students to graduate within 17 or 21 months, depending on the chosen track. Students of the MSc program are required to elect eleven course modules from the following six concentrations: Accounting & Financial Management, Economics & Financial Markets, Innovation & Entrepreneurship, Marketing & Sales, Strategy, and Supply Chain Management. Students in the WHU Master in Management program benefit from a large network of nearly 200 partner universities across the world and from the opportunity to gain practical experience abroad in one of WHU's numerous partner companies.

In the academic year 2012/13, 180 Master students were enrolled at WHU and benefited from the outstanding student-to-faculty ratio (4 Master students to 1 professor). The comprehensive, module-based curriculum does not only equip our students with analytical tools and business knowledge, but will also foster teamwork skills and help students to develop their personal potential. Similar to our Bachelor program, Master students are graded on different aspects (case studies, group or individual assignments, as well as presentations) rather than on exam performance only.

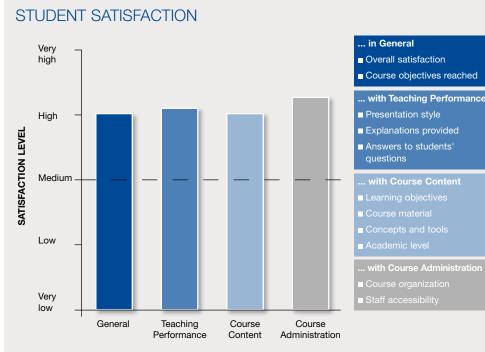

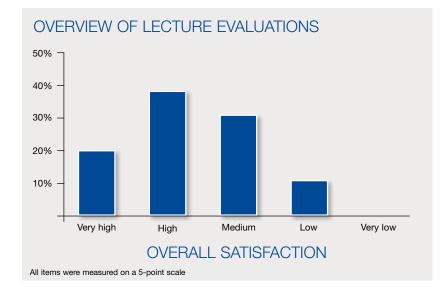

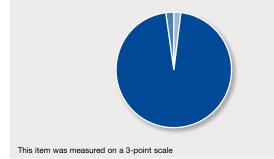
All items were measured on a 5-point scale



The majority of our Master courses is evaluated positively. The results indicate that students perceive 20% of the courses as outstanding and that they were highly satisfied with 38% of the courses.

PERCEIVED DIFFICULTY OF MASTER-COURSES





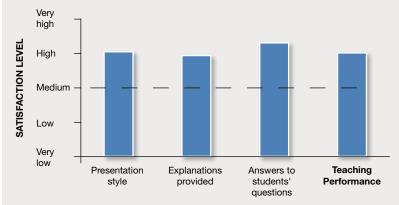
WHU students in the Master of Management program perceive 96% of the courses as challenging but appropriate.

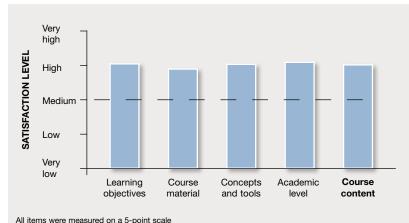

Future of the Program

Master in Finance

In fall 2013, a specialized Master in Finance (MiF) program has started. WHU's Master in Finance program is designed for graduates with an excellent first academic degree in a business-related field of study. Within 17 or 21 months, it provides students with an in-depth understanding of financial markets by offering a wide range of modules in the field of finance. Students of the Master of Finance program are required to choose course modules in finance, which are taught in English. The modules cover key issues such as Capital Market Theory, Financial Valuation, Asset Management, and Behavioral Finance. The program offers both practical orientation and international experience due to integrated internships and a study abroad program. The program aims at preparing students for careers in the global financial industry and for leadership tasks in the financial sector.

Full-Time MBA

Study in Germany. Experience the World.

The Full-Time MBA program aims at qualifying participants for the strategic leadership of companies. Full-Time MBA students graduate within 15 months and complete four core modules as well as four elective concentration modules. There is a broad range of concentrations as well as one comprehensive concentration in Personal Leadership. The Full-Time MBA program at WHU is characterized by practical orientation, internationality, and small class sizes to guarantee an optimal learning experience. Teamwork is an essential element of our teaching approach. In study groups of five to six MBA students, participants discuss course content and apply taught concepts and tools in case studies. In the academic year 2012/13, 42 students were enrolled in the Full-Time MBA program. The curriculum emphasizes management concepts which foster strategic vision, entrepreneurial spirit, operational excellence, and awareness of cultural differences. Students have the opportunity to attend three mandatory international modules at topranked partner universities in USA (Kellogg School of Management, Chicago), India (IIM, Bangalore), and China (Fudan University, Shanghai). Due to the global perspective, an understanding of cultural differences and how these matter for individual and corporate success is developed.

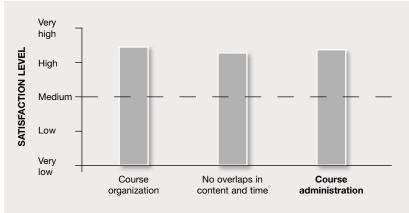

The provided concepts and tools, as well as the orientation on previously defined learning objectives were highly satisfying. Furthermore, our Full-Time MBA students are highly satisfied with both the academic level as well as with the practical usefulness of their courses.

The Essence of Leadership

The Part-Time MBA program at WHU is an internationally oriented general management program designed for participants with different academic and professional backgrounds. It addresses young professionals who want to perform effectively in a challenging global environment by enhancing, deepening, and developing their knowledge in the fields of business administration and economics. It equips participants with the knowledge to understand the interdisciplinary relations within a business organization and make sustainable strategic decisions based on stateof-the-art management concepts.

In the academic year 2012/13, 80 students were enrolled in the Part-Time MBA program and benefited from the strong focus on personal development and leadership competence. Students are required to complete four core modules and to deepen their knowledge in concentration modules providing profound know-how in the fields of marketing, finance, value chain management, strategy, and innovation. It is our goal to create a mindset that features responsibility towards the social and environmental consequences of managerial decisions. During three residential weeks in USA (Columbia Business School, NYC), India (IIM, Bangalore), and China (CEIBS, Shanghai), the program participants learn about chances, challenges, and risks of doing business abroad.

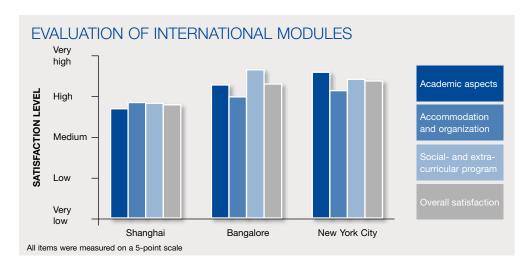

The Kellogg-WHU Executive MBA program is designed for executives working in medium and upper management with at least eight years of work experience. Our candidates are experienced executives with an international focus, eager to learn, motivated, and willing to grow. The program's time structure of weekend courses allows participants to continue in their profession while at the same time actively participating in the program. Thanks to the time structure, participants can immediately put into action what they learned during the program.

In the academic year 2012/13, 107 international participants have benefited from the holistic approach of our EMBA program, which is rated the best Executive MBA in Germany and among the top-ten Executive MBAs in Europe by the Financial Times Ranking of 2013. The Kellogg-WHU EMBA program synthesizes American and European management know-how and puts strong emphasis on teamwork to prepare our participants for future leadership roles. A mix of techniques, focused strongly on the case study methodology, allows students to work in interdisciplinary groups and, in turn, discuss, debate, and solve real-life business problems. A mix of additional methods is used to draw on the participants' own professional experience, creating an interactive learning environment and promoting an exchange of ideas between students and faculty. 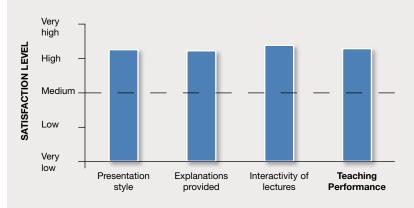

Bucerius/WHU Master of Law and Business



Bucerius/WHU Master of Law and Business Joachim Herz Program

The Bucerius Law School and the WHU - Otto Beisheim School of Management offer a joint Master's program, which aims to convey both law and business knowledge. The program is designed for international students whose first degrees are in law or business studies with at least two years of working experience. The program primarily takes place on the campus of Bucerius Law School in Hamburg, but the participants also spend time on the WHU campus for two live-in weeks, for some student events, and, in some cases, while they are writing their Master's thesis. The 12-months program consists of academic courses, practical exercises, and social projects. The Bucerius-WHU Master of Law and Business is a truly interdisciplinary program that combines the various aspects of international business law with topics in international management. Exercises and case studies are used to enable students to apply the learned concepts, frameworks, and techniques in practice. The entire program is accompanied by a "Studium Generale" (general course of studies) which consists of lectures and other events in international politics, business ethics, as well as German and European culture, society, and politics.

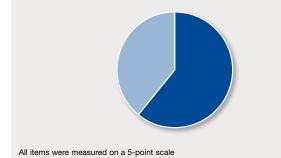

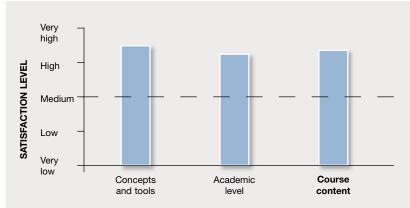

Future of the Program

Termination of our Bucerius/WHU Master of Law and Business Program

In 2006, the Bucerius Law School and the WHU – Otto Beisheim School of Management introduced the MLB program that combined elements of graduate law and business programs. Through 2013, about 360 students from more than 70 countries enrolled in the joint MLB program. Taking the students' home country as a measure, the MLB is by far the most international program at both institutions. Additionally, the Bucerius-WHU MLB cooperation has yielded various other collaborations in different aspects of the universities' academic lives. For example, WHU has, for some years, structured the business curriculum in the LL.B. Program at the Bucerius Law School, while the Bucerius Law School has orchestrated the law courses for WHU students. This cooperation will endure in the years to come. As of fall 2014, the MLB program itself will not be continued as a joint Bucerius/WHU program. While the MLB program has been a huge academic success for both schools and its graduates, both institutions wish to adjust their respective program portfolios to reflect their institutional developments over the past 8 years. As the MLB Program is currently the only master's level program at the Law School, Bucerius will continue to offer the MLB degree. In addition, the Law School now wishes to introduce the internationallywell-recognized LL.M. (Legum Magister) degree with a focus on business law, thus creating synergies with the MLB Program. WHU, in turn, will continue its successful programs Master in Management, Master in Finance, MBA, Part-time MBA, and Executive MBA, in order to focus on pure business programs as a part of its growth strategy.
