Authors' Note

Abstract

In the recent past, the demand for luxury experiences has grown. An increase in the middle and upper class disposable income, changes in lifestyle patterns, and demand for unique and exotic holiday experiences have been the forefront drivers.

The global luxury travel market is expected to garner USD 1.2tr by 2022. Epitomising desirable destinations, luxurious accommodations, convenient transport facilities, and authentic travel experience, the luxury travel market has great future potential to grow and diversify. Customization and personalization gain increasing importance in luxury tourism. Also, the concept of luxury travel changes from opulence to exclusive.

Synonymous with luxury, LVMH bets on the future of this market that is increasingly going experiential. Belmond would help it increase its luxury image. It would benefit from a luxury perception with both tangible and experiential products in its portfolio In December 2018, Bernard Arnault made a strategic move into the luxury hospitality sector with the announcement that LVMH Moët Hennessy – Louis Vuitton and Belmond Ltd., owner, part-owner and/or manager of 46 luxury hotel, restaurant, train and river cruise properties, have entered into a definitive agreement for LVMH to acquire Belmond for USD 25.0 per Class A share in cash.

LVMH, the firm behind fashion labels such as Louis Vuitton and Christian Dior, has a rich history of managing, acquiring, and fostering heritage brands for the long term. It already has a portfolio of hotels including the Cheval Blanc in the prestigious Courchevel ski resort in the French Alps as well as Bylgari hotels.

In 2018, the luxury market is reported to have reached EUR 0.9tr, of which EUR 0.3tr was in personal luxury goods and EUR 0.5tr was for experiential luxury. Therefore, there are avenues for growth in the luxury experiential market. As experiential luxury grows at about 5%, far faster than personal luxury at 3%, the acquisition comes at an important time. It would help LVMH have a strong presence in the ultimate hospitality world.

Established 40 years ago and synonymous with history, heritage, and timeless experiences, Belmond's portfolio is difficult to replicate. Belmond delivers unique experiences to discerning travelers and owns a number of exceptional assets in the most desirable destinations. This will complement LVMH's own Cheval Blanc Maisons and the Bylgari hotels activities.

The deal is LVMH's largest acquisition since it spent EUR 4.3bn in 2011 to buy Bvlgari and EUR 6.5bn in 2017 to gain full control of

Christian Dior. The Belmond deal, with an enterprise value of USD 3.2bn, justifies the value that Belmond will add to LVMH's portfolio. It would not only supplement the existing luxury experiential offerings of LVMH, but also complement the other products from the wide product portfolio – luxury bags, watches, clothing and more.

The current trend in the market is that younger generations are more willing to wait or pay extra for personalised products and services. Consumers demand personalised luxury as they seek ways to stand out from the crowd in a world where brands are in danger of becoming overexposed through social media and the mass consumption of luxury. As so-called experiential luxury drives a new era for the industry, the boundaries of bespoke are expanding. LVMH will be able to attract consumers from this market segment and try and build brand loyalty.

Therefore, LVMH will now reach critical mass in the ultimate luxury hotel world with this one single acquisition and it is consistent with its long-term strategy focused on offering the consumer a full spectrum of luxury experiences.

Synopsis

- LVMH Moet Hennessy Louis Vuitton SE acquired the entire share capital or 103.0 million class A ordinary shares of Belmond Ltd, a London-based hotel operator, for USD 25.0 in cash per share, or a total USD 2.6bn
- On completion, Belmond was delisted from New York Stock Exchange
- Originally, in August 2018, Belmond announced that it was seeking a buyer for the company. KSL Capital Partners LLC, Blackstone Group LP, KKR & Co, and Ashkenazy Acquisition Corp. were rumored as potential bidders

Rationale

- The purposes of the transaction were for LVMH Moet Hennessy Louis Vuitton SE to strengthen and expand its operations in the hotel sector and for Belmond Ltd to increase its shareholders value and to offer a broader range of services
- For LVMH the transaction enhances its existing luxury experiential offerings and strengthens its presence in the luxury hospitality sector by complementing the hotel activities of the Cheval Blanc Maisons and Bylgari hotels, already in the company's portfolio

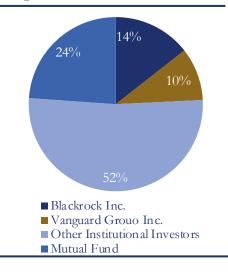

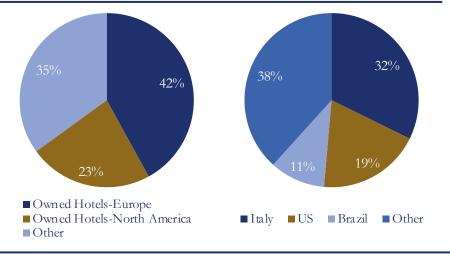

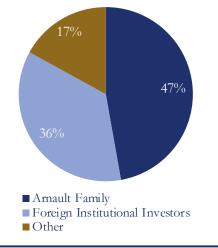
Key Management & Ownership Structure



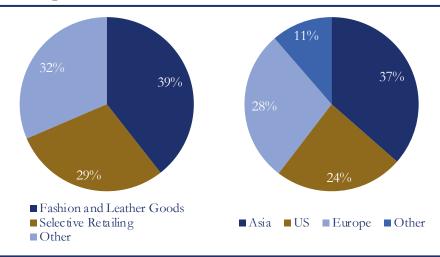
