Approximations for the Distribution Function of the Sum of iid Random Variables with Compact Support in $I\!\!R_+^{-1}$

Manfred Brandt

Abstract

In this paper a unified approach to central and decentral approximations of the distribution function F(x, n) of the sum of n iid random variables with compact support in \mathbb{R}_+ is given. This approach yields direct Edgeworth expansion (especially the Central limit theorem) and indirect Edgeworth expansion (Theorem of Bahadur-Rao, large deviation results) within a unified framework. An approximative inversion of the LST of F(x, n) (approximation of the complex inversion integral over a line by an integral over a proper bounded arc with a proper integrand) allows to get these approximations and moreover explicit error bounds.

1 Introduction

The distribution of the number N(t) of packets arriving during an interval [0, t] and generated by independent identically distributed sources within an ATM network, cf. [BB94], led to the problem of approximating the distribution function of the sum of iid random variables with compact support in \mathbb{R}_+ . Also in risk theory often appears the problem of approximating the distribution function of the sum of iid random variables. The distribution function of the sum of n real-valued iid random variables can be approximated by the Central limit theorem or, with more accuracy, by a direct Edgeworth expansion. But in case of very rare events large deviation techniques yield better approximations.

Applying complex analytic methods, these approximations and explicit error bounds are obtained within a unified framework. An investigation of the LST of a distribution function with compact support in \mathbb{R}_+ and an approximative inversion of the *n*-th power of the LST yield these results. The approximative inversion of the *n*-th power of the LST is based on an approximation of the complex inversion integral for Laplace transforms over a line by an integral over a proper bounded arc and a proper integrand. Depending on the choice of the arc in the complex plane we obtain a central approximation (Central limit theorem or direct Edgeworth expansion, cf. e.g. [F71] p. 541, depending on the choice of the approximating integrand) or a decentral approximation (large deviation results, Theorem of Cramér, indirect Edgeworth expansion, Theorem of Bahadur-Rao, cf. e.g. [BR60], [BC79], [B90]). In particular, firstly this approach yields a unified

framework for the approximation of the distribution function of the sum of iid random variables in the different regions, secondly we obtain new error bounds for these approximations.

The paper is organized as follows. In Section 2 we investigate the LST of the distribution function of a random variable with compact support in R_+ . The LST is an entire holomorphic function of first order. We obtain bounds for the LST and for the semi-invariants of the distribution function. Moreover we show that the inversion integral for Laplace transforms yields an approximation of the distribution function by substituting the path of integration over a line in the right half plane by a proper bounded arc in the complex plane. In Section 3 we give central approximations (Central limit theorem and direct Edgeworth expansion) of the distribution function of the sum of iid random variables with compact support in R_+ and explicit error bounds. In Section 4 in an analogous way we obtain a decentral approximation (indirect Edgeworth expansion rsp. Theorem of Bahadur-Rao) of the distribution function of the sum of iid random variables with compact support in R_+ and also explicit error bounds. As an application in Section 5 we investigate the superposition of iid two-state sources (e.g. voice sources) within an ATM network, cf. [BB94].

2 The LST of the distribution function of a real-valued random variable with compact support

Let $F(x) := P(X \le x)$ be the distribution function of a real-valued random variable X. We assume that F(x) has the following property:

P1: The support of F(x) is a compact subset of \mathbb{R}_+ and contains at least two points.

Later also we will make use of the following property of F(x) which especially excludes the case of a lattice distribution:

P2: There exist an interval I of positive length ℓ and $\delta > 0$ such that

$$|F(x_2) - F(x_1)| \ge \delta |x_2 - x_1| \quad \forall \ (x_1, x_2) \in I^2.$$
(2.1)

Let us denote by [a, b] the shortest interval containing the support of F(x) and by L := b - a its length. Let $g(s) := Ee^{-sX}$ be the LST of the distribution function F(x). Since the support of F(x) is compact in R_+ and contains at least two points g(s) is an entire holomorphic function of first order with an infinite number of zeros. Choosing that branch of $\sigma_0(s) := \log g(s)$ vanishing at s = 0 we obtain a function which is holomorphic in a neighborhood of s = 0. Finally, let

$$\sigma_{\nu}(s) := (-1)^{\nu} \frac{\mathrm{d}^{\nu}}{\mathrm{d}s^{\nu}} \sigma_{\theta}(s), \quad \nu \in \mathbb{N}.$$
(2.2)

 $\sigma_{\nu}(s)$ is a meromorphic function for $\nu \in \mathbb{N}$. $\sigma_{I}(0)$ and $\sigma_{2}(0)$ are the expectation rsp. the variance of the random variable X, in general $\sigma_{\nu}(0)$ is the semi-invariant of order ν of the distribution function F(x), cf. [F71].

The following Lemma 2.1 gives bounds for $\sigma_{\nu}(u), u \in \mathbb{R}, \nu = 2, 3, \dots$ The distribution functions

$$F_{2}(x) := \frac{1}{2} \operatorname{II}\{x \ge a\} + \frac{1}{2} \operatorname{II}\{x \ge b\},$$

$$F_{3}(x) := \left(\frac{1}{2} \pm \frac{1}{\sqrt{12}}\right) \operatorname{II}\{x \ge a\} + \left(\frac{1}{2} \pm \frac{1}{\sqrt{12}}\right) \operatorname{II}\{x \ge b\}$$

show that these bounds are sharp in case of $\nu = 2$ and $\nu = 3$.

Lemma 2.1 Let F(x) be a distribution function satisfying (P1). Then we have:

i) $\sigma_0(s)$ is holomorphic in $G := \{s \in \mathcal{C} : |\text{Im } s| < \pi/L\}$ satisfying the estimate

$$\left|\operatorname{Im}\left(\sigma_{\theta}(s) + \frac{a+b}{2}s\right)\right| \leq \frac{L}{2}|\operatorname{Im} s| \quad \forall s \in G.$$

$$(2.3)$$

- ii) $\sigma_1(u)$ is strictly decreasing on \mathbb{R} and maps \mathbb{R} onto the interval (a, b).
- iii) For $u \in \mathbb{R}$ it holds

$$0 < \sigma_2(u) \le \frac{1}{4}L^2, \tag{2.4}$$

$$|\sigma_{\mathcal{J}}(u)| \leq \frac{\sqrt{3}}{18}L^{\mathcal{J}},\tag{2.5}$$

$$\left|\frac{\sigma_{\nu}(u)}{\nu!}\right| \leq \frac{3\sqrt{3}}{4} \left(\frac{L}{\pi}\right)^{\nu}, \quad \nu = 2, 3, \dots$$
 (2.6)

Proof:

i) For $s \in G$, s = u + iv it follows

$$\operatorname{Re}(e^{\frac{a+b}{2}s}g(s)) = \int_{a}^{b} e^{(\frac{a+b}{2}-x)u} \cos\left(\left(\frac{a+b}{2}-x\right)v\right) dF(x) \ge e^{-\frac{L}{2}|u|} \cos\left(\frac{Lv}{2}\right) > 0.$$

Therefore, g(s) has no zeros in G and $\sigma_0(s) = \log g(s)$ is holomorphic in G. Furthermore, for $s \in G$, Im s > 0 it follows

$$\operatorname{Im}(e^{i\frac{Lv}{2}}e^{\frac{a+b}{2}s}g(s)) = \int_{a}^{b} e^{(\frac{a+b}{2}-x)u}\sin((b-x)v)\mathrm{d}F(x) \ge 0,$$
$$\operatorname{Im}(e^{-i\frac{Lv}{2}}e^{\frac{a+b}{2}s}g(s)) = \int_{a}^{b} e^{(\frac{a+b}{2}-x)u}\sin((a-x)v)\mathrm{d}F(x) \le 0$$

hence

$$|\operatorname{Im}\log(e^{\frac{a+b}{2}s}g(s))| = |\arg(e^{\frac{a+b}{2}s}g(s))| \le \frac{L}{2}|\operatorname{Im} s| \quad \forall \ s \in G.$$

iii) Let

$$F_u(x) := \frac{1}{g(u)} \int_a^x e^{-u\xi} \mathrm{d}F(\xi)$$

denote the twisted distribution function, cf. [B90]. For fixed $c \in \mathbb{R}$ the expansions

$$\frac{e^{ch}g(u+h)}{g(u)} = \int_{a}^{b} e^{(c-x)h} \mathrm{d}F_u(x) = 1 + \sum_{k=1}^{\infty} \frac{h^k}{k!} \int_{a}^{b} (c-x)^k \mathrm{d}F_u(x)$$

and

$$\log \frac{e^{ch}g(u+h)}{g(u)} = h \int_{a}^{b} (c-x) dF_{u}(x) + \frac{h^{2}}{2!} \Big[\int_{a}^{b} (c-x)^{2} dF_{u}(x) - \Big(\int_{a}^{b} (c-x) dF_{u}(x) \Big)^{2} \Big] + \frac{h^{3}}{3!} \Big[\int_{a}^{b} (c-x)^{3} dF_{u}(x) - 3 \int_{a}^{b} (c-x) dF_{u}(x) \int_{a}^{b} (c-x)^{2} dF_{u}(x) + 2 \Big(\int_{a}^{b} (c-x) dF_{u}(x) \Big)^{3} \Big] + \dots$$

converge for $|h| < \pi/L$. On the other hand, for $|h| < \pi/L$ we have the Taylor-expansion

$$\log \frac{e^{ch}g(u+h)}{g(u)} = ch + \sigma_0(u+h) - \sigma_0(u) = h(c - \sigma_1(u)) + \sum_{k=2}^{\infty} \frac{h^k}{k!} (-1)^k \sigma_k(u).$$

Comparing the coefficients we obtain representations of $\sigma_k(u)$ for $k \in \mathbb{N}$. Choosing $c = \sigma_1(u)$ rsp. c = (a+b)/2 the representation

$$\sigma_2(u) = \int_a^b (c-x)^2 \mathrm{d}F_u(x) - \left(\int_a^b (c-x)\mathrm{d}F_u(x)\right)^2$$
(2.7)

yields

$$\sigma_{2}(u) = \int_{a}^{b} (\sigma_{1}(u) - x)^{2} \mathrm{d}F_{u}(x) > 0,$$

$$\sigma_{2}(u) \leq \int_{a}^{b} \left(\frac{a+b}{2} - x\right)^{2} \mathrm{d}F_{u}(x) \leq \frac{1}{4}L^{2}.$$
(2.8)

Choosing c = b the representation of $\sigma_3(u)$ yields in view of Cauchy-Schwarz's inequality

$$\sigma_{\beta}(u) = -\int_{a}^{b} (b-x)^{\beta} dF_{u}(x) + 3\int_{a}^{b} (b-x) dF_{u}(x) \int_{a}^{b} (b-x)^{2} dF_{u}(x) - 2\left(\int_{a}^{b} (b-x) dF_{u}(x)\right)^{\beta} \\ \leq -\int_{a}^{b} (b-x)^{\beta} dF_{u}(x) + 3\left(\int_{a}^{b} (b-x) dF_{u}(x)\right)^{\beta/2} \left(\int_{a}^{b} (b-x)^{\beta} dF_{u}(x)\right)^{1/2}$$

$$-2\Big(\int_{a}^{b} (b-x) dF_{u}(x)\Big)^{\beta}$$

= $\Big(\frac{\int_{a}^{b} (b-x)^{\beta} dF_{u}(x)}{\int_{a}^{b} (b-x) dF_{u}(x)}\Big)^{\beta/2} (-\xi + 3\xi^{2} - 2\xi^{\beta}),$

where

$$\xi := \Big(\int_{a}^{b} (b-x) \mathrm{d}F_{u}(x)\Big)^{3/2} \Big(\int_{a}^{b} (b-x)^{3} \mathrm{d}F_{u}(x)\Big)^{-1/2}.$$

Since

$$-\xi + 3\xi^2 - 2\xi^3 \le \frac{\sqrt{3}}{18}, \quad \xi \in [0, \infty)$$

we get

$$\sigma_{\beta}(u) \leq \frac{\sqrt{3}}{18} \left(\frac{\int_{a}^{b} (b-x)^{\beta} \mathrm{d}F_{u}(x)}{\int_{a}^{b} (b-x) \mathrm{d}F_{u}(x)} \right)^{\beta/2} \leq \frac{\sqrt{3}}{18} L^{\beta}.$$

The corresponding estimate below for $\sigma_{\beta}(u)$ follows by choosing c = a.

Let $\varphi(s) := \sigma_0(s) + \frac{a+b}{2}s$, $s \in G$. Let $u \in \mathbb{R}$ and $r \in (0, \pi/L)$ be fixed. Then for $\nu = 1, 2, ...$ it holds

$$\int_{0}^{\pi} \operatorname{Im} \varphi(u + re^{i\alpha}) \sin(\nu\alpha) d\alpha = \int_{0}^{\pi} \operatorname{Im} \left(\sum_{k=0}^{\infty} \frac{\varphi^{(k)}(u)}{k!} (re^{i\alpha})^{k} \right) \sin(\nu\alpha) d\alpha$$
$$= \sum_{k=0}^{\infty} \frac{\varphi^{(k)}(u)}{k!} r^{k} \int_{0}^{\pi} \sin(k\alpha) \sin(\nu\alpha) d\alpha.$$

In view of

$$\int_{0}^{\pi} \sin(k\alpha) \sin(\nu\alpha) d\alpha = \frac{\pi}{2} \delta_{k\nu}$$

it follows

$$\frac{\varphi^{(\nu)}(u)}{\nu!} = \frac{2}{\pi r^{\nu}} \int_{0}^{\pi} \operatorname{Im} \varphi(u + re^{i\alpha}) \sin(\nu\alpha) d\alpha, \quad \nu = 1, 2, \dots$$

By the definitions of $\varphi(s)$ and $\sigma_{\nu}(s)$ therefore we have

$$\frac{\sigma_{\nu}(u)}{\nu!} = \frac{2(-1)^{\nu}}{\pi r^{\nu}} \int_{0}^{\pi} \operatorname{Im} \varphi(u + re^{i\alpha}) \sin(\nu\alpha) d\alpha, \quad \nu = 2, 3, \dots$$

Because of (2.3) we get the estimate

$$\left|\frac{\sigma_{\nu}(u)}{\nu!}\right| \leq \frac{2}{\pi r^{\nu}} \int_{0}^{\pi} \left|\frac{L}{2} r \sin(\alpha) \sin(\nu\alpha)\right| \mathrm{d}\alpha = \frac{L}{\pi r^{\nu-1}} \frac{2\nu}{(\nu^{2}-1)\tan(\frac{\pi}{2\nu})}, \quad \nu = 2, 3, \dots$$

The limit $r \uparrow \pi/L$ yields

$$\left|\frac{\sigma_{\nu}(u)}{\nu!}\right| \le \left(\frac{L}{\pi}\right)^{\nu} \frac{2\nu}{(\nu^2 - 1)\tan(\frac{\pi}{2\nu})}, \quad \nu = 2, 3, \dots$$

Elementary computation shows

$$\frac{2\nu}{(\nu^2 - 1)\tan(\frac{\pi}{2\nu})} \le \frac{3\sqrt{3}}{4}, \quad \nu = 3, 4, \dots, 7,$$

and in case of $\nu \geq 8$ it follows

$$\frac{2\nu}{(\nu^2-1)\tan(\frac{\pi}{2\nu})} \leq \frac{2\nu}{(\nu^2-1)\frac{\pi}{2\nu}} = \frac{4/\pi}{1-(1/\nu)^2} \leq \frac{4/\pi}{1-(1/8)^2} < \frac{3\sqrt{3}}{4}.$$

In view of (2.4) therefore it holds (2.6).

ii) Because of $\sigma'_1(u) = -\sigma_2(u)$ and (2.4) the function $\sigma_1(u)$ is strictly decreasing on \mathbb{R} . Therefore only we have to prove

$$\lim_{u \to -\infty} \sigma_1(u) = b, \qquad \lim_{u \to +\infty} \sigma_1(u) = a,$$

i.e.

$$\lim_{u \to -\infty} \frac{\int\limits_{a}^{b} x e^{-xu} dF(x)}{\int\limits_{a}^{b} e^{-xu} dF(x)} = b, \qquad \lim_{u \to +\infty} \frac{\int\limits_{a}^{b} x e^{-xu} dF(x)}{\int\limits_{a}^{b} e^{-xu} dF(x)} = a.$$

From

$$\int_{a}^{b} (x-a)e^{-xu} \mathrm{d}F(x) \ge 0$$

it follows

$$\frac{\int_{a}^{b} x e^{-xu} dF(x)}{\int_{a}^{b} e^{-xu} dF(x)} \ge a \quad \forall \ u \in I\!\!R.$$
(2.9)

For fixed $\varepsilon \in (0, L/2)$ and sufficiently large $u \in \mathbb{R}$ we have

$$\begin{split} \int_{a}^{b} (a+2\varepsilon-x)e^{-xu} \mathrm{d}F(x) &\geq \int_{a}^{a+\varepsilon} \varepsilon e^{-(a+\varepsilon)u} \mathrm{d}F(x) - \int_{a+2\varepsilon}^{b} Le^{-(a+2\varepsilon)u} \mathrm{d}F(x) \\ &\geq e^{-(a+\varepsilon)u} \Big(\varepsilon \int_{a}^{a+\varepsilon} \mathrm{d}F(x) - Le^{-\varepsilon u} \Big) > 0, \end{split}$$

i.e.

$$\frac{\int_{a}^{b} xe^{-xu} \mathrm{d}F(x)}{\int_{a}^{b} e^{-xu} \mathrm{d}F(x)} < a + 2\varepsilon.$$
(2.10)

From (2.9), (2.10) we obtain the limit $u \to +\infty$. Analogously the limit $u \to -\infty$ follows.

The following Lemma 2.2 gives bounds for the quantity |g(u+iv)/g(u)|. Obviously, this quantity lies in the interval [0, 1]. In case of a distribution function F(x) satisfying (P1) Lemma 2.2 gives nontrivial bounds only in a neighborhood of v = 0. If F(x) satisfies (P1) and (P2) then Lemma 2.2 gives a global nontrivial upper bound, too.

Lemma 2.2 Let F(x) be a distribution function satisfying (P1). Then it holds

$$\left|\frac{g(u+iv)}{g(u)}\right| \ge 1 - \frac{1}{2}\sigma_2(u)v^2 \quad \forall \ (u,v) \in \mathbb{R}^2,$$

$$(2.11)$$

$$\left|\frac{g(u+iv)}{g(u)}\right| \le 1 - \frac{2}{L^2} \sigma_2(u) \sin^2\left(\frac{Lv}{2}\right) \quad \forall \ (u,v) \in \mathbb{I} \times [-\pi/L, \pi/L].$$

$$(2.12)$$

Let F(x) be a distribution function satisfying (P1) and (P2). Then moreover we have

$$\left|\frac{g(u+iv)}{g(u)}\right| \le 1 - \left(1 - \frac{2}{\pi}\right)\delta\ell e^{-L|u|} \min\left\{1, \left(\frac{\ell v}{\pi}\right)^2\right\} \quad \forall \ (u,v) \in \mathbb{R}^2.$$

$$(2.13)$$

Proof: Let F(x) be a distribution function satisfying (P1). Then for $(u, v) \in \mathbb{R}^2$ and for all $\varphi \in \mathbb{R}$ it holds

$$\begin{aligned} |g(u+iv)| &\geq \operatorname{Re} e^{i\varphi v}g(u+iv) = \int_{a}^{b} e^{-xu} \Big(1 - 2\sin^{2}\Big(\frac{\varphi - x}{2}v\Big)\Big) \mathrm{d}F(x) \\ &\geq \int_{a}^{b} e^{-xu} \Big(1 - \frac{v^{2}}{2}(\varphi - x)^{2}\Big) \mathrm{d}F(x) = g(u) - \frac{v^{2}}{2}(g(u)\varphi^{2} + 2g'(u)\varphi + g''(u)). \end{aligned}$$

Choosing now $\varphi := -g'(u)/g(u)$ we conclude (2.11).

Now, let $(u, v) \in I\!\!R \times (0, \pi/L)$. In view of (2.3) it holds

$$\left|\operatorname{Im}(\sigma_0(u+iv)) + \frac{a+b}{2}v\right| \le \frac{b-a}{2}v,$$

i.e. $-\arg(g(u+iv)) \in [av, bv]$. Hence there exists $\varphi \in [a, b]$ such that

$$|g(u+iv)| = \operatorname{Re} e^{i\varphi v}g(u+iv) = \int_{a}^{b} e^{-xu} \left(1 - 2\sin^{2}\left(\frac{\varphi - x}{2}v\right)\right) \mathrm{d}F(x).$$

As we have

$$\frac{\sin t}{t} \ge \frac{\sin(\frac{Lv}{2})}{\frac{Lv}{2}}, \quad |t| \le \frac{Lv}{2} < \frac{\pi}{2}$$

furthermore it follows

$$\begin{aligned} |g(u+iv)| &\leq \int_{a}^{b} e^{-xu} \left(1 - \frac{2}{L^2} \sin^2\left(\frac{Lv}{2}\right) (\varphi - x)^2\right) \mathrm{d}F(x) \\ &= g(u) - \frac{2}{L^2} \sin^2\left(\frac{Lv}{2}\right) (g(u)\varphi^2 + 2g'(u)\varphi + g''(u)) \end{aligned}$$

Maximizing the right-hand side of this inequality wrt. $\varphi \in \mathbb{R}$ yields

$$\left|\frac{g(u+iv)}{g(u)}\right| \le 1 - \frac{2}{L^2} \sigma_2(u) \sin^2\left(\frac{Lv}{2}\right), \quad (u,v) \in \mathbb{I} \times (0,\pi/L).$$

Using continuity and symmetry wrt. real axis we get (2.12).

Now, let F(x) be a distribution function satisfying (P1) and (P2). Then for $(u, v) \in \mathbb{R}^2$ and for proper $\varphi \in \mathbb{R}$ it holds

$$\begin{split} e^{\frac{a+b}{2}u}[g(u) - |g(u+iv)|] &= e^{\frac{a+b}{2}u}[g(u) - \operatorname{Re} e^{i\varphi v}g(u+iv)] \\ &= \int_{a}^{b} e^{(\frac{a+b}{2}-x)u}(1 - \cos((\varphi-x)v))\mathrm{d}F(x) \geq e^{-\frac{L}{2}|u|} \int_{I} (1 - \cos((\varphi-x)v))\mathrm{d}F(x) \\ &\geq \delta e^{-\frac{L}{2}|u|} \int_{I} (1 - \cos((\varphi-x)v))\mathrm{d}x = \delta e^{-\frac{L}{2}|u|} \left(\ell - \frac{2}{v}\sin(\frac{\ell v}{2})\cos((\varphi-\theta)v)\right) \\ &\geq \delta \ell e^{-\frac{L}{2}|u|} \left(1 - \left|\frac{\sin(\frac{\ell v}{2})}{\frac{\ell v}{2}}\right|\right), \end{split}$$

where θ denotes the center of the interval *I*. Because of

$$e^{\frac{a+b}{2}u}g(u) = \int_{a}^{b} e^{(\frac{a+b}{2}-x)u} dF(x) \le e^{\frac{L}{2}|u|}$$

we have

$$\left|\frac{g(u+iv)}{g(u)}\right| \le 1 - \delta \ell e^{-L|u|} \left(1 - \left|\frac{\sin(\frac{\ell v}{2})}{\frac{\ell v}{2}}\right|\right).$$

$$(2.14)$$

Elementary analysis yields

$$1 - \left|\frac{\sin t}{t}\right| \ge \left(1 - \frac{2}{\pi}\right) \min\left\{1, \left(\frac{2t}{\pi}\right)^2\right\} \quad \forall t \in \mathbb{R}.$$
(2.15)

From (2.14), (2.15) we obtain (2.13).

For $(u, v) \in \mathbb{R} \times (0, \infty)$ let $\gamma(u, v)$ be a rectifiable arc in $\mathbb{C} \setminus (-\infty, 0]$ from u - iv to u + iv. The following Lemma 2.3 shows that for proper (u, v) the term

$$\frac{1}{2\pi i} \int\limits_{\gamma(u,v)} g(s) \, e^{xs} \frac{\mathrm{d}s}{s}$$

represents an approximation of the distribution function F(x), i.e. taking the inversion formula for Laplace transforms and integrating over $\gamma(u, v)$ instead of a line in the right half plane we obtain for proper (u, v) an approximation of F(x).

Lemma 2.3 Let F(x) be a distribution function satisfying (P1). Then for $(u, v) \in \mathbb{R} \times (0, \infty)$ it holds

3 Central approximation of the sum of *n* iid random variables

Let $\{X_{\nu}\}_{\nu=1}^{\infty}$ be a sequence of iid real-valued random variables. We assume that the distribution function $F(x) = P(X_{\nu} \leq x)$ satisfies (P1). Let $F(x,n) := P(S_n \leq x)$ be the distribution function of the sum $S_n = X_1 + X_2 + \ldots + X_n$ of the first *n* random variables. Obviously, F(x,n)satisfies (P1) for $n \in \mathbb{N}$, too. We denote by g(s) the LST of the distribution function F(x), i.e. $g(s)^n$ is the LST of F(x,n) for $n \in \mathbb{N}$.

The following Theorem 3.1 corresponds to a direct Edgeworth expansion. Especially in a neighbourhood of the expectation $n\sigma_1(0)$ of S_n we get a good approximation of its distribution function F(x, n). This approximation makes use of the moments of F(x) up to third order. The absolute error is uniformly bounded by $O(n^{-1})$. In case of the Central limit theorem, where only the first two moments of F(x) are used, the absolute error is uniformly bounded by $O(n^{-1/2})$.

Theorem 3.1 Let F(x) be a distribution function satisfying (P1) and (P2).

Then for $x \in \mathbb{R}$ and $n \in \mathbb{N}$ the approximation

$$F(x,n) = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{y} e^{-\frac{1}{2}\xi^{2}} d\xi + \frac{1}{6\sqrt{2\pi}} \sigma_{\beta}(0)\sigma_{2}(0)^{-\beta/2} n^{-1/2} (1-y^{2}) e^{-\frac{1}{2}y^{2}} + r_{n}(y), \quad (3.1)$$

4 Decentral approximation of the sum of *n* iid random variables

In case of very rare events in general a decentral approximation (large deviation results rsp. indirect Edgeworth expansion) of the distribution function F(x, n) of the sum of n iid random variables is better than a central one. We assume again that the distribution function F(x) of the generic random variable satisfies (P1) and (P2). As in case of the central approximation the starting point is Lemma 2.3, but now we choose $u \in \mathbb{R} \setminus \{0\}$.

Theorem 4.1 Let F(x) be a distribution function satisfying (P1) and (P2).

5 Numerical results

Fluid flow approximations are used for approximating models of communication systems where packet arrival streams are generated in a regular manner over certain intervals. The appropriate mathematical model for describing the bursty arrival streams in the fluid flow framework are the Markov modulated rate processes (MMRP's). For details see [BB94]. We consider the distribution of the number N(t) of packets in an interval [0, t] of a MMRP. In [BB94] for the distribution of N(t) explicit formulas are given in case of two-state sources (e.g. voice sources).

The support of the distribution function $F(x) := P(N(t) \le x)$ is the interval $[r_1t, r_2t]$, where $0 \le r_1 < r_2$ and r_1, r_2 are the packet rates in the first rsp. second state of the source. The LST g(s) of the distribution function F(x) has the following representation, cf. [BB94] p. 289:

The examples show that the central approximation based on moments up to third order corresponding to the first part of Theorem 3.1 is very good in a neighbourhood of the expectation and better than the Central limit approximation, especially in case of a very large number n of sources. But in case of very rare events and only in this case a decentral approximation is much better than a central one, cf. Table 5.1 for x = 560 and x = 1100.
